#### Shade Tree Commission Chair Thomas Mills - proposed new Tree Ordinance

The Tree Commission is presenting a replacement Tree Ordinance for review and adoption during tonight's meeting. The Shade Tree Commission has finished the year-long work to develop a tree ordinance that reflects the changing times of our urban forest city-wide, and efforts of the Public Works Department and volunteers.

A comparison was emailed by the Council Clerk to City Councilmembers and the Administration on Wednesday, April 13, 2016 to show the old ordinance with the new additions and deletions. The Tree Commission dates back over thirty (30) years, and much has changed in practice along our streets, arboriculture technical details, types of trees available, plans for the future, and programs that may help secure grants, volunteers and provide better trees in the right places. An ordinance is now needed that makes better sense for our community.

The Shade Tree Commission thanks City Councilman Niemeyer, former Councilwoman Spence, Service-Safety Director Schmelzer, Public Works Department team of Matt Stoffel, Dave Honse and AJ Copus, Law Director Rasmussen, City Clerk Kathy Launder, Council Clerk Denise DeVore, and Ohio Department of Natural Resources Division of Forestry Stephanie Miller for their collective efforts and support these past months. Thanks to Mayor Mihalik for the care, concern, and funding support of Findlay, our Tree City USA Community and our Urban Forest Program.

After the Shade Tree Commission ordinance is adopted, the Tree Commission is ready with an educational plan to communicate the ordinance to residents, contractors, developers and others working along our City streets to keep them safer and more beautiful. Ordinance No. 2016-040 was created.

#### Service-Safety Director Paul Schmelzer - Airport Runway 18/36 (FY 16) & Taxiway A rehabilitation (FY17)

The City has the opportunity to apply for grant funding through the Aviation Division of the Ohio Department of Transportation (ODOT). If approved, the grant funds would be used as follows:

- FY16 5% match funds to supplement the City's share of the Runway 18/36 rehabilitation project. FAA will pay 90% of the estimated \$2.6 million construction costs. This project is included in the 2016 Capital Improvements Plan.
- FY17 84% of the eligible construction costs for rehabilitation of a portion of the parallel taxiway to Runway 18/36 (Taxiway A). Estimated project cost is \$443,700 and will be included in the 2017 Capital Improvements Plan.

Legislation authorizing the Service-Safety Director to sign the grant applications and agreements is requested. Resolution No. 017-2016 was created.

Total precipitation recorded at the City of Findlay Water Pollution Control Center was 7.37 inches of rain and 5.91 inches of snow for the first quarter (Jan-Mar) of 2016.

At the end of March, the Findlay reservoirs stood at 100 % of capacity. This reservoir level represents a 1,138 day water supply at the city's current use.

Water treated at the plant totaled 510.39 million gallons for the first quarter (Jan-Mar) of 2016. Water treated per day at the City of Findlay Water Treatment Plant averaged 5.609 million gallons (MG).

#### **MINUTES**

#### ATTENDANCE

Members Present: Paul Schmelzer, Chair, Matt Cordonnier, Dennis McPheron, Greg Meyers, Gary Pruitt, Grant Russel, Mike Slough, Dave Trisel.

Staff Present: Matt Stoffel, Lisa Mansfield, Jarron Reesman.

Frische, Council.

#### APPROVAL OF MINUTES

Pruitt stated that in his report in the January 19, 2016, meeting minutes, it should be reported that the new trail will be from Riverside Suites to Bright Road rather than to the Hancock Park District offices. Motion to accept minutes of the January 19, 2016, meeting as amended by Meyer, second by Slough. Motion passed 8-0.

#### **OLD BUSINESS**

Recreation Summit Recap: Mansfield stated that there was good attendance at the Summit. All but one or two user groups were represented at the meeting. A lot of good discussion. Went over how the City handles its field permits and ice contracts with the user groups to make sure they understand and the importance of maintaining the conflict calendar. Discussed the National Alliance for Youth Sports but after discussing the benefits, there wasn't a lot of interest in it. The City will not pursue. Alissa Preston from the Hancock County Convention and Visitors Bureau (CVB) addressed the different programs and assistance they have available to the different groups that are bringing in tournaments. Additional items discussed was an additional sheet of ice at the Cube and the need for a multipurpose sports facility. Those suggestions will need future planning. Need for a real time calendar. Looking at current software capabilities and making contact with BGSU ice rink staff to schedule a time to look at their software. The University of Findlay (UF) baseball team requested additional batting cages. The City already has this in the capital plan for this year. The funds for the batting cages are scheduled to be appropriated in the second quarter. Need for a permanent ticket structure at the main entrance to the Marathon Diamonds. Findlay youth baseball and girls fastpitch softball stated that they have already raised funds toward this project. One structure will be built at the main entrance and one at the entrance off the proposed parking lot for the Miracle Field. This will be started in April. Hancock Soccer Association would like assistance with water and maintenance bills at Emory Adams Park. They will need to address Park and Recreation Board to request the assistance. Since there have been changes in staffing at Findlay City Schools (FCS) and the City's Recreation Department, a meeting will be scheduled to confirm if FCS wants to continue having the City handle the scheduling of their facilities. Long Term items: Youth Football - power needs, will need estimates. Traffic Lights will assist in plans for electric. UF would like electric in dugouts at the Marathon Diamonds. If we are going to do electric in these dugouts, we will do electric in all the dugouts in all the fields at the Marathon Diamonds. Traffic Lights will also look at this. Also coordinate with Miracle Field electric needs. Hancock Soccer wants an indoor facility. FAST states a need for another pool, possibly coordinate with YMCA what their future plans are.

Schmelzer stated that in the future, the City will have disucussions with user groups ahead of creating the capital plan. No sense budgeting for something when the user groups can raise money. Good feedback from the meeting. When we can take some of the items that are relatively inexpensive to take care of and address a need, that's a win for the meeting. When we start having the Summit annually, we won't have to go over as much of the rules. Long term wants/needs that we have heard before—pool, additional sheet of ice, indoor soccer. We

have an idea of what the pool will cost. We have a concept for this major indoor complex. This is a little beyond what we are really talking about for indoor space and flex space or an additional sheet of ice. Where does the board want to go with long term items that were suggested and the question—what are the new ideas, what if any other direction should the recreation in the City be taking? Do we want to start looking at what indoor ice and indoor flex space would look like by evaluating an architect and having them come on board and paying them a fee to help deliver a product much like we have for the swimming pool? Do we want to have somebody facilitate a discussion about strategic planning for building some of these items?

Slough mentioned that these issues aren't going to go away. There will be more demand for additional space and additional ice. Some individuals can't get ice, so they are going to Bowling Green or Detroit. If it is one of the goals of this community to provide facilities for people of our community then position should be taken for additional space for indoor soccer or flex facility plus sheet of ice. With the growth of the usage of the facility we have the basis for additional facility. We should move ahead rather than waiting.

Meyers interesting thing there hasn't been a lot that has changed. Same wants and needs from 25 years ago. Additional ice, indoor soccer, pool. It might be a good idea to expand the assessment to not just the user groups but to people within the community.

Schmelzer stated that the YMCA is in the process of a market study/facility study. They are looking at needs in the community to develop what their program looks like, we should reach out as a board to see what that discussion looks like. We definitely don't want to do anything that is competing. We need to be complementary and not duplicate other efforts. Meyer stated that we should include UF in our discussions.

Grant stated that the survey was completed by 50% of recipients. Mansfield stated she resent the survey to those who did not respond with a summary of the summit for those not attending the summit and just the survey to those attending. Mansfield stated that she make the personal contact if wanted.

Cordonnier state that he is in favor of a facility that 80% of residents would use, not 1%.

Need to engage public what or if it should be built.

Can we piggy back on YMCA strategic planning. It is in its infancy. Requesting it be made a community wide study vs. just YMCA. Russel stated that the YMCA has completed their study and have their needs identified. Have Brent Finley come to the next Board meeting to talk about what their study looks like and from there develop what we want to do going forward. UF and Fair Board will also be invited to next meeting. Schmelzer stated a utilization study needs to be done for City facilities. Then a community-wide discussion needs to be held.

Waive fee for Expo by Design: Expo by Design rented dry floor space for its event. As is normal practice, chillers were turned on during the event because ice was going to be put on the next day. The new chillers cool the floor 10 times faster than the old one. So this event had a cold environment and had blankets and glass that had condensation on it. Schmelzer suggests waiving the remaining balance of \$1088 of the bill. Staff knew from past practice that chillers can be turned on during an event and it would not get cold enough to impact the event. The new chillers dropped the floor temperature extremely quickly. Schmelzer stated the fair compromise is to waive the remaining balance of bill.

Motion to waive \$1088.00 for the Expo by Design event, by Russel, second by Cordonnier. Motion passed 8-0.

Hunting at Reservoir: Schmelzer stated that a few months ago the Board had a discussion about permits for bird hunting at the reservoir. Water Treatment usually issues about a dozen permits per year. Have not had any issues. Looking for additional information from Water Treatment and Ohio Department of Natural Resources (ODNR). Water Treatment put together a map of the reservoir that was distributed with hashed areas where it is suggested that hunting would be prohibited. It is also suggested the Rules and Regulations be revised under 4. Hunting as follows: e) No person shall discharge any firearm from any areas designated as closed to hunting, or from grassy slope of any outer reservoir dikes; and add i) Must be 100 yards off shore in areas where dikes are closed to hunting.

Newcomer stated that there haven't been any issues. The areas that are suggested to be permanently closed to hunting is because there aren't a lot of areas for water fowl within that area. Vonalmen reported that he has been here for about a year and has only experienced one water fowl hunting season. There is not a lot of hunting of water fowl on the reservoirs. A few do hunt fairly regularly. He has not had any issues. Vonelmen stated that everyone he has checked has had the appropriate permits.

Pruitt inquired what ODNR's stand is regarding hunting in a public place with other activities. Vonelmen stated that ODNR's goal is to get people out to utilize the resources. Safety is definitely a priority when multiple

activities are taking place. Hunters are required to go through safety course that teaches fire arm safety to obtain their permit. There have been five injury instances across the state for the hundreds of thousands of sportsmen that are out there, a very small percentage. The City is in a hunting cooperative program with ODNR. Therefore, hunters need to get the permit from the City to hunt at the reservoir. Anybody that is stopped that does not have this permit will receive a citation. The City does not charge a fee for the permit. Schmelzer stated that there is no reason we should not make the changes that Newcomer suggested.

Motion that we modify the rules regarding hunting at the reservoir to modify Section e) No person shall discharge any firearm from any areas designated as closed to hunting, or from grassy slope of any outer reservoir dikes and add Section i) Must be 100 yards off shore in areas where dikes are closed to hunting and require the no hunting areas be delineated on a map and make the map available to those hunters that pick up the permit to hunt at the reservoir, by Schmelzer, second by Russel. Motion passed 8-0.

#### **NEW BUSINESS**

<u>Riverside Pool Agreement with Findlay YMCA</u>: Schmelzer reported that the agreement is very similar to last year. Council had the first reading of the ordinance last Tuesday.

Motion to recommend that Council approve entering into an agreement with Findlay YMCA for the operation of Riverside Pool for 2016 season, by Schmelzer, second by Cordonnier. Motion passed 8-0.

#### **DEPARTMENT REPORTS**

Recreation Department Report: Mansfield created a form for entities requesting for fees to be reduced or waived. The Board thought the form was good. Entities need to complete this form and then come before the Board. UF Softball had first double header last week; UF Baseball team will have home game middle of April. On April 23, the City will host a Pitch Hit & Run event at the Marathon Diamonds. Mayor Mihalik signed up the City of Findlay to be part of Play Ball, an initiative of the U.S. Conference of Mayors and Major League Baseball. Different events will be held throughout the summer in relation to this initiative. Softball managers meeting was held and registrations are due April 15. Games start the second weekend in May. Miracle Field and Playground for All will hold their grand opening on August 20. Three games will be held that day with six teams competing. Gliding Stars and Silver Blades ice shows were held last weekend and everything went smooth.

An Arlington softball league would like to bring their games to Findlay on Friday nights at Rawson Field and Cooper Field. They were told the Independent League fee is \$1000 plus \$100 administrative fee, plus \$50 electric fee per field, per night. They thought the fee was a bit high for the electric. In an effort to work with the new league, it was suggested that the fee for a league that runs in the daytime would be \$1000 plus \$100 administrative fee; the fee for a league that runs in the evening would be \$2000 plus \$100 administrative fee (this would include the electric use). Schmelzer stated that this is the same discussion as we have had in the past. Leagues pay the umpires much more than what they pay the City to use its facilities. Cost of facilities and electricity is spread out over quite a few players. Why should the City give a break for use of our facilities and utilities? Schmelzer stated this would not be a policy change, just an exception to the rule for this instance for this league. Make it clear that this is a one year concession. It is unlikely that this is going to be a year after year occurrence. We welcome them to give us a shot to show how much better our facilities are. If they want to come back next year, it will be at full price.

Motion to give the Arlington softball league a one-time only exemption for a flat rate fee of \$2000 league fee with electricity plus \$100 administrative fee, by Cordonnier, second by Slough. Motion passed 8-0.

Mansfield introduced Jarron Reesman, new hire at Recreation Department. Mansfield reported that 20 security Cameras have been installed at various locations at the Cube as a security measure due to vandalism. Motion sensor lights will also be installed.

#### OTHER REPORTS

Hancock Park District Report: Pruitt reported that they have the Blanchard River Challenge self-guided float trips with shuttle service and horseback riding in partnership with UF will be offered this spring. Registration now open.

#### **OTHER BUSINESS**

Next Meeting: The next meeting of the Parks and Recreation Board is scheduled for April 18, 2016, at 4:00pm in the third floor conference room of the Municipal Building.

### **ORDINANCE NO. 2016-040**

AN ORDINANCE REPEALING CHAPTER 913 OF THE CODIFIED ORDINANCES OF THE CITY OF FINDLAY, OHIO, AND IN ITS PLACE, ESTABLISHING A NEW CHAPTER 913 ENTITLED ESTABLISHMENT OF SHADE TREE COMMISSION AND TREE REGULATIONS ORDINANCE FOR THE CITY OF FINDLAY, OHIO.

SECTION 1: That Chapter 913 of the Codified Ordinance of the City of Findlay, Ohio be and the same is hereby repealed in its entirety.

SECTION 2: That a new Chapter 913 be and the same is hereby adopted to read as follows:

#### 913.01 ESTABLISHMENT

There is hereby created and established the Shade Tree Commission of the City of Findlay, County of Hancock, State of Ohio.

#### 913.02 MEMBERSHIP AND TERMS

- The Commission shall consist of eleven (11) members. Six members shall be appointed by the Mayor. One member each shall be from City Council, the City Engineer's office, the Service Director's office, a City Forester, and one member from the Public Works Department.
- 2. The Mayor, subject to the approval of the City Council, shall appoint all members of the Commission.
- The Chairperson of the Commission shall preside over all meetings of the Commission and act as parliamentarian. The Vice-Chairperson shall assume the duties of the Chairperson in his or her absence.
- 4. The six public members of the Commission shall be appointed for three-year terms so staggered so not more than two members' terms expire in the same year. An exception to the expiration schedule shall be if a member or members resign before the expiration of his/her or their term, the Mayor shall immediately appoint a replacement to fill the unexpired term.
- 5. The Commission members shall serve without compensation.
- 6. Any Commission member who misses three (3) consecutive meetings or more than fifty percent (50%) of the regular meetings on an annual basis shall be removed from the Shade Tree Commission.

#### 913.03 POWERS AND DUTIES

- 1. The Commission, when requested by City Council, shall consider, investigate, make findings, report and recommend upon any special matter or question regarding the tree lawn or public trees.
- To hold regular and special meetings, at which the subject of trees, insofar as it relates to the Municipality, may be discussed by the members of the Commission, officers, personnel, and Council committees of the Municipality and all others interested in the tree program.
- 3. To educate and inform the public regarding the selection, planting and maintenance of trees within the corporate limits, whether the same be on private or public property.
- 4. To establish the recommended species and varieties of trees to be planted in the tree lawns and other public places.
- 5. To implement an Arbor Day observance on an annual basis.
- 6. To participate in the Tree City USA programs to the extent possible.
- 7. To work with the City Administration, the Public Works Department, and/or a Forester to implement a tree planting program as the budget allows.
- 8. To adopt rules, regulations and policy consistent with this chapter and to enforce in a court of law said rules, regulations and policy.

#### 913.04 MEETINGS AND PROCEDURES

The Commission shall choose its own officers, make its own rules and regulations and keep a journal of its proceedings. A simple majority of the appointed members present shall be a quorum for the transaction of business. All plans, findings, advice, reports, and recommendations of the Commission shall be in writing. The minutes shall be filed with the Mayor's office.

#### **913.99 PENALTY**

Any person violating or failing to comply with any provision of this chapter upon conviction or a plea of guilty, for the first offense shall be subject to a minor misdemeanor penalty. A second violation shall constitute a separate violation and upon conviction or plea of guilty shall be subject to a misdemeanor of the fourth degree penalty. A third violation upon conviction or a plea of guilty shall be subject to a misdemeanor of the third degree penalty. A fourth violation upon conviction or plea of guilty shall be subject to a misdemeanor of the second degree penalty. A fifth and subsequent violation thereafter upon a conviction or plea of guilty shall be a misdemeanor of the first degree. The Court shall consider the issue of restitution for damages in addition to any fine or term of imprisonment.

#### 913.05 TREE REGULATIONS

#### A. DEFINITIONS

- "Boulevard" means a wider than normal street with two-way traffic separated by a median strip usually landscaped with shrubs and/or trees.
- 2. "City Forester" means the person who, under regular supervision, performs specialized professional work in the planning and coordination of a comprehensive tree management program throughout the City.
- 3. "Hazardous Tree" means any public tree capable of causing damage or safety threats to persons or property. In situations that are not readily obvious, use the following definition: shall refer to a tree when assessed by a trained, professional arborist or urban forester utilizing International Society of Arboriculture Tree Risk Assessment Best Management Practices is deemed as having a high probability of failure and Targets.
- 4. "Large Trees" shall refer to trees taller than 50' at maturity.
- 5. "Medium Trees" shall refer to trees taller than 25' and no taller than 50' at maturity.
- 6. "Person" means any person, firm, partnership, association, corporation, company, or organization of any kind.
- 7. "Property Line" means the boundary between two (2) pieces of property.
- 8. "Property Owner" means the person owning such property as shown by the County Auditor's Plat of the City of Findlay, Hancock County, Ohio, including the executor, administrator, or beneficiary of the estate of a deceased owner.
- 9. "Pruning" means the arts and science of removing of tree parts for a specific reason following International Society of Arboriculture Best Management Practices.
- 10. "Public Places" shall include all other grounds owned by the City of Findlay.
- 11. "Public Trees" shall include all trees now or hereafter growing on any public places or tree planting area.
- 12. "Public Works Superintendent" means the person designated by the Service Director who, among other things, has under his or her control all public streets and highways within the corporate limits of the City.
- 13. "Right-of-Way" means any strip of land dedicated to public use.
- 14. "Service Director" means the person designed as Director of Public Service pursuant to Ohio Revised Code Chapter 735 et seq.

- 15. "Shrub" means a low growing woody plant with one or several perennial main stems producing branches, shoots, or multiple stems from or near the base of the plant and incapable of being pruned to provide at least six feet of clear branchless trunk.
- 16. "Small Trees" shall refer to trees no taller than 25' at maturity.
- 17. "Street, Boulevard or Highway" means the entire width of every public way, easement of right-of-way when any part thereof is open to the public, as a matter of right, for the purpose of vehicular and pedestrian traffic.
- 18. "Target" refers to people, property, or activities that could be injured, damaged, or disrupted by a tree failure.
- 19. "Tree" means a tall growing woody plant with one or more perennial main stems or a trunk which develops branches from the aerial section of the stem rather than from the base; capable of being pruned to at least six feet of clear branchless trunk below the crown within ten (10) years of planting. Tree size is defined in 4, 5, and 16
- 20. "Tree Inventory" means a survey of trees in all public places, including city parks and tree lawns; identifying the number of trees, species distribution, size distribution, maintenance needs, and planting needs.
- 21. "Tree Lawn" means that part of a street and or that part of private land abutting the street or highway, lying between the property line and that portion of the street or highway usually used for vehicular traffic.
- 22. "Tree Topping" is the practice of removing whole tops of trees or large branches and/or trunks from the tops of the trees leaving stubs or lateral branches that are too small to assume the role of a terminal leader.

#### B. DUTY OF PRIVATE PROPERTY OWNER

- It shall be the duty of any private property owner owning or occupying property bordering on right of way upon which property there may be non-public trees or shrubs, to prune or cause to be pruned such tree or shrub in a manner that they will not shade or obstruct street lights, street signs, or obstruct pedestrian or vehicular traffic on sidewalks or streets. Debris disposal shall be the responsibility of the private property owner.
- 2. It shall be the duty of any person owning or occupying property bordering on right of way upon which there are any non-public trees or shrubs that are designated by the Public Works Department as dead, dying, diseased, or hazardous or deemed a menace to the health, safety, and welfare of the people of Findlay, to remove or cause to be removed said tree(s) and/or shrub(s).

- 3. In either of the above situations, the Public Works Department shall provide a notice to the property owner indicating the required action (pruning or removal) to be taken and a deadline by which to respond. Should the property owner fail to comply with the Public Works deadline, it shall be lawful for the Mayor or his/her agent to enter upon the property and cause such action. The property owner or occupant may be charged triple the actual cost of the work and cash payment shall be made within thirty days; otherwise said costs shall be assessed to the property taxes.
- 4. No person or property owner shall remove or significantly impact a tree from the right of way for any reason without approval from the Public Works Department, and/or City Forester, and/or the Service Director. Should approval not be given for the removal, the person shall be required to replant or replace an equal number of approved trees at the landowner's cost. The Public Works Department, and/or City Forester, and/or the Service Director must approve the replacement or replanting. Failure to plant replacements shall result in replacement by the City and triple the actual cost to the City shall be billed to the property owner.

#### C. CITY MAY REMOVE PUBLIC TREES

- 1. The Public Works Department, with the assistance of a City Forester, may identify hazardous trees that have the potential to fall on people or property, and may remove those trees as soon as practical. In situations that are not readily obvious, a certified arborist or urban forester shall be used to determine if a tree or trees should be removed utilizing International Society of Arboriculture Tree Risk Assessment Best Management Practices.
- 2. The Public Works Department may remove or cause or order to be removed, any trees or part thereof which by reason of its nature is injurious to existing sewers, electric power lines, gas lines, water lines, sidewalks or other public improvements.
- 3. The Public Works Department shall provide notice to the property owner indicating the required action to be taken.

#### D. CITY MAY PRUNE TREES

- 1. The Public Works Department and/or a City Forester may prune trees that impede utility, traffic and visibility clearance, pedestrian and vehicular clearance.
- 2. The Public Works Department and/or a City Forester may provide notice to property owner(s).

#### E. CITY MAY PLANT TREES

- 1. The Shade Tree Commission, with the continuing financial support of the City, will conduct an annual tree planting program. City residents may participate in the tree planting program which will allow them to purchase a tree at a reduced rate, and based on guidance from the Commission, plant the tree in a specified spot on their tree lawn.
- 2. The City may subsidize purchase of a tree to plant on private property in an area not to exceed 20' from the right of way line.
- 3. Whenever it is necessary for the Public Works Department to remove a tree from the tree lawn and other public places the property owner may apply to plant a new tree in a contiguous area if possible, within regulations set forth herein.
- 4. Developers/builders will submit plans in advance to the Shade Tree Commission, Service Director, Public Works Department, and/or a City Forester for tree planting in tree lawn areas. Plans for proposed tree plantings must comply with regulations set forth herein.
- F. PLANTING TREES IN TREE LAWNS AND OTHER PUBLIC PLACES
  No person shall plant a tree in a tree lawn or other public place without first
  obtaining the prior approval of the Tree Commission or designee.

#### G. TREES PROHIBITED IN TREE LAWNS & OTHER PUBLIC PLACES

- No person shall plant a tree that is on the Shade Tree Commission's prohibited tree list.
- 2. Whenever any tree or shrub is planted or set out in conflict with the provisions of this Regulation, the Public Works Department may cause the removal of the same without obligating the City to replace the illegally planted tree(s).

#### H. ABUSE OR MUTILATION OF PUBLIC TREES

- 1. No person or entity shall intentionally damage, cut, carve, top, transplant, or remove any tree; attach any rope, wire, nails, advertising posters, squirrel feeder, or other contrivance to any tree or shrub; allow any gaseous, liquid, or solid substance to come in contact with them; set fire or permit fire to burn when the fire or heat thereof shall injure any portion of any tree or shrub.
- 2. No person or entity shall excavate any ditches, tunnels, trenches, alley or drive within a radius of ten feet from any public tree or shrub without obtaining approval from the Public Works Department.

### I. PLACING MATERIALS ON PUBLIC PROPERTY

No person shall deposit, place, store, or maintain upon any tree lawn or public place, any stone, brick, sand, concrete, or other materials that may impede the free passage of water, air, or fertilizer to the roots of any tree growing therein, except by written consent of the Public Works Department.

#### J. TREE SPACING

These are regulations for tree placement and planting. Exceptions may occur in special plantings designed or approved by the Service Director, a City Forester, the Shade Tree Commission, and the Public Works Department.

The spacing of public trees will be in accordance with the three (3) species size classes referred to in the Shade Tree Commission's list of Street Trees and no trees may be planted closer together than the following:

Small trees:

twenty (20) feet

Medium trees:

thirty (30) feet

Large trees:

forty (40) feet

#### TREE LAWN

a. DISTANCE FROM CURB AND SIDEWALK
Minimum size of the tree lawn width shall be-

Small trees:

eight (8) feet

Medium trees:

eleven (11) feet

Large trees:

fourteen (14) feet or planted on private property as noted in private easement section at least 5 feet from

the sidewalk and no more than 20 feet from right of

away line.

Plant trees in center of the tree planting area to avoid root conflicts with sidewalks and curbs.

There shall be no plantings in a tree planting area of less than eight (8) feet.

## K. DISTANCE ON NON CURBED STREETS

Minimum size of the tree planting area shall be 10' from edge of pavement.

- L. DISTANCE FROM THE STREET CORNERS, WATER METERS, MANHOLES, FIRE PLUGS, ETC.
  - 1. No public tree shall be planted closer than fifty (50) feet from any stop sign or seventy-five (75) feet from the outside of the curb radius on a street where there are no stop signs.
  - 2. No public tree shall be planted closer than ten (10) feet to any fire hydrant.

- 3. No public tree shall be planted closer than ten (10) feet to any water meter cover or lid or manhole cover or lid.
- No public tree shall be planted closer than four (4) feet from underground utility lines and utilities including gas, water, and sewer.
- 5. No public tree shall be planted closer than ten (10) fee from curb cuts (e.g. driveways or crosswalks) and street signs.
- 6. No public tree shall be planted closer than twenty-five (25) feet from street lights.
- 7. No public trees shall be planted closer than seventy-five (75) feet from mid street cross walks.
- 8. No public tree shall be planted until all utilities are located.

#### M. UTILITIES

No public trees may be planted under or within twenty-five (25) lateral feet of any overhead utility wire without prior approval from the Service Director, the Public Works Department, a City Forester and/or Shade Tree Commission.

#### N. ADOPTION OF RULES

The Shade Tree Commission, with the approval of City Administration, may adopt rules consistent with the Ordinance that shall provide detailed guidelines for the administration of this Ordinance.

SECTION 3: This Ordinance shall be in full force and effect from and after the earliest

#### **ORDINANCE NO. 2016-**041

ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF FINDLAY, OHIO TO PROVIDE A CERTIFICATE OF APPROVAL, AS THE HIGHEST APPLICABLE ELECTED REPRESENTATIVES, IN CONNECTION WITH THE ISSUANCE OF TAX-EXEMPT LEASE OBLIGATIONS TO BE ISSUED PURSUANT TO A MASTER LEASE-PURCHASE AND SUBLEASE-PURCHASE AGREEMENT BY AND AMONG FIFTH THIRD BANK, THE BLANCHARD VALLEY PORT AUTHORITY AND THE UNIVERSITY OF FINDLAY AND DECLARING AN EMERGENCY.

WHEREAS, the Blanchard Valley Port Authority, Ohio (the "Port Authority"), by virtue of the laws of the State of Ohio, including Section 4582.21, et seq., of the Ohio Revised Code (the "Act"), acting by and through its Board of Directors (the "Board"), is authorized (i) to lease "port authority facilities," as defined in the Act ("Port Authority Facilities"), and to sublease such Port Authority Facilities in furtherance of the public purposes of the Act and (ii) to enact this legislation and execute and deliver the agreements and instruments hereinafter identified; and

WHEREAS, it is expected that the Board of the Port Authority shall determine to authorize the issuance of lease obligations (the "Lease Obligations"), in one or more series of obligations, pursuant to and secured by a Master Lease-Purchase and Sublease-Purchase Agreement dated as of May 1, 2016 (the "Agreement") among the Port Authority, as lessee, Fifth Third Bank, as lessor (the "Lessor") and the University of Findlay, an Ohio nonprofit corporation, as sublessee (the "Corporation") for the purpose of, together with other available moneys (but not moneys of the City of Findlay, Ohio, the Port Authority or any other political subdivision), for the financing of the construction of a project currently anticipated to be a two story Center for Student Life/College of Business Building, which is planned to include a full kitchen, an open multi use seating area, bookstore, a copy and mail center, an executive dining room, student activities areas, approximately twenty meeting, lecture and classroom areas and office space (the "Project"). The proceeds of the Lease Obligations would be made available to the University for the purpose of financing (a) the Project to be located on the campus of the University on the south side of Davis Street east of Morey Street, with a street address of 301 Davis Street, Findlay, Ohio 45840; and (b) certain issuance costs in connection with the taxexempt financing. The Project is owned and operated by the University at the above referenced location; and

WHEREAS, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), requires that prior to their issuance, the Lease Obligations must be approved by the highest "applicable elected representative" of the Port Authority (as defined in such Section 147(f) of the Code); and

WHEREAS, the Mayor is the highest "applicable elected representative" of the Port Authority for purposes of Section 147(f) of the Code; and

WHEREAS, after due publication of notice, a public hearing shall be conducted by the Port Authority on April 13, 2016 with respect to the issuance of the Lease Obligations; and

WHEREAS, in order to facilitate the issuance of the Lease Obligations, this Council desires to authorize the Mayor to execute a certificate providing the requisite approval pursuant to Section 147(f) of the Code;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council (the "Council") of the City of Findlay, Ohio:

SECTION 1. That, after due authorization of the Lease Obligations by the Port Authority, the Mayor of this Council, as the highest "applicable elected representative" of the Port Authority for purposes of Section 147(f) of the Code, is hereby authorized to provide a "Certificate of Applicable Elected Representatives" in order to facilitate the issuance of the Lease Obligations by the Port Authority. The proceeds of the Lease Obligations shall be used for the purposes set forth in the preambles hereto and such obligations shall not be obligations of the City of Findlay, Ohio. Any comments from the public hearing shall be communicated to this Council for further consideration.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the *Ohio Revised Code*, and the rules of this Council in accordance therewith.

SECTION 3. That this ordinance is hereby declared to be an emergency measure because it is necessary to expeditiously facilitate certain the federal law compliance measure further described herein for the purpose of facilitating the issuance of the Lease Obligations through the Port Authority, which Lease Obligations are necessary for the public peace, health, safety and welfare of the inhabitants of the City of Findlay, Ohio in providing interest cost savings to the Corporation. This ordinance shall take effect upon its adoption by this Council and approval by the Mayor.

#### CERTIFICATE OF APPLICABLE ELECTED REPRESENTATIVE

The undersigned, Lydia Mihalik, Mayor of the City of Findlay, Ohio (the "City") hereby certifies as follows:

- 1. I am the Mayor of the City, elected directly by the people of the City.
- 2. The Blanchard Valley Port Authority, (the "Lessee") has undertaken a plan of finance whereby it shall enter into a Master Lease-Purchase and Sublease-Purchase Agreement and schedules thereto (collectively, the "Lease Agreement") among Fifth Third Bank (the "Lessor"), the Lessee and The University of Findlay (the "Sublessee"). Sublessee has represented in the Lease Agreement that the proceeds of the lease obligations provided for under the Lease Agreement will be used for the financing of the construction of a project currently anticipated to be a two story Center for Student Life/College of Business Building, which is planned to include a full kitchen, an open multi use seating area, bookstore, a copy and mail center, an executive dining room, student activities areas, approximately twenty meeting, lecture and classroom areas and office space (the "Project"). The proceeds of the Lease Obligations would be made available to the University for the purpose of financing (a) the Project to be located on the campus of the University on the south side of Davis Street east of Morey Street, with a street address of 301 Davis Street, Findlay, Ohio 45840; and (b) certain issuance costs in connection with the tax-exempt financing. The Project is owned and operated by the University at the above referenced location.
- 3. Sublessee has represented in the Lease Agreement that the Project is owned and operated by Sublessee and is part of Sublessee's facilities, the addresses of which facilities are attached hereto as *Exhibit A*.
- 4. The Sublessee published in a newspaper (*The Courier*) on March 17, 2016, a notice of hearing concerning the financing of the Project (*see Exhibit A* hereto).
- 5. On April 19, 2016, the City Council of the City of Findlay, Ohio passed an ordinance authorizing the Mayor of the City to execute this Certificate of Applicable Elected Representative in connection with the issuance of the lease obligations to be issued pursuant to the Lease Agreement. On April 13, 2016, at 3:30 p.m., the Lessee conducted a public hearing pursuant to Section 147(f) of the Code and the related Treasury Regulations. The City will not be a party to the Lease Agreement. Neither the undersigned person in her individual or official capacity nor other officers or officials of the City shall assume any direct or indirect financial responsibility for the payment of any amounts under the Lease Agreement or any present or future schedule thereto.

#### **EXHIBIT A**

This correspondence is to apprise you of a potential tax-exempt financing for the benefit of the University of Findlay (the "University"). The University is in the process of negotiating financing terms with Fifth Third Bank (the "Bank"). The proceeds of potential tax-exempt financing will be used for the construction of a project currently anticipated to be a two story Center for Student Life/College of Business Building, which is planned to include a full kitchen, an open multi use seating area, bookstore, a copy and mail center, an executive dining room, student activities areas, approximately twenty meeting, lecture and classroom areas and office space (the "Project"). The proceeds of the would be made available to the University for the purpose of financing (a) the Project to be located on the campus of the University on the south side of Davis Street east of Morey Street, with a street address of 301 Davis Street, Findlay, Ohio 45840; and (b) certain issuance costs in connection with the tax-exempt financing. The Project is owned and operated by the University at the above referenced location.

In order for the proposed financing to qualify as "tax-exempt," the University is requesting that the Blanchard Valley Port Authority (the "Authority") participate as the conduit "issuer" of its tax-exempt obligations. The proposed tax-exempt obligations would be revenue obligations payable solely from revenue sources provided by the University, and would not constitute a pledge of assets or revenues of the Authority nor would these obligations involve a full faith and credit pledge of the Authority or any other political subdivision of the State of Ohio. Further, the issuance of these obligations would not involve the implication of debt limitations under state law. However, this transaction would be a "qualified 501(c)(3)" financing, and therefore, the principal amount of the tax-exempt obligations would count against the Authority's \$10,000,000 "bank qualification" for calendar year 2016 (i.e. in general, the Authority's ability to privately negotiate tax-exempt deals with financial institutions for a particular calendar year). The anticipated principal amount of the proposed financing is expected not to exceed \$10,000,000.

With respect to the proposed structure of the financing, it is anticipated that the Authority would issue tax-exempt lease obligations. Under this type of structure, where there is real property, the University would enter into an Agreement of Lease with the Bank, transferring a leasehold interest in the applicable real property to the Bank. In addition, the Bank (as lessor), the Authority (as lessee) and the University (as sublessee) would enter into a Master Lease-Purchase and Sublease-Purchase Agreement (the "Lease Purchase Agreement") under which the Bank would lease the applicable property, improvements and/or facilities to the Authority and the Authority would sublease the same to the University. Under the Lease Purchase Agreement,

the University would make rental payments (i.e. principal and interest payments) to the Authority, which payments would be assigned directly to the Bank. Pursuant to the Lease Purchase Agreement, the Authority generally has its duties and responsibilities assigned to the University, in turn, receiving comprehensive indemnification from the University. The indemnification received by the Authority typically extends not only to coverage for rental payments and other contractual amounts due and payable, but also for other acts and omissions relating to the financed facilities. Other refinancing documents include documents that provide the Bank with a security interest in certain real and/or personal property, such as UCC filings and an Amended Mortgage.

As you know, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), makes it necessary to conduct a public hearing prior to the issuance of tax-exempt obligations. In addition, it will be necessary to obtain the approval of the highest "applicable elected representative" in accordance with Section 147(f) of the Code. Accordingly, we intend to request that the City of Findlay assist with this requirement.
