AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF FINDLAY, OHIO, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE DOWNTOWN FINDLAY IMPROVEMENT DISTRICT, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Findlay, State of Ohio, two-thirds (2/3) of all members elected thereto concurring:

SECTION 1: That the Mayor of the City of Findlay, Ohio be and she is hereby authorized to enter into a Memorandum of Understanding (MOU) with the Downtown Findlay Improvement District (DFID) for the maintenance of hanging flower baskets in the downtown Findlay area as attached hereto as Exhibit A.

SECTION 2: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the inhabitants of the City of Findlay, Ohio, and for the further reason it is immediately necessary to enter into said MOU so that said maintenance of hanging flower baskets in Findlay's downtown area may proceed.

WHEREFORE, this Ordinance shall be in full force and effect from and after its passage

and approval by the Mayor.

Memorandum of Understanding

The City of Findlay (the City) and Downtown Findlay Improvement District (DFID) enter into a Memorandum of Understanding for the City of Findlay to provide the below services from approximately mid-May – September 2021.

The City will provide to DFID, weekly fertilizing of all hanging flower baskets (Exhibit A) and watering as needed. DFID will provide fertilizer to the City.

If requested by the City, DFID will allow use of DFID's gator which is appropriately insured and use of DFID's watering wand and nozzle. DFID to provide City copy of proof of insurance.

For these services the DFID will pay to the City of Findlay \$5,000 to ensure coverage of all expenses incurred by the City of Findlay.

This agreement will be in full force and effect beginning May 24th, 2021 and shall apply to the term stated above.
