

Hi Kathy—

I am sending an email to you to try to explain a parking situation that we have in front of the public library. We have three spaces on Broadway (directly in front of our front entry door) that have been reserved for curbside parking for those that wish to call and have their books/tapes brought out to them so that they don't have to come inside. Elderly patrons and families particularly like this procedure. We have three signs sitting out in front of the spaces letting our patrons know that they are saved for "curbside" only. A permit was issued last year during the summer I believe. It was originally meant to be temporary but it was so well received that our Admin and Board has included that into our 3 year plan.

The issue is this. There is a sign hanging on a light pole which is located directly in front of space number two. The sign states that this is meant for a 10 minute book drop space and we do not need that anymore. Patrons place books/tapes/cd's that they have taken out and now are returning to the library. There are approximately 3-40 other spaces available for them to park in. In the past year there has been no issue with this until last week when two patrons got into an argument about the parking space. Both were correct in what they were doing because of the 10 minute sign.

To resolve this issue we would like to remove the 10 minute parking sign and continue our curbside service to the other patrons. We have those spaces used all day during our open hours. Thank you for your consideration with this.
