ORAL COMMUNICATIONS:

Jerry Arkebaker and Leon Wyden - University of Findlay bond issue

Mr. Arkebaker, Director of the Port Authority asked City Council to adopt tonight's ordinance that authorizes the Mayor to sign, as the highest applicable elected official, the issuance of tax-exempt bonds that the Blanchard Valley Port Authority would issue. The Port Authority Board has taken action to authorize the issuance of these bonds. They have already had the Internal Revenue Service's required public hearing and explained that the purpose of these bonds which is to assist the University in finalizing the construction costs for its new Student Activities Center and College of Business building. Ten million dollars (\$10,000,000) worth of bonds were issued earlier this year, and now it is their goal that another five million dollars (\$5,000,000) worth of bonds will be issued next week. In order for that to happen, City Council will have to authorize the Mayor to sign the required IRS form as the highest applicable elected official approval. This is a good project for the City and for the University.

Mr. Wyden, Vice President of Business Finance for the University of Findlay, explained that the University is mid-way through the construction of the lights in College of Business building. The brick is going up on the outside. The building's completion date is scheduled for July 31, 2017. The finance date is critical to have that plan move forward so that it is ready for students when they return this fall. It will be a beautiful building with a lovely entrance way and a wall that will recognize Findlay veterans as well as other veterans, helping to connect students with local veterans. The first floor will be a dining center with various food options for students. There will also be several different meeting rooms and areas that students, faculty, and staff will have access to. The College of Business will be on the second floor with state of the art classrooms, meeting rooms, and approximately thirty (30) offices for faculty. They are looking forward to having this building available this fall.

Discussion:

Councilman Monday asked if Mr. Arkebaker and Mr. Wyden's goal is for Council to suspend the rules and waive the readings tonight in order to pass this ordinance so that they can move through the bonds next week. Mr. Arkebaker replied it is. The set bond rate will expire next week, so the bonds have to be closed next week. It would be very helpful to keep this on schedule so they can do so.

Councilwoman Frische asked if Council has already done this for the University before and if it is a standard request. Service-Safety Director Schmelzer replied that every time the University does a project, this is required. Mr. Arkebaker added that every time they do a tax-exempt project, a bond issue has to be done in this manner. They have to have the Mayor sign to comply with the IRS.

City Auditor Jim Staschiak - RLF Administration

The Hancock Regional Planning Commission has submitted an invoice for their expenses/staff time for RLF administration for September 2016 through November 2016. This is now a routine request where Council has approved requesting the appropriation without going to committee each time. Legislation to authorize a draw from the Revolving Loan Fund account and appropriate \$1,283.31 from the RLF to General Expense #21010000-449400 to pay the invoice. ORDINANCES

ORDINANCE NO. 2017-001 (appropriations for current expenses & other expenditures for 2017) first reading adopted AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF FINDLAY, OHIO, DURING FISCAL YEAR ENDING DECEMBER 31, 2017, AND DECLARING AN EMERGENCY.

Councilwoman Frische moved to suspend the statutory rules and give the ordinance its second and third readings. Councilman Russel seconded the motion. Ayes: Frische, Harrington, Hellmann, Klein, Monday, Niemeyer, Russel, Shindledecker, Watson, Wobser. The ordinance received its second and third readings. Councilman Monday moved to adopt the ordinance, seconded by Councilwoman Frische.

Discussion:

Councilman Monday asked if the City Auditor could summarize what changes were made since the meeting in December. City Auditor Staschiak replied there are five (5) changes. The numbers in this ordinance reflect the numbers that were provided to City Council and the public during the finance presentation via the 2017 budget book. Fifty-seven thousand nine hundred dollars (\$57,900) was added to the general expense line 449300 which is a new line called Hotel/Motel – others. It is for the hotel/motel bed tax that the City collects. Twenty-five hundred dollars (\$2,500) was added to unemployment in the Recreation Department, four thousand dollars (\$4,000) was added to the HR budget for some incentives (a letter on it went out), and one hundred ten thousand dollars (\$110,000) was added to the Severance Payout Reserve due to a retirement that was not known about at the time the budget book was presented. The total General Fund budget is sixty-four thousand four hundred dollars (\$64,400) higher than the numbers that were received and reviewed during the budget meeting on December 15, 2016.

Discussion:

City Auditor Staschlak pointed out that the total amount of this appropriation corresponds with Ordinance No. 2017-001, page 4, Sanitary Sewer Maint line. The personal services account for those water lines do not add up to \$263,807. This ordinance is to remain in compliance with the State of Ohio.

Councilman Russel asked if the only reason a separate ordinance for storm water is not done and one is done for sewer is to keep in compliance with the State of Ohio. City Auditor Staschiak replied it is restricted monies. Money is appropriated out of the regular fund as part of Ordinance No. 2017-001, but since they are restricted, it requires a specific release of those restricted funds out of the storm water funds.
