Kathy,

Since I will be out of the office for the next Traffic Commission I wanted to give a little extra information on my end for the two items below.

- 1) Decrease speed limit on Tiffin Avenue and Center Street between North Blanchard and North Main Street from 35 to 25.
 - a. From my understanding in previous conversations, the City has the ability to change the speed limit for a section of roadway within City Limits. ODOT has a set of standards for speeds on roadways, but once the State Route runs into a City Corp Limit the City has the ability to adjust the speeds as needed to ensure the safety of its users. With that being said and it does pertain to this instance, but we cannot raise the speed above ODOT's standards but we can lower as we deem necessary.
- 2) Decrease speed limit on South Main Street from W. Lima Street to Southern Corporation limit.
 - a. Option 2 would be South to 6th Street.
 - b. This is a City Street and route so we can lower the speed limit as necessary for the safety and well-being of its users and citizens.
