We recommend that the City Engineer moves forward with services needed to validate and assemble data for CSO Long Term Control Plan projects. Move forward with drafting legislation for data collection and the modeling phase for the CSO LTCP for the amount of \$\$\pi\$ 390,000.

New Items

- 1. Combines Sewer Overflow (CSO) Long Term Control Plan (LTCP)
 - Per Kalb
 - Three engineering firms responded to the RFQ/RFP:
 - Strand
 - Stantec
 - Arcadis
 - Strand has been selected because they found some items in the previous CSO LTCP that could be reused & built upon whereas other two offered complete start-from-scratch plans
 - \$521,900 is Strand's bid
 - Other bids are believed to be higher, but we didn't have the figures available at the meeting; Stantec was competitive; Arcadis was significantly higher

- Strand plans include spring & fall 2023 flow monitoring, a quality control process to ensure modeling matches what we are actually seeing in the system
- Strand will
 - create a new system wide flow modeling
 - because this is an EPA mandated project, Strand will create a regulatory compliant framework for implementation in conjunction with the Ohio EPA
 - Strand will accompany City of Findlay in dealings with the EPA
- We expect to have a finalized plan by end of 2024
- Kalb wants to ensure that projects City of Findlay implements as a result of the CSO LTCP will actually be effective

- It will cost more upfront, but the hope is it will cost less in the long run
- Strands plan comes in 8 different distinct tasks
 - Tasks 1-4 we know we are doing the upfront tasks to design the modeling
 - Tasks 5-8 are more unknown based upon what the modeling tells us
- Staschiak suggests appropriation for tasks 1-4 initially and 5-8 after 1-4 is complete
 - 1-4 approximately \$355K
 - Kalbe is ok with this approach
- City of Findlay discussed our concerns with the previously approved CSO LTCP with the EPA – City of Findlay presented the flaws we saw in the plan
 - EPA agreed to provide City of Findlay with an extension once a firm is on-board and money appropriated
- Discussion amongst Council reps and Kalb/Martin on project management and communication requirements for Strand
- Kalb the ultimate goal for the CST LTCP is to remove CSOs and SSOs from our systems
 doing so will decrease the flow into the plant, extending the life of the plant
- Russel requests that we work toward developing a pro-forma for the sewer dept now that we have more accurate costs for the CSO LTCP
- Discussion about adding a contingency for steps 1-4 as part of the requested legislation -\$390K agreed upon
- Motion:
 - Recommend that the City Engineer move forward with services needed to assemble and validate data necessary for the CSO LTCP projects. Request that the Law Director draft legislation for the data collection and modeling phases of the CSO LTCP for the amount of \$390,000.
 - Motion Greeno; Second Russel
 - Motion passed (3-0)
