Mayor Muryn – Maumee Watershed Conservancy District MOA

Over the past decade, our community has lived in fear of storm events which could result in flooding, causing damage to property and significant financial and emotional distress. In the past five (5) years through the efforts of the Hancock County Commissioners , Maumee Watershed Conservancy District, Blanchard River Watershed Partnership and the City of Findlay, we have made significant progress through the below projects which together will lower the flood waters in downtown Findlay by approximately three feet (3 ft) in a one hundred (100) year storm event which would have kept Main Street dry in 2007. These projects provide even greater benefits in small storm events and benefit the entire Blanchard River Watershed.

- Completing transportation corridor improvements to ensure accessibility throughout our community specifically for safety services.
- Completing the phase 1 benching near Swale Park (0.8 ft benefit).
- Secured a Federal RAISE/BUILD Grant of \$7MM to support the modification and replacement of the Norfolk Southern Railroad Bridge which is expected to begin construction in late 2023 or early 2024. (0.3 ft benefit)
- Secured \$60MM in State of Ohio Department of Natural Resources funds to pay for construction of the Eagle Creek Basin which is slated to begin construction in 2024. (1.5 ft benefit)
- Working with Commissioners and ODOT to reconfigure 68/15 interchange to ensure accessibility.
- Secured the necessary properties and plans for completing the phase 2 benching in downtown Findlay which is expected to break ground in late 2023 or early 2024 (0.3 ft benefit).
- Working to complete all projects with prioritization focused on gaining greatest benefit most quickly.

The City of Findlay has been in communication with the Hancock County Commissioners, as well as, the Maumee Watershed Conservancy District to organize the transfer of properties to the City of Findlay, as well as, the long-term operations and maintenance of the projects.

The Phase 1 properties have already been transferred and are being maintained by the City. As part of today's agenda, two (2) separate pieces of legislation are being requested: 1) for the transfer of parcels rom the Hancock County Commissioners associated with the phase 2 benching in downtown Findlay. 2) To enter into a Memorandum of Agreement with the Maumee Watershed Conservancy District for the transfer of properties at the completion of construction of the Eagle Creek Basin. *(Exhibit B).*

A couple of items of note specific to the Eagle Creek Basin:

- There have been questions on the legality of utilizing stormwater funds for the operations and maintenance of the basin. The Law Director has already an opinion on this matter, but per the Auditor's request, Mayor Muryn is working to gather an outside opinion, however, this legislation does not define the specific way the City will cover the cost. This allows flexibility to determine the method in the future on whether it may be General Fund dollars or other funds. To ensure forward momentum on this project, Mayor Muryn is comfortable with the execution of this Memorandum of Agreement. The Maumee Watershed Conservancy District requested that this discussion be in process prior to their May 5, 2023 annual meeting.
- Projected Expense breakdown from the Engineering Firm (Exhibit A).
- It has been questioned whether property assessments are appropriate for this project. The Administration has been opposed to that method and continues to be. Additionally, that is not an option at this point.
- Upon completion of the various flood mitigation projects listed above, approximately two thousand (2,000) parcels are expected to be removed from the floodplain.
- The City of Findlay and Project Manager Steve Wilson have been in communication with FEMA regarding the flood redraw. All projects
 have to be significantly complete prior to requesting FEMA begin this process. The Administration are keeping a close eye on this and
 will begin as soon as possible. This project is projected to take approximately eighteen (18) months to complete.

City Auditor Staschiak - retirement settlements

The City of Findlay has experienced five (5) retirements so far this year with five (5) additional occurring in the coming weeks. These retirements were not included in the development of the 2023 budget appropriations as official written notice had not been received from the employees at the time. Legislation appropriating funds in order to pay these retirements that have already occurred and the known upcoming retirement settlements is requested. Ordinance No. 2023-042 was created.

Mayor Muryn – Miracle League donation

The City of Findlay received a donation of five thousand five hundred two dollars and two cents (\$5,502.00) from the Miracle League to go toward the purchase of security cameras to be installed at the Blanchard Valley Health System Miracle Park. These funds have been deposited in the General Fund. Legislation to appropriate funds is requested. <u>Ordinance No. 2023-044 was created</u>.

Mayor Muryn – appointment to Hancock Metropolitan Housing Authority Board; Parks and Recreation Board

Mayor Muryn is appointing Dionne Kinninger to serve on the Hancock Metropolitan Housing Authority Board. Her appointment will be effective through December 31, 2026. She is also appointing Greg Meyers to serve on the Parks and Recreation Board. His appointment will be effective through December 31, 2025. These appointments do not require Council's confirmation.

Fire Chief Eberle – Firefighter Hazmat training

The Ohio Public Utilities Commission (PUCO) offers a Hazardous Materials Training and Planning Grants Program which can be used for tuition cost of Hazmat training for Firefighters. The program is a reimbursement grant and the application period closes on May 31, 2023. The application is for twenty-two thousand five hundred dollars (\$22,500.00) that will host two (2) forty (40) hour Hazmat Technician courses scheduled for the fall 2023 and spring 2024. The grant program covers one hundred percent (100%) of the cost with no local match required. Award notification is not anticipated before August of this year. Legislation to apply for and accept the grant, if awarded, is requested. <u>Ordinance No. 2023-045 was created</u>.

PRECIPITATION & RESERVOIR LEVELS

Total precipitation recorded at the City of Findlay Water Pollution Control Center was 10.02 inches of rain and 10.3 inches of snow for the first quarter (Jan-Mar) of 2023.

At the end of March, the Findlay reservoirs stood at 89% of capacity. This reservoir level represents a 990 day water supply at the city's current usage rate.

The City of Findlay Water Treatment Plant treated 518.52 million gallons of water in the first quarter of 2023. That is an average of 5.76 million gallons per day.

All those planning to give testimony were sworn in by Jacob Mercer.

APPROVAL OF MINUTES

Dan Clinger asked a few follow up questions. On CU-02-2023, he wanted clarification whether we did not include landscaping as a condition. Jacob Mercer noted that the condition was to have an approved striping plan for the parking lot. Mayor Muryn added that due to the lot lines

there was not enough room for landscaping on the property. There will be additional landscaping added on the County owned property in the future which will help.

On the SP-04-2023, Mr. Clinger asked if there was any additional clarification if the MediaOne Building was demolished using FEMA dollars. Neither HRPC nor the City Zoning Staff have received an update.

Jackie Schroeder added on Page 15 there is a sentence that is cut off. Jacob Mercer said he would fix it.

Dan DeArment motioned to approve the minutes for the February 9, 2023 meeting. Dan Clinger seconded. Motion approved 5-0-0.

OLD ITEMS

1. APPLICATION FOR CONDITIONAL USE #CU-02-2023 filed by John Snyder to re-establish a pylon sign at 208 N. Main Street.

CPC STAFF

General Information

This request is located on the west side of N. Main Street at the southwest intersection with Meeks Avenue. It is zoned C-3 Downtown Commercial. To the north, south and east, it is also zoned C-3 Downtown Commercial. To the west, it is zoned C-2 General Commercial. It is located within the 100-year flood plain. The City of Findlay Land Use Plan designates the area as Downtown.

Parcel History

The site is vacant after Snyder's Auto Mart closed.

Staff Analysis

This item went to the February 9th CPC meeting to re-establish an auto sales business on the site. One of the conditions for approval was to remove the pylon sign from the site. Erik Atkins said in the meeting that the sign location hung over the right-of-way, which is prohibited. In section 1161.12.19 OTHER SIGNS, letter D. ABANDONED SIGNS & REMOVAL reads 30 Days - Owners of abandoned signs have thirty days to remove the violation after the Zoning Administrator issues a written citation indicating a sign has been abandoned.

In recent years, staff have promoted monument signage rather than allowing pylons signs. In the C-3 district, pylon signs are not recommended because they are traffic oriented signage. Staff is not supportive of the request.

Staff Recommendation

CPC Staff recommends denial of APPLICATION FOR CONDITIONAL USE #CU-02-2023 filed by John Snyder to re-establish a pylon sign at 208 N. Main Street.

DISCUSSION

John Snyder was present on behalf of the request. Matt Cordonnier offered some clarification, regarding the item. He said the original conditional use request for re-establishing the auto sales business on the site was approved with two conditions, one being the removal of the non-conforming sign. Mr. Snyder has asked the Commission to reconsider that condition of removal of the sign.

Mr. Snyder spoke saying that he was not notified that there was an issue with the sign. He wanted to know why his sign is being targeted when others along Main Street actually hang further into the right-of-way.

Erik Adkins said that the code states that after sixty days, non-conforming signs are required to be removed. He said that he sent a letter a few years ago to Brian Snyder without a response. He said that at the time, the property was zoned C-2, so the sign should be ten feet off the property line. Matt Cordonnier added that he did visit the site, and he said that although it may overhang, he couldn't definitely say how much it was overhanging it.

Mayor Muryn said there are two options. While not preferred, C-3 does allow pylon signs, so it would be conforming if it was not overhanging the right-of-way. The issue last month was approving the auto sales business in the C-3 district, which she said was not her favorite use of the site. She noted that there is signage on the walls of the building, so having the pylon removed would not be detrimental to the business and the removal of the sign would help clean up the aesthetic of the site. Mr. Clinger agreed and thought, given that there will be more than 25 cars parked on site, it will be pretty apparent what the business is without needing a pylon.

Mr. DeArment asked staff how long the business had been closed. Mr. Adkins said it has been closed since 2020. Mayor Muryn added that if the sign had been removed after they were notified, they would have been compliant with the C-2 district in the code. Since they waited, and the zoning changed, C-3 did allow for pylon signs, which is partly why we are reconsidering it. Mr. Adkins added the original pylon did make some sense due to the building locations along that stretch of Main Street and that the business was set back off the right-of-way. Since the floods and the demolitions in the area, all that remains is a flat floodplain, making the sign stick out more.

The site is currently vacant land.

Staff Analysis

The proposed plat would subdivide this area into nine parcels. At the east end of the site, there is an extension of the existing stub street, Glenmar Parkway. This would connect Andrew Jackson Lane to Smokies Way. This phase is in keeping with the overall development plan for the Glenmar subdivision.

CPC STAFF

General Information

This request is located on the north side of E. Sandusky Street directly west of the Stix Restaurant at 110. E. Sandusky Street. It is zoned C-3 Downtown Commercial and is completely surrounded by C-3. It is located within the 100-year flood plain. The City of Findlay Land Use Plan designates the area as Downtown.

Parcel History

The site is currently a parcel owned by the City of Findlay. The parcel was created via lot split in 2012 and is leased to the neighboring restaurant, Stix, for outdoor seating.

Staff Analysis

The applicant, Renz Salanga, has applied to have an outdoor bar space in an enclosed shipping container structure. While this is not listed as a conditional use explicitly, City Planning Commission has the discretion to review uses when deemed appropriate. The container itself is 8 feet by 20 feet in size. There is a window that can enclose the actual bar. Barstool seating can

be found around the perimeter of the bar. There is a staircase on the side of the container, which would allow patrons to have seating on top of the space.

Staff would add that Conditional Use permits are revocable if there are any issues with this use in the future.

Staff Recommendation

CPC Staff recommends approval of APPLICATION FOR CONDITIONAL USE #CU-03-2023 filed by Renz Salanga to construct a semi-permanent structure to be used as an outdoor bar at parcel 210001029176, adjacent to 110 E. Sandusky Street.

DISCUSSION

Renz Salanga was present on behalf of the application. Mayor Muryn started the discussion by acknowledging that this property is leased to Stix for use of the patio. Mr. Salanga has met with her and City staff to discuss the proposal and the City do not have any concerns about it.

Matt Cordonnier added that the application did go through the Design Review Board the prior night and was given approval of the design. Mr. Clinger asked for details on what it would look like. Mr. Salanga said the color of the container would be tricorn black, which will match the trim of the updates to Stix. He will be painting the sidewall white, but doing the trim tricorn black.

Mr. DeArment said that his concern was about having a sink in the structure for washing dishes and glasses. Mr. Salanga said that they would have two pipes coming from the Stix location, and piped into a handwashing sink station. They would only be using it during the warmer months, so it will be drained when it is not in use. The goal is to make the work for staff easier. Currently, they have an outdoor bar that they have to tear down every day. This would allow them to just close up and keep everything outside securely. Mr. Salanga added that he has had discussions with Wood County and they will require engineered drawings, which he is working on getting. Mr. DeArment asked if any existing doors would be blocked by the container. Matt Cordonnier noted that the back of the container backs up to the pocket park, so it is not backing up to the building. The shipping container essentially makes a fence for their liquor area.

Mr. Clinger asked if the signage in the submission was specific to his business. He noted one of the pictures showed a big coffee cup and said "Drink Coffee". Mr. Salanga said that was a stock image and that he does not intend to start selling coffee. Mr. Clinger asked how long Stix has been closed. Mr. Salanga said that he has been closed for a year and a half. He said they were pouring concrete in Stix this past week. He is working on getting people hired soon to re-open. The container will be one of the last pieces to getting things reopened. The container costs can vary widely, and the cheapest one he has found is in Thailand, so it may take a while to get it on location.

Mayor Muryn said she was excited to see the development and will do a good job to improve the area. Mr. Clinger asked if the shipping container removal would be added to the lease agreement. She said that it would be, and that the idea is that if they are no longer leasing, that they have to return the site to its previous state.

3.. APPLICATION FOR SITE PLAN REVIEW #SP-05-2023 filed by Terra Nova Medical Clinic, for a proposed 5769 sf medical office and parking at 710 Fox Run Road.

CPC STAFF

General Information

This request is located at the intersection of Greendale Avenue and Fox Run Road, behind the First United Church of Christ. The site has officially been rezoned to O-1 Office/Institution after they went to Planning Commission in December 2022. The surrounding area is a mix of office, residential and commercial. It is not in the 100-year flood plain.

Parcel History

The site is currently vacant land.

Staff Analysis

The parcel was created via split in April 2022. In December 2022, the site was approved to rezone from R-1 Large Lot Residential to O-1 Office/Institution. The proposed building is 5,769 square feet in size. It is only one story, so it meets the height requirements for the district. It has a parking lot that would accommodate 53 parking spots. This is well over the require parking 20 parking spots. The building meets the setback in the O-1 district.

The building has 83 foundation plants around the building which is above the required 64. The perimeter landscaping also meets the standard in the code. A photometric sheet shows that the lighting on site also meets the standard in the code.

Staff Recommendation

CPC Staff recommends approval of APPLICATION FOR SITE PLAN REVIEW #SP-05-2023 filed by Terra Nova Medical Clinic, for a proposed 5769 sf medical office and parking at 710 Fox Run Road.

ENGINEERING

Access -

The site will be accessed by a proposed drive to come off of Fox Run Road.

Water Service –

The site is proposing a 1.5" Water service to come off of the waterline that is located on the west side of Fox Run Road.

Sanitary Service -

The proposed sanitary service will connect to the existing sanitary sewer located at the east side of Fox Run. The Engineering Department agrees with the proposed plans that the sanitary lateral will need to be bored under Fox Run Road.

Stormwater Management -

Detention calculations have been submitted as part of the site plan and do comply with City standards. The site plans show a detention pond to be located on the south end of the property and the outlet pipe will tie into the City storm sewer located on the north side of Greendale Avenue.

MS4 Requirements –

The disturbed area is more than 1 acre so the applicant will need to comply with the City of Findlay's Erosion & Sediment Control Ordinance. Applicant has provided a SWPPP plan for the site.

Recommendations: Approval of the Site

The following permits may be required prior to construction:

- Sanitary Sewer Tap Permit x1
- Waterline Service Tap Permit x 1
- Strom Sewer Tap Permit x1
- Drive Permit x1

DISCUSSION

Dan Stone was present on behalf of the application. Jackie Schroeder asked if he could clarify about the detention. Mr. Stone said it was a dry basin. The land drains from the northeast to the southwest, he had it positioned there so that it would tie into the storm sewer. He noted that there is land on the south that could be a second building space. Mr. Clinger noted that there are a number of trees on the site, and it would be a shame to remove them. Mr. Stone said that given the EPA requirements, then needed the detention and it is the low spot on the site. The owner did attempt to keep the character of the lot by keeping as many trees as possible.

Mr. Clinger said one of his desires would be to move the detention and the building to the south to move it further from the apartments north of the site. Mr. Stone said the intent was to protect the south end of the lot for potential future development. The drainage is set up properly where they have it, they will screen the lighting to not be an issue with the neighbors too.

Mr. Clinger asked if Terra Nova was currently operating. Dr. Iyabo Adetutu Iboaya said that they were at the office space around the corner on Bright Road. This would be an expansion of the office. Mr. Clinger asked what kind of services they provide. She confirmed it is all out-patient care. Mr. Clinger asked if it was all ages or did they specialize. She confirmed it would be all ages. Mr. Clinger said they should consider adding additional handicapped spots for older patients. Mr. Clinger asked why there was so much parking. Mr. Stone said that the parking in the back would be for employees and the parking in front would be for patients. Dr. Iboaya said that with 4 providers and 15 staff they could have 16-17 patients at a time. Mr. Clinger said with 53 parking spots it seems like they have more than they need. Mr. Stone reiterated that this is what the practice needed rather than sticking with the minimum the code required.

Mr. Clinger asked if there was a dumpster. Mr. Stone said that they would only use wheeled containers, which would be located by the employee entrance. Mr. Clinger asked if they would have a requirement to have them screened. Matt Cordonnier said that trash receptacles should be hidden from view. He thought a small wooden fence would be appreciated. Mr. Clinger asked if the trash service would come back to the site. Dr. Iboaya said yes, and that is how they currently operate at their facility.

Mayor Muryn said that while she initially thought it would be good to move the building to the south, but overall she thought that it was a good use for the site.

Mr. Clinger wanted to discuss the architecture of the building itself. He said that as an architect they have a duty to meet the needs of the client while meeting the aesthetic of the neighborhood. He thought this current design failed to live up to that standard. Mr. Stone said that there is not an architectural code, and that his comments are excessive in terms of requirements. Mr. Cordonnier noted that there are architectural standards in the zoning code, and staff reviewed it based on those. He said that the current design does meet those standards.

Mr. Clinger had some additional comments on the north end of the building. He thought there was a door that currently did not have a connection to the parking lot. Mr. Stone said that if Wood County has a comment on that, they would connect it via sidewalk. Mr. Clinger wanted to see additional landscaping along the north of the site. Mr. Stone said that the Boxwood meets the standard. Mr. Martin said that this was more personal preference, but as long as they meet the code, he did not think they could dictate that. Mr. Cordonnier said the foundational plantings are allowed to be clustered, so he suggested that they shift some around to the north end of the building. Mr. Clinger asked about parking lot landscaping on the west side of the site. Mr. Cordonnier added that it is a rear lot line and typically that they do not require additional landscaping. He was not concerned given that this parking area abuts another parking lot.

CPC STAFF

General Information

This request is located on the east side of N Blanchard Street south of the intersection with Tiffin Avenue. It is zoned R-3 Small Lot Residential. To the north and west, it is zoned C-1 Local Commercial. To the south and east, it is zoned R-3 Small Lot Residential. It is located within the 100-year flood plain.

Parcel History

The site is currently vacant after a fire destroyed the home on site in October 2022.

Staff Analysis

The applicant would like to rezone the property to C-1 Local Commercial. This would allow the lot to be combined with the parcel to the north, which is Dan Maciejewski's State Farm Insurance Agent office. Once rezoned, they will be able to extend the parking lot. Given the small size of the lot, and the proposed parking expansion, staff is supportive of the rezoning.

Staff Recommendation



General Information

This request is east side of S. Cory Street, just south of the intersection with Lima Avenue. It is zoned R-3 Small Lot Residential. 827 and 829 S. Cory Street are zoned R-3, but otherwise the neighborhood is zoned R-2 Medium Lot Residential.

Parcel History

The site is currently operating as a duplex. Mr. Willford purchased the property in 2015.

Staff Analysis

Mr. Willford is in the process of selling the property. During this process, zoning staff communicated that there was no permit on file for the property to be operated as a duplex. During the zoning map update of 2020, the property was rezoned from R-2 Medium Lot Residential to R-3 Small Lot Residential due to the Auditor Tax Code indicating it was a duplex. When staff reviewed the property, they indicated that there was a lack of off-street parking for the duplex. One of the factors in reviewing whether to grant a conditional use for a duplex is having the required 2 off-street parking spaces per unit. In this case, there are only 2 spots currently when they need 4.

The applicant has indicated that they have requested a variance from the BZA regarding the off-street parking requirement.

4. APPLICATION FOR SITE PLAN REVIEW #SP-06-2023 filed by Taco Bell Corp, for a proposed 2657 sf new Taco Bell building at 701 W. Trenton Avenue.

CPC STAFF

General Information

This request is located between W. Trenton Avenue and W. Foulke Avenue along Fox Street. The site is zoned C-2 General Commercial. Along W. Trenton Avenue, it is zoned C-2 General Commercial. The neighborhood to the south and east is zoned a mix of I-1 Light Industrial and R-3 Small Lot Residential. It is not in the 100-year floodplain.

Parcel History

The site has been a Taco Bell restaurant since 2004. In the southwest corner of the site, there is a commercial building, but it has been acquired by G Made Inc for their Taco Bell expansion.

Staff Analysis

The owners of the Taco Bell are requesting a complete tear down and reconstruction of the restaurant. The drive-thru industry has seen a shift toward double-lane drive-thru's, and this would allow them to continue that trend.

The new building would shift to the southwest to provide the drive-thru more room along the east side of the site. The parking would shift to be entirely on the west half of site, with the drive-thru stacking starting at the south end of the site. The stacking would allow for 16 cars. The dumpster enclosure would shift to the middle of the site, but is going to be enclosed by a 6-foot-high privacy fence.

The only concern staff has is with the landscaping on site. The site plan indicates that they are short on perimeter landscaping, foundation plantings, and trees on site. Here is a breakdown on these requirements:

- Foundation Plantings: Required:44 shrubs; Provided: 24 shrubs
- Perimeter Landscaping Shrubs: Required: 152 shrubs; Proposed: 29 shrubs + keep existing
- Perimeter Trees: Required: 8 trees on the perimeter, 4 trees in the drive aisle; Provided: 2 trees and 15 shrubs

While the applicant is short on the landscaping, the overall flow of the drive thru and parking plan will improve the site layout.

Staff Recommendation

CPC Staff recommends approval of APPLICATION FOR SITE PLAN REVIEW #SP-06-2023 filed by Taco Bell Corp, for a proposed 2657 sf new Taco Bell building at 701 W. Trenton Avenue

ENGINEERING Access –

The site will be accessed by the existing curb cuts off of Trenton Avenue, Fox Street, and Foulke Avenue. The curb cut on Foulke Avenue will be reworked to a smaller drive apron that will match the existing curb cut on Trenton Avenue.

Water Service –

Sanitary Service -

The existing sanitary lateral will be utilized as part of the proposed building.

Stormwater Management -

The site will be incorporating more pervious areas throughout the site. No additional storm water detention will be required for the site.

The disturbed area is less than 1 acre so the applicant does not need to comply with the City of Findlay's Erosion & Sediment Control Ordinance.

Dear Honorable Council,

Over the past decade our community has lived in fear of storm events which could result in flooding, causing damage to property and significant financial and emotional distress. In the past five years through the efforts of the Hancock County Commissioners, Maumee Watershed Conservancy District, Blanchard River Watershed Partnership and the City of Findlay, we have made significant progress through the below projects which together will lower the flood waters in downtown Findlay by approximately 3 ft in a 100-year storm event which would have kept Main Street dry in 2007. These projects provide even greater benefits in small storm events and benefit the entire Blanchard River Watershed.

They include:

- Completing transportation corridor improvements to ensure accessibility throughout our community specifically for safety services.
- Completing the phase 1 benching near Swale Park (0.8 ft benefit).
- Secured a Federal RAISE/BUILD Grant of \$7MM to support the modification and replacement of the Norfolk Southern Railroad Bridge which is expected to begin construction in late 2023 or early 2024. (0.3 ft benefit)
- Secured \$60MM in State of Ohio Department of Natural Resources funds to pay for construction of the Eagle Creek Basin which is slated to begin construction in 2024. (1.5 ft benefit)
- Working with Commissioners and ODOT to reconfigure 68/15 interchange to ensure accessibility.
- Secured the necessary properties and plans for completing the phase 2 benching in downtown Findlay which is expected to break ground in late 2023 or early 2024 (0.3 ft benefit).
- Working to complete all projects with prioritization focused on gaining greatest benefit most quickly.

The City of Findlay has been in communication with the Hancock County Commissioners as well as the Maumee Watershed Conservancy District to organize the transfer of properties to the City of Findlay as well as the long-term operations and maintenance of the projects. The Phase 1 properties have already been transferred and are being maintained by the City. As part of today's agenda, I am requesting two separate pieces of legislation: 1) For the transfer of parcels from the Hancock County Commissioners associated with the phase 2 benching in downtown Findlay. 2) To enter into a Memorandum of Agreement with the Maumee Watershed Conservancy District for the transfer of properties at the completion of construction of the Eagle Creek Basin. (Exhibit B)

A couple of items of note specific to the Eagle Creek Basin:

- There have been questions on the legality of utilizing stormwater funds for the operations and maintenance of the basin. The Law Director has already provided an opinion on this matter, but per the Auditors request, I am working to gather an outside opinion. However, for the legislation before you this does not define the specific way the City will cover the cost. This allows us flexibility to determine the method in the future on whether it may be general fund dollars or other funds. To ensure forward momentum on this project, I am comfortable with executing the Memorandum of Agreement. The Maumee Watershed Conservancy District requested that this discussion be in process prior to their May 5, 2023, Annual Meeting.
- Projected Expense breakdown from the Engineering Firm (Exhibit A) -
- It has been questioned whether property assessments are appropriate for this project. The administration has been opposed to that method and continues to be. Additionally, that is not an option at this point.
- Upon completion of the various flood mitigation projects listed above, approximately 2,000 parcels are expected to be removed from the floodplain.
- The City of Findlay and Project Manager Steve Wilson have been in communication with FEMA regarding the Flood Map redraw. We have to wait until all projects are significantly complete prior to requesting FEMA begin this process. We are keeping a close eye on this and will begin as soon as we are able. This project is projected to take approximately 18 months to complete.

Thank you for your time and consideration of these critical pieces of legislation and continued support of flood mitigation efforts in Findlay and Hancock County.

MEMORANDUM OF AGREEMENT BY AND BETWEEN THE MAUMEE WATERSHED CONSERVANCY DISTRICT AND THE CITY OF FINDLAY, OHIO

I. BACKGROUND:

The Maumee Watershed Conservancy District (MWCD), a watershed district formed pursuant to Chapter 6101 of the Ohio Revised Code, has received recommendations for flood mitigation improvements in and near the City of Findlay from Stantec, a consulting firm hired by the MWCD to review the plan presented by the US Army Corps of Engineers General Investigation Study of the Blanchard River.

One of Stantec's recommendations was the construction of a Flood Storage Basin on Eagle Creek in Sections 1 & 2 of Eagle Township. In 2021, the Maumee Watershed Conservancy Court amended the District's Official Plan to include the recommended Basin.

Funding for the construction of the recommended Basin has been secured through three (3) grants totaling \$60 million dollars from the State of Ohio that are being administered by the Ohio Department of Natural Resources (ODNR).

MWCD does not wish to be responsible for the continued ownership of real property required to construct said Basin or to be responsible for the costs of future maintenance of said Basin. MWCD and the City of Findlay (CITY) seek to memorialize by this AGREEMENT a plan for the transfer of real property owned by MWCD needed to construct said Basin to the CITY and further to place the responsibility of future maintenance of said Basin with the CITY.

II. MWCD DUTIES AND REQUIREMENTS:

A. <u>Use of Funds</u>. MWCD shall use the funds authorized by the three (3) grants from the State of Ohio totaling \$60 million dollars to purchase necessary real property, engineer and design the proposed Basin in compliance with all State and Federal regulations, and construct said Basin to the final approved design.

B. <u>Disbursements.</u> In lieu of levying assessments as prescribed in ORC 6101.48 to pay the costs of a capital improvement, the MWCD shall submit advance requests to the ODNR on a periodic basis to utilize the grant funds to pay for property acquisition, design and construction of said Basin.

C. <u>Transfer of Real Property</u>. At the conclusion of construction of said Basin and following certification from ODNR that all costs associated with the acquisition of real property, design and construction of said Basin are in compliance with the grant close-out requirements of ODNR, MWCD agrees to transfer all real property acquired for said Basin to the CITY.

D. <u>Notice of Tax-Exempt Bond Financing</u>. The State of Ohio issued Tax Exempt bonds to finance the \$60 million of grant funding. Notices of Tax-Exempt Bond Financing are required to be recorded in the Hancock County Recorder's office for each of the real properties acquired in support of the Basin project. MWCD will assist the CITY with the recording of new Tax-Exempt Bond Financing Notices should ODNR require said notices as part of the transfer of property from MWCD to the CITY. E. <u>Periodic Inspection.</u> MWCD shall conduct periodic inspections of the completed Basin to determine if the CITY is complying with the responsibility to maintain the Basin as designed and constructed. These inspections are independent of the requirements of the ODNR Dam Safety Office for periodic inspection reporting of authorized and permitted constructed embankments. MWCD shall notify the CITY of any deficiencies and request immediate attention to said deficiencies. Likewise, if no deficiencies, MWCD shall notify the CITY of same.

F. <u>Representations</u>, <u>Warranties and Covenants</u>. MWCD is a subdivision of the State of Ohio with all the requisite power and authority to construct, or provide for the construction of, and operate the Project under the laws of the State and to carry on their activities as now conducted. MWCD has the power to enter into and perform its obligations under this Agreement and has been duly authorized to execute and deliver this Agreement. MWCD is not the subject of, nor has it initiated any claim or cause of action that would give rise to any liability which would in any way inhibit the ability of MWCD and to carry out the performance of the terms of this Agreement.

III. CITY OF FINDLAY DUTIES AND REQUIREMENTS:

A. <u>Transfer of Real Property</u>. In compliance with Section IIC, shall accept the transfer of all real property acquired for said Basin.

B. <u>Maintenance of completed Basin</u>. The City agrees to provide all necessary funding, labor, materials, and equipment necessary to maintain the completed Basin to it's constructed condition. The City further agrees to abide by all requirements of the ODNR Dam Safety permit that authorized construction of the Basin embankment.

C. <u>Assignment of Grant Agreements</u>. The City shall enter into an agreement with MWCD whereby MWCD will assign its obligations and under three (3) Grant Agreements between MWCD and ODNR, relating to appropriations for the Eagle Creek Watershed Flood Mitigation under S.B. 51 of the 132nd Ohio General Assembly, S.B. 310 of the 133rd Ohio General Assembly, and H.B. 687 of the 134th Ohio General assembly. Notwithstanding MWCD's assignment of its obligations and duties under the Grant Agreements, MWCD shall remain jointly and severally liable with the City for the performance of such obligations and duties.

IV. GENERAL TERMS

A. <u>Liability</u>. Each party to this Agreement shall be responsible for its own acts and omissions and those of its officers, employees and agents. In no event shall either party be liable to the other party for indirect, consequential, incidental, special, or punitive damages, or lost profits.

B Effective Date. This Agreement shall become effective by the date of last signature.

C. <u>Governing Law.</u> This Agreement shall be interpreted and construed in accordance with the laws of the State. In the event any disputes related to this Agreement are to be resolved in a Court of Law, said Court shall be located in the courts of Hancock County, State of Ohio.

D. <u>Entire Agreement</u>. This Agreement and its Appendices and Attachments contain the entire understanding between the parties and supersede any prior

understandings, agreements, proposals, and all other communications between the parties relating to the subject matter of this Agreement, whether such shall be oral or written.

E. <u>Assignment.</u> Neither this Agreement nor any rights, duties or obligations described herein shall be assigned by any party hereto without the prior written consent of the other parties.

OLD BUSINESS

Auditor Staschiak had noted a few meetings ago there are at least two sets of meeting notes that are not accurately reflected. He provided information from a meeting in November and one from a few meeting ago. He notes that the document does not accurately reflect the votes taken. Wober requested which items and Staschiak stated that he provided those items. He feels that notes are not reflecting what has been discussed in the meetings. Wobser said that for the issue of transparency that Staschiak should bring forward the items. Staschiak said that he does not feel that he has had the appropriate amount of time to review the documents and they have changed. Mayor Muryn stated that the version that is circulated this evening has been shared over the past few weeks, this is a version that is easier to read based on prior changes. The other document that has been circulated is community feedback that has been received since the last meeting. She prepared slides based on the requested from Wobser at the end of the last meeting.

Auditor Staschiak had abstained from voting on paying PlanningNEXT. The contract is not time specific it is not action specific, we should qualify any legislation that is needed in order to pay them the additional fees and it should be thoroughly reviewed. We should be very careful in the specific language. He was concerned all deliverables had not been met. Wobser stated there will be legislation at the City Council meeting to be discussed. Hellman asked if this is something that Wobser may want to meet regarding the issues that the Auditor has raised. Wobser stated the deliverables have not changed but the time has changed, we are six months past where we are supposed to be. Nothing has changed with the deliverables from the initial contract. Staschiak is not in favor of paying additional money, he believes it should be treated as a change order to a contract. He wants to make sure it is clear from an auditors perspective. Mayor stated that following the last meeting legislation should have been included, it is added legislation for the Council meeting. As it is worked through the process is the auditor has concerns it can be amended through the process. Hellman agrees that the consultant has done their part and would like Staschiak to put together a one pager explaining the situation and work with the Mayor on it. Staschiak said he will work with all parties.

Auditor Staschiak has mentioned that some things in the document are not City functions. One in particular is assisting in delinquent taxes. The powers are municipal corporations are spelled out specifically in the Ohio Revised Code. Wobser stated we have always said the plan is for what the City is able to do under the law. Staschiak said that he is not the City law director. Wobser stated that the law director and City Council will need to review and approve the final draft before it is adopted.

NEW BUSINESS

Muryn presented the updated recommendation from PlanningNEXT for the goals of a "safe community." "A safe community where people feel comfortable in their community because of its well-maintained physical appearance and well trained and equipped emergency response." Muryn asked if the group would like to review this and discuss it in the next meeting. Russell said it should be held for the next meeting.

Muryn said that she would like to go through the goals and objectives. She will read them and allow items to be pulled for consideration otherwise they will be approved. The information on the document has not changed.

Goal 1

Muryn read Goal 1 Objectives and subpoints 1.1-1.5. Stasciak asked if 1.1 includes non-city provided services. Russel believes there should be an adjective added before "detention" to clarify it is about the jail and not water in 1.3. Muryn suggested adding "inmate" to goal 1.3. Staschiak questioned if how it appears as it's all framed together. He asked if alternative sentencing should be included. Russel stated that information would be included in a bullet under that point. 1.3 is the high scale point. Wobser agreed. Staschiak questioned if additional language to broaden is necessary. Muryn suggested broadening to "ensuring appropriate community criminal justice needs are met." Russel stated this point was specific to the jail facility discussions that are occurring. She asked if we should pull the item to be considered later.

Wobser motioned to approve goal 1 with the word "inmate" after "term."

Russel suggested "Ensure inmate detention needs are met. "Russel the group is at the point where the court system is telling the individual this is the next step and what that might look like. This is a broad goal which many things fall under.

Russel motioned to pulling 1.3 for further consideration. Muryn seconded. 7-0 passed

Wobser motioned to approve 1.1, 1.2, 1.4, 1.5 as written. Seconded by Russel. 7-0 passed

Goal 2

Muryn read goal 2 objectives and subpoints 2.1-2.8. Russell questioned why 2.5 would not be under 2.8. He said that City facilities fall under City infrastructure so it makes having them both unnecessary. Staschiak suggested that it all falls under capital assets.

Muryn moved to merge 2.5 and 2.8 and reword 2.8 as follows "Maintain, plan, and invest in Capital Assets to ensure it is safe, affordable, and high quality." Second by Greeno. 7-0

Staschiak asked if the 1% income tax was important enough to move up from the sub bullet under 2.6. Russel agreed it is worthy of being bumped up a level. Hellman asked if this would bind us to this in the case of an emergency situation. Staschiak clarified that it would not and that this is simply stated we are going to do everything we can to not raise it.

Staschiak moves to add "while protecting the 1% income tax rate." to goal 2.6. Seconded by Russel. 7-0

Muryn motions to approve slate of goal 2 as presented. Hellmann seconded. 7-0

Goal 3

Muryn read goal 3 and the objectives. Staschiak questioned what point 3 refers to and means to the group. Wobser said it is the City making sure that we are working with community groups to ensure that we are creating connections. Russel said that it is intangible but it is neighbors helping neighbors, it's pride in your City, it's community clean up events with overflow of volunteers, it's people picking up trash on their own, it's what makes people choose living here over other places.

Wobser questioned the use of the word equity in goal 3.2. Should the term equity be included in the list of values, it is quite different than the word equality. Russel agrees that the word equity is political charged right now and does like the order that the words are in. The use of the word equity in this document brings on a lot it is not trying to say or that it is not about. He is unsure why the parenthesis is in a high-level statement. It is also used in 3.1 and should be removed. Staschiak concurs that the words in the parenthesis should be removed, they can be addressed in the subpoints. Russel stated that words have meaning and in that order they are quite loaded. Muryn agrees that they can be removed and added to subpoint. Muryn suggests to change the wording of goal

Muryn motion to changed wording to "a caring government that supports all community members and looks for opportunities to strengthen community pride and belonging" Russell second. 7-0

Russell move to remove parenthesis text on 3.1 and 3.2. Greeno second. 7-0

Discussion on Section 3:

Staschiak questioned if there should be any more sub goals added to goal 3. Muryn likes the change to the word "belonging" to be consistent, it is ok to leave these points broad at this point. Staschiak suggested adding a sub goal 3.3 to discuss community celebration and pride. Russell believes there is merit but it should be tabled and thought over.

Goal 4

Muryn read goal 4 and objectives 4.1-4.6. Russel stated that 4.6 is an action item and not an objective. It is a very important resource for the City that we would not be able to maintain without FAA grants. Staschiak asked if the airport is bumped up a level to recognize the importance of the

airport. Marathon used to own it and gave it to the city because we are eligible for the grants. The group considered adding "protect the airport" but Staschiak pointed out that it implies we could lose the airport. We should never give up the airport.

Muryn motion to change language to "Promote and preserve the Findlay Airport as a vital community resource." Staschiak second 7-0

Staschiak asked if 4.2 should be higher level that it should not just be done through programs but also legislation and grant assistance.

Hellman motion to change language of 4.2 to "support business and entrepreneurs through various initiatives." Wobser second. 7-0

Staschiak questioned if skilled trades should be mentioned in 4.4. They are very important to our community. Hellmann wanted to confirm that included masonry. Muryn clarified that she wanted to make sure it is clear that it is referring to trade labor and not unions.

Wobser motion to change subgoal 4.4 to "Support education, skilled trades, and workforce development." Staschiak second. 7-0

Stasciak questioned if 4.5 should go to goal 3. Muryn suggested that she leave a note and that PlanningNEXT can give a recommendation when they go through. The group was ok with that.

Russel questioned if 4.3 holds up at this level after the conversation of the sub bullets. Should it be held or discussed now. Staschiak agreed that it could drop down because it fits as an action item. Russel said that they heard in community sessions discussion regarding broadband. He is vehemently opposed to the City undertaking that. We should remove the "government owned" portion. Muryn said that we already own the fiber network. Russel clarified that we are not offering it to individuals. Muryn stated that Findlay City Schools, the City, and the County owns a trunk. Staschiak said as he understands as a municipality of Ohio we are only able to do what is strictly stated under the law. Russell questioned if he is sure that is true. Staschiak said we are allowed to own our own utility lines but are we allowed to be in the business of utilities that are not specifically authorized. Wobser stated that this deserves more conversation and that it should be moved to another time. Russell agreed and that it should be left at this level for the time being.

Staschiak suggested that at some point in time the Mayor should be authorized to talk to Bricker? They are doing a lot of other work for us on some of these specifics. Wobser concurred.

Russel motion to approve goal 4 and subpoint 4.1, 4.2, 4.4, 4.6 as it reads and with understanding that 4.3 and 4.5 will get further consideration. Warnecke second.

Disccussion: Staschiak asked if there should be reference to the state of Ohio.

Russell Motion to change 4.1 to "continue to strengthen economic development through ongoing partnerships" Seconded by Hellmann. 7-0

Goal 5

Muryn read goal 5 and sub goals 5.1-5.6.

Russel feels that the words play and explore are redundant in goal 5 and that PlanningNEXT should look at it. Group agreed to have PlanningNEXT re-word goal 5. Muryn to follow up. Auditor stated that goal 5 is very important and there should be enough time for more conversation.

Wobser moved to move May 2 meeting to May 3.

Wobser adjourned the meeting.

"Effective January 8, 2023, employees with the titles of Water Treatment Plant Operator, Water Treatment Plant Operator Assistant, Lab Technician I and II, Wastewater Treatment Plant Operator and Wastewater Treatment Plant Operator Assistant shall be paid an hourly shift differential during the afternoon and overnight shifts.

Eligible employees shall receive one dollar forty cents (\$1.40) per hour for each complete hour worked between 4 p.m. and midnight, and they shall receive (\$1.00) per hour for each complete hour worked between midnight and 8 a.m. Shift differential shall not be paid for any partial hour worked.

When an eligible employee works between the hours of 4 p.m. and 8 a.m. on the holidays outlined in Section 23, Paragraph D, or when an operator is working overtime during the hours of 4 p.m. through 8 a.m., appropriate shift differential will be paid at the same factoring rate as the base wage.

It shall be replaced with:

Effective May 14, 2023, employees with the titles of Water Treatment Plant Operator, Water Treatment Plant Operator Assistant, Lab Technician I and II, Wastewater Treatment Plant Operator and Wastewater Treatment Plant Operator Assistant shall be paid an hourly shift differential during the afternoon and overnight shifts.

Eligible employees shall receive one dollar forty cents (\$1.40) per hour for hours worked between 4 p.m. and midnight, and they shall receive (\$1.00) per hour for each hour worked between midnight and 8 a.m. These amounts shall be pro-rated and rounded to each quarter of an hour during the hours named above.

When an eligible employee works between the hours of 4 p.m. and 8 a.m. on the holidays outlined in Section 23, Paragraph D, or when an operator is working overtime during the hours of 4 p.m. through 8 a.m., appropriate shift differential will be paid at the same factoring rate as the base wage.

SECTION 2: That Section 10 of Codified Ordinance No. 2022-81, As Amended, of the City of Findlay, that Paragraph E be added and shall read as follows:

"E. Effective May 14, 2023, an employee of the Water Treatment Plant who is assigned the duty of gathering water samples for testing shall be granted one-half hour (thirty minutes) of paid time for completing that task."

SECTION 3: That Section 10 of Codified Ordinance No. 2022-81, As Amended, of the City of Findlay that Paragraph F be added and shall read as follows:

"F. Effective May 14, 2023, an employee who is assigned the duty of opening and/or closing the Findlay Maple Grove Cemetery gates on days scheduled by the Public Works Superintendent or the Public Works Supervisor shall receive ¾ hour (45 minutes) for each instance of opening or closing the gates. If the employee is eligible for overtime, the Public Works Superintendent or Public Works Supervisor may mandate upon acceptance of the gate opening/closing duty that the time received be converted to compensatory time and be subject to the rules of the compensatory time accruals."
