Mayor Muryn - Revolving Loan Fund Board appointment

Mayor Muryn is appointing Chris Keller to the Revolving Loan Fund Board. Ms. Keller have expressed a desire and willingness to continue to serve the community as members of the City Revolving Loan Fund Board. Her appointment will be effective January 1, 2024 through December 31, 2025. This appointment requires Council confirmation.

Police Chief Mathias – seized drug investigation funds

On November 16, 2023, the Findlay Police Department received notice from the Hancock County Common Pleas Court of the seized six thousand thirty-six dollars and forty-three cents (\$6,036.43) from a suspect in a possession of drugs investigation. That case was dismissed in the court system, but the money seized during the investigation was ordered to be forfeited to the Findlay Police Department. The six thousand thirty-six dollars and forty-three cents (\$6,036.43) was taken out of the Police Department's property room and was deposited with the City Auditor's Office. Police Chief Mathias would like to use these funds to purchase equipment for one high efficiency drug disposal incinerator for evidence drugs, paraphernalia, and Active Pharmaceutical Ingredients (API's) for the Property Officer and have been unable to recently meet EPA, State and Federal requirements at facilities around the area in Ohio and Michigan. This unit would save personnel from driving long distances to dispose of these types of items in the future and to do it locally, safely, and effectively in the future. Legislation to appropriate funds to the City of Findlay Police Department budget is requested. Ordinance No. 2024-014 was created.

Mayor Muryn - local Opioid Settlement Funds

Mayor Muryn is providing a quick update related to the City of Findlay local Opioid Settlement Funds. As of December 31, 2023, the City of Findlay had \$55,099.04 in the local Opioid Abatement Fund. These dollars are to be utilized for a variety of purposes broadly related to Strategies for Community Recovery, Strategies for Statewide Innovation & Recovery, and Strategies for Sustainability. When looking at strategies for community recovery, they include treatment, early intervention and crisis support, address the needs of criminal justice involved persons, mother-centered treatment and support, recovery support, prevention, harm reduction, services for children, first responder support, and workforce. In discussion with the Hancock County Board of Alcohol, Drug Addiction and Mental Health Services (ADAMHS), it is recommend to hold these dollars for the time being. This allows the City to leverage other funds that are being deployed from regional, state and federal partners. Accumulating these dollars and holding them for a more impactful deployment will best serve the community. The City will continue to evaluate this on a regular basis and will come to Council when ready to implement the funds. Mayor Muryn encourages Councilmembers to have anyone that contacts them on use of these funds, to have them reach out to the ADAMHS Board or a specific local service provider to work with the City to understand the feasibility. Mayor Muryn – appointment to Airport Advisory Board

Mayor Muryn is appointing Matt Rutter to serve on the Airport Advisory Board. His appointment will be effective through December 31, 2026. This appointment does not require Council's confirmation.

City Engineer Kalb - ODOT FY24 HAN-Bigelow Avenue, PID117611 (32833800)

As authorized by Ordinance No. 2023-079, a bid opening was held for this project on January 25, 2024. Bids were received from three (3) potential contractors with the bid amounts ranging from \$643,743.00 to \$812,080.00. The lowest and best bid was received from Shelly Co., Inc. of Findlay, Ohio. All of the received bids were under the Engineer's estimate of \$833,524.75. This project is included in the 2023 Capital Improvements Plan and will be using the grand funding received from the Ohio Department of Transportation (ODOT) annually for being one of the largest seven (7) cities that are not part of an Metropolitan Planning Organization (MPO). The grant funds can be used to cover eighty percent (80%) of the construction cost up to \$714,287.80 (eighty percent (80%) of Engineer's Estimate and Construction Engineering Reimbursement). Since the grant agreement is for \$714,287.80, that amount needs to be appropriated even though the City should end up receiving \$516,000 based upon the bid amount. Two thousand dollars (\$2,000) was previously appropriated to the project for advertising. Additional funds are not needed to cover the City's portion of the construction cost and provide a contingency for the project. Legislation to appropriate and transfer funds for capital expenditures is requested. In order to maintain the schedule that is required for funding, the ordinance needs to be approved during the February 20, 2024 City Council meeting. Ordinance No. 2024-016 was created.

As part of the final punch list, there are a couple of items that will need to be completed prior final acceptance of this project. Once spring comes around, the project will be reseeded in areas that are deemed necessary, adjust any outstanding drainage issues, and complete outstanding project items. To ensure that there are enough funds in the project to compensate the contractor for any additional work that may be needed, it is desired to appropriate additional funds to the project to cover the estimated cost. Legislation to appropriate and transfer funds for capital expenditures is requested. Ordinance No. 2024-017 was created.

The Ohio Department of Transportation (ODOT) Aviation Division has awarded the City a grant in the amount of \$465,880 for the replacement of the Precision Approach Path Indicator (PAPI)s and Runway End Identifier Lights (REIL)s on Runway 7/25 at the Findlay Airport. The awarded grant funds will cover ninety-five percent (95%) of the design and construction of the replacement and the City will be responsible for a five percent (55%) local match. Legislation to appropriate and transfer ODOT Aviation grant funds and the City's local match funds to the project so the design work can commence is requested. <u>Ordinance No. 2024-018 was created.</u>

The awarded grant funds will cover five percent (5%) of the design cost. Previous appropriations have been made to appropriate funds from the Federal Aviation Administration (FAA) grant and part of the local match. Meredith is a Field Engineer with OneEnergy and has a background in Mechanical Engineering. Her background in engineering, knowledge of communities across the country, and passion for Findlay will be an asset to the board. Both individuals have shared their passion for the Findlay community and desire to be more engaged helping Findlay maintain its character while spurring investment and protecting downtown as an attractive place for all to enjoy. Their terms will expire December 31, 2026. These appointments require Council's confirmation.

Mayor Muryn – Ordinance No. 2024-010

As mentioned at the APPROPRIATIONS COMMITTEE meeting, the City of Findlay received updated project cost share estimates for the reconfiguration of 68/15. The updated cost share is now approximately \$573,000, therefore, she is requesting Ordinance No. 2024-010 be amended to appropriate \$575,000.00 Legislation to amend Ordinance No. 2024-010 is requested. <u>Ordinance No. 2024-010, AS AMENDED was created as an add-on (already received its first reading during the January 16, 2024 Regular Session City Council meeting).</u>

City Engineer Kalb – Blanchard Street Waterline, Phase II-OPWC, Project No. 35740500

The City of Findlay Engineering Department is working on the design on multiple projects so that it can be advertised early in the construction season. It is now desired to appropriate startup funds to the Blanchard Street waterline replacement project for design and advertisement. This project consist of replacing the existing 10-inch waterline on Blanchard street with a new 16-inch waterline. The replacement will start at Sixth Street and will stretch south towards the south water tower. Legislation authorizing the Mayor, Service-Safety Director, and/or City Engineer to advertise for bids and enter into contracts for construction, as well as appropriate and transfer funds is requested. Service-Safety Director Martin – authorization to sell parcel #570000921770 (515 Prospect Street) at public auction

The City of Findlay has owned the property at 515 Prospect Street (parcel no. 57000921770) since 1999. The property had garage structures on the property and had been used for vehicle maintenance and minor storage for the Findlay Police Department. In December of 2022, there was an appraisal completed when the structures were still standing. The structures on the property were found to be in bad shape and based on the poor conditions of the buildings, a decision was made to tear down the structures in anticipation of future discussions on what to do with the property with Council. Currently, this parcel is a grass lot and is of no purpose to the City with a land value of approximately ten thousand dollars (\$10,000). With Council's approval, it is the City Administration's intent to sell this lot at public auction to the highest bidder. Legislation authorizing the City Administration to proceed with the sale of Parcel #570000921770 by public auction is requested. Ordinance No. 2024-021 was created.

Mayor Muryn – flood mitigation update & FEMA Hazard Mitigation grant

This letter is submitted jointly to provide an update on flood mitigation efforts and request support for an application to the Federal Emergency Management Association, FEMA. In 2023, FEMA released a notice of funding for the Flood Mitigation Assistance grant. The detailed Notice of Funding can be found at the following link, Microsoft Word - Final_Upload_FY23 fma-nofo-fact-sheet_DRAFT_9.22.23_clean_SUBMIT_highlights (fema.gov). FEMA requires a member of the National Flood Insurance Program (NFIP) to be an applicant for the funding opportunity. The City of Findlay is a member of NFIP and are requesting that the City of Findlay applies for the \$20,000,000 from FEMA to be utilized for the flood mitigation efforts detailed below. In November 2009, the votes of Hancock County passed a .25% sales tax to be utilized for flood mitigation. The sales tax generated more than thirty-two million dollars (\$32,000,000) over a ten (10) year period. In addition, the community has received financial support form the Federal and State Governments. Local, State and Federal investments have support the completion of the following: purchase of properties which had regular significant damage due to flooding, transportation corridor improvements to ensure safety service accessibility throughout the County and Phase 1 benching. In addition to the projects completed, there are three (3) major projects in the design phase; widening of the Norfolk Southern Railroad Bridge from one hundred fifty feet (150') to three hundred feet (300'), the Eagle Creek Flood Basin and Phase 2 Benching east of the Norfolk Southern bridge. Following the completion of the benching project, Norfolk Southern bridge expansion and the Eagle Creek Basin, there will be a decrease in flood waters by three feet (3') in downtown Findlay during a 100-year storm event, as well as the removal of hundreds of parcels and hundreds of acres of tillable farmland from the 100-year flood plain. These projects are critical to the long-term sustainability of Hancock County. Investing in the community to reduce flooding shows citizens, as well as our businesses, as well as outside investors that Findlay is a safe, sustainable community to live, invest, and work. Although a significant amount of funding has been secured to complete the Eagle Creek Basin, Phase II Benching and the Norfolk Southern Bridge there is still funding needed to complete all of the projects. The table below details the 2019 construction cost estimates for the three (3) remaining projects along with the current construction estimates.

To date, there has been multiple sources of funding secured to complete the projects.

- Norfolk Southern Railroad Bridge the Federal Government has awarded a seven million one hundred thousand dollar (\$7,100,000.00) RAISE grant to be utilized for the construction of the railroad bridge. After the RAISE grant was awarded, the construction costs rose significantly and the grant is not indexed to increased costs. The increased cost has created a shortage of funds to complete the project. It has been requested that Norfolk Southern close one hundred percent (100%) of the remaining gap to replace this 100-year bridge.
- Phase II Benching the County Commissioners have over six million dollars (\$6,000,000.00) remaining in the Sales Tax Fund that was
 generated over a ten (10) year period form 2009-2019. The sales tax remaining is sufficient to cover the cost to complete Phase II
 Benching.
- Eagle Creek Storage Basin the State of Ohio has awarded sixty million dollars (\$60,000,000.00) to the Ohio Department of Natural Resources to complete the Eagle Creek Storage Basin.
- In 2023, the City of Findlay approved two million five hundred thousand dollars (\$2,500,000.00) in Capital Funding to be utilized for flood mitigation.

To secure funding and complete construction of three (3) remaining projects, the City of Findlay has been requested to submit a Federal Emergency Management Agency, Flood Mitigation Assistance grant application.

For audit purposes, a resolution of support is requested to request authorization from City Council to submit the application for the Federal Emergency Management, Hazard Mitigation grant for a requested amount of twenty million dollars (\$20,000,000.00). The grant application is due February 22, 2024 and are requesting the legislation be adopted during the February 6, 2024 City Council meeting.

Submitting this grant does not bind the City of Findlay to any specific funding agreement for flood mitigation efforts moving forward, and per Ohio EMA, the local match requirement is met through the funds which have already been spent on flood mitigation efforts, as well as the State funds towards the Eagle Creek Basin. <u>Resolution No. 009-2024 was created</u>.



Women's Resource Center of Hancock County 116 Laquineo Street Findlay, Ohio 45840

Parcel History

- Women's Resource Center of Hancock County ("WRC") purchased the property at 116 Laquineo on 8/2/2021.
- WRC purchased this property with the intent to remodel and use this property as offices, secondary to the primary location at 1011 N. Main Street, which is an abutting parcel.
- An application for Conditional Use #CU-08-2-21 (see attachment 1) was submitted to the City Planning Commission ("CPC"), and on November 10, 2021, the CPC approved the application with the following conditions (see attachment 2, meeting minutes excerpt).
 - Vacate the north-south alleyway between 116 Laquineo Street and 1011 N. Main Street.
 - o Combine the parcels containing 116 Laquineo Street and 1011 N. Main Street.
- In reference to attachment 2, pg. 2, where a possible parking deficiency existed. In recent months, an additional parking space has been added on the west side of the garage at 116 Laquineo. This brings the total number of parking spaces between 1011 N. Main and 116 Laquineo to a total of 16 spaces. See attachment 4 for a picture of the newly created parking space.
- The alley vacation petition for the alleyway, (Cypress Avenue) was submitted and approved by Findlay City Council March 2022, reference ordinance 2022-014. See attachment 4 for meeting minutes excerpt.
- The parcel combination request was sent to the Hancock County Auditor's Office in June 2022 (see attachment 5).
- On or about December 5, 2022, during a routine check of the Auditor's website to see if the parcels were merged, it was observed from the Auditor's map that both parcels were merged (see attachment 6). Based upon what was observed, it was assumed that the parcel merger request was approved and completed.

- In early 2023, property tax bills were received from the Hancock County Auditor for the parcel location at 116 Laquineo.
- WRC was under the assumption that there would be no separate real estate tax bill for 116
 Laquineo as a result of observing the merged parcels (reference attachment 6).
- Upon contacting the Auditor's Office for clarification, the WRC was informed that the parcels were not merged due to the land use codes being different between the two parcels.
- The parcel location at 1011 N. Main Street (the original WRC building), was exempt from real estate taxes as it had a land use code of 680, which is used for charitable organizations.
- The parcel location at 116 Laquineo had a taxable land use code.
- An application was submitted to the State of Ohio to change this land use code for the 116
 Laquineo property to that of a charitable organization in January of 2023. See attachment 7 for cover sheet of application.
- In January 2024, the State of Ohio approved this land use code change and both parcels owned by WRC now have the same land use code. See attachment 8.
- The Hancock County Auditor is requiring the parcel merge application to be resubmitted as such a long period between the initial application and State approval has made the original application null and void.
- To avoid added confusion in this matter, the WRC has elected to postpone the application for parcel merge until the outcome of this zoning matter is determined, unless the bodies governing this rezoning process deem otherwise. Postponing this parcel merge also prevents a situation where a parcel has two separate zoning codes.

Current Petition Request

- The WRC would like to install signage in front of 116 Laquineo, however current zoning regulations prohibit this for an R-3 property.
- Whereas WRC is seeking to change the zoning for 116 Laquineo Street from R-3 to O-1.
- The original WRC office at 1011 N. Main Street is zoned O-1.
- Upon successful rezoning of 116 Laquineo;
 - The appropriate permits will be completed prior to installation of any signage at 116
 Laquineo.

CPC STAFF

General Information

This request is located on the north side of Laquineo Street, just east of the intersection with N. Main Street. It is zoned R-3 Small Lot Residential, but is also within the University Overlay District. To the north and west, it is zoned Office. To the south and east, it is zoned R-3 Small Lot Residential. It is not located within the 100-year flood plain. The City of Findlay Land Use Plan designates the area as Single Family-Small Lot.

Parcel History

The site has been a residential dwelling. The Women's Resource Center purchased the building in August 2021.

Staff Analysis

The applicant is proposing to renovate the interior of 116 Laquineo Street into additional office space for the Women's Resource Center. Since the parcel is located within the University Overlay, office is a conditional use.

Stoff had concerns about parking on the site. There are currently only two off-street parking on the parcel. The Office parking requirement would be one space per 300 square feet. This would require the site to have six parking spaces. The parking lot at the main Women's Resource Center location, 1011 N. Main Street, has nineteen (19) total spots, which is enough for both buildings. Staff recommends that due to the lack of parking at 116 Laquineo Street, that the Women's Resource Center combine the two parcels. The alleyway that runs north/south between the two parcels should be vacated as part of the combination process.

Staff Recommendation

By having the funds set as de early, he can get the contracts signed and projects can get done early.



Councilman Russel asked if this ordinance is passed tonight if it would allow bidding to go out without having to deal with pricing pressures. City Engineer Kalb replied that a lot of the bidding will be on equipment and vehicles that will involve state contracts who will not hold pricing and may ask for rebids. The City's projects have funds included for street resurfacing. One of the benefits to getting bids out early is that contractors want to get started early which gives the City an advantage because they tend to be their first jobs for the year so they get the job done quicker. By having the funds set aside early, he can get the contracts signed and projects can get done early.

Mayor Muryn added that even the Police Department is ordering boots for new hires early because of the supply chain and length of time they arrive which may not be until October. The sooner items needed for projects can be ordered, the better so that it is ensured that we will receive them.

Councilman Wobser noted that asphalt directly related to the crude oil price has gone up over the last two (2) weeks, but could come down just as quickly depending on what happens in the world markets, so the City needs to be cautious in buying too far in advance and could end up with a much better price towards the end of the season.

President of Council Harrington added that Spot Oil went below a hundred dollars (\$100.00) today for the first time in quite awhile which made the markets go wild.

Councilman Russel moved to suspend the statutory rules and give the Ordinance its third reading, seconded by Councilman Bauman. Ayes: Slough, Warnecke, Wisener, Wobser, Bauman, Hellmann, Niemeyer, Palmer, Russel. The Ordinance received its third reading. Councilman Wobser moved to adopt the Ordinance, seconded by Councilman Palmer. Ayes: Warnecke, Wisener, Wobser, Bauman, Hellmann, Niemeyer, Palmer, Russel, Slough. The Ordinance was declared adopted and is recorded in Ordinance Volume XXIII, Page 2022-017 and is hereby made a part of the record.

I am excited to inform you of the continued success of the Ohio Municipal League to strengthen our advocacy efforts and better represent your community to the state's executive and legislative policymakers, as well as the critical need to continue that success through our enhanced advocacy services.

Last year, the Ohio Municipal League engaged the Montrose Group, LLC, a Capitol Square consulting firm with substantial municipal lobbying and local economic development experience, to expand our advocacy footprint and enhance our strategies for protecting municipalities. This engagement provided OML additional lobbying support to combat a very challenging start to the 135th Ohio General Assembly.

The enhanced lobbying approach has paid big dividends. Through it we have successfully advocated against the efforts of some legislators against the municipal income tax that could lead to further changes in how municipal income taxes are administered, putting the sustainability of this critical funding source in jeopardy. We have also successfully lobbied against special interest groups' continued efforts to erode local regulations and compromise the ability of municipalities to operate in a manner consistent with the home-rule authority granted to them through Article XVIII of the Ohio Constitution. Furthermore, we defeated efforts to change Ohio's property tax structure that could have proved devasting to many villages and cities that operate through special voter-approved property tax levies.

Bringing in the Montrose Group to support OML's lobbying team expanded the relationships and contacts for Ohio's cities and villages during the 135th General Assembly and increased advocacy efforts on a range of important state policy matters. However, the lobbying work for the 135th Ohio General Assembly is not finished.

Findlay/Hancock County Transit Development Plan

The HHWP Community Action Commission is the public transportation provider for Hancock County through the federal 5311 Rural Public Transit program.

HATS transportation provides demand response public transportation for Hancock County and the City of Findlay for \$2 for trips within the City of Findlay.

The CAC received a \$70,000 grant through ODOT for a transit development study for Findlay and Hancock County to determine what service structure may be best suited to the county and city and how to fund service in the future. The plan will be driven by community surveys that will take into account what folks think changes need to be made for transportation to be more accessible for county residents.

More than 700 surveys have already been returned and additional public engagement is scheduled for the first week of March.

A majority of the 68,000 rides provided by HATS last year was workforce related. Last year, nearly 1,300 trips were denied because of a lack of availability. HATS is also the only

transportation provider in the city that can handle trips for those with accessibility issues as all of its vehicles are wheelchair accessible.

Of note is that Findlay is the largest Ohio city without any sort of fixed route transportation with a daily schedule with set bus stops.

Recommendations from the plan will be released in June.



Dear Council Members,

As a former member of the Community Outreach Team for the Strategic Planning Committee, a frontlines surveyor and a scribe at the roundtable meetings, I can confidentially say that a "Safe" and "Connected" city where not any of the top responses that the Strategic Plan has in place as goals, neither is an "Active Community". In addition to the goals mentioned, one of the seven goals listed in the plan is a "Caring Government", yet our local government does not lend an ear to the people who speak, as is agreed upon by thousands in our community. I also ask that you give the voice back to the people by removing the verbiage of "Declaring an Emergency" on all Ordinances & Resolutions.

In February of 2020 Councilman Jeff Wobser asked Service Director Paul Smeltzer the question, "What if we find out that 5g causes cancer in mice?". Then, at the December 2023 budget hearing Councilman Dennis Hellman asked the question about health concerns due to the 5g technology being installed. Mayor Muryn responded by saying she has no concerns as there has been extensive testing done. I emailed Muryn for the test results of this testing and she responded with "The City did not specifically conduct this testing. It is completed by manufacturers before they are able to put their product on the market." I have spoke with many residents in the City of Findlay that are concerned due to pace and increase of wireless technology being put in place by the City of Findlay. Studies have shown that SMART cities are harmful to our health. I'd like the City of Findlay to consider the health of our community. So, in addition to the above requests, I am requesting that the City of Findlay conduct a Radiation test across the city to assure the residents that there is no reason for Radiation concerns due to Metronet's 5g installation, SMART electric meters, SMART water meters and the powering up of the first of its kind Digital Substation.

Thank you for your thoughtful consideration in this highly important matter.



On November 16, 2023, the Findlay Police Department received notice of from the Hancock County Common Pleas Court of the seized \$6,036.43 from a suspect in a possession of drugs investigation. That case was dismissed in the court system, but the money seized during the investigation was ordered to be forfeited to the Findlay Police Department. The \$6,036.43 was taken out of the Police Department's property room and it was deposited with the Auditor's Office. I would like to use these funds to purchase equipment for one high efficiency drug disposal incinerator for evidence drugs, paraphernalia, and Active Pharmaceutical Ingredients (API's) for the Property Officer. We have been unable to meet EPA, State and Federal requirements at facilities around our area in Ohio and Michigan recently. This unit would save personnel from driving long distances to dispose of these types of items in the future and to do it locally, safely, and effectively in the future.

I respectfully request the amount of \$6,036.43 be appropriated to the Police Operating budget as follows:

I wanted to provide a quick update related to the City of Findlay local Opioid Settlement Funds. As of December 31, 2023, the City of Findlay had \$55,099.04 in our local Opioid Abatement Fund.

These dollars are to be utilized for a variety of purposes broadly related to Strategies for Community Recovery, Strategies for Statewide Innovation & Recovery, and Strategies for Sustainability. When looking at strategies for community recovery they include treatment, early intervention and crisis support, address the needs of criminal-justice involved persons, mother-centered treatment and support, recovery support, prevention, harm reduction, services for children, first responder support, and workforce.

In discussion with the Hancock County Board of Alcohol, Drug Addiction and Mental Health Services (ADAMHS), we recommend holding these dollars for the time being. This allows us to leverage other funds that are being deployed from our regional, state and federal partners.

We believe accumulating these dollars and holding them for a more impactful deployment will best serve our community. We will continue to evaluate this on a regular basis and come to you when ready to implement the funds. If anyone contacts you having ideas for use of these funds I would encourage you to have them reach out the ADAMHS Board or a specific local service provider and they can work with us to understand the feasibility.

Bids were received from three (3) potential contractors with the bid amounts ranging from \$643,743.00 to \$812,080.00. The lowest and best bid was received from Shelly Co., Inc.; of Findlay, Ohio. All of the received bids were under the Engineer's Estimate of \$833,524.75.

This project is included in the 2023 Capital Improvements Plan and will be using the grant funding that we receive from ODOT annually for being one of the largest 7 cities that are not part of an MPO. RE: Flood Mitigation Update & FEMA Hazard Mitigation Grant

Council President Harrington and Council Members,

We are submitting this letter jointly to provide an update on flood mitigation efforts and request support for an application to the Federal Emergency Management Association, FEMA. In 2023, FEMA released a notice of funding for the Flood Mitigation Assistance grant. The detailed Notice of Funding can be found at the following link, <u>Microsoft Word - Final Upload FY23 fma-nofo-fact-sheet DRAFT 9.22.23 clean SUBMIT highlights</u> (fema.gov). FEMA requires a member of the National Flood Insurance Program (NFIP) to be an applicant for the funding opportunity. The City of Findlay is a member of NFIP and we are requesting that the City of Findlay applies for the \$20 MM from FEMA to be utilized for the flood mitigation efforts detailed below.

In November 2009, the voters of Hancock County passed a .25% sales tax to be utilized for flood mitigation. The sales tax generated more than \$32,000,000 over a ten-year period. In addition, our community has received financial support from the Federal and State Governments. Local, State and Federal investments have supported the completion of the following: purchase of properties which had regular significant damage due to flooding, transportation corridor improvements to ensure safety service accessibility throughout the county and phase 1 benching. In addition to the projects completed there are three major projects in the design phase; widening of the Norfolk Southern Railroad Bridge from 150' to 300', the Eagle Creek Flood Basin and Phase 2 Benching east of the Norfolk Southern bridge. Following the completion of the benching projects, NS bridge expansion and the Eagle Creek Basin there will be a decrease of flood waters by 3ft in downtown Findlay during a 100-year storm event as well as the removal of hundreds of parcels and hundreds of acres of tillable farmland form the 100-year flood plain

These projects are critical to the long-term sustainability of Hancock County. Investing in our community to reduce flooding shows our citizens, as well as our businesses, and outside investors that Findlay is a safe, sustainable community to live, invest, and work.

Although we have secured a significant amount of funding to complete the Eagle Creek Basin, Phase II Benching and the NS Bridge there is still funding need to complete all of the projects. The table below details the 2019 construction cost estimates for the three remaining projects along with the current construction estimates.

To date there has been multiple sources of funding secured to complete the projects.

• NS Railroad Bridge – The Federal Government has awarded a \$7,100,000 RAISE grant to be utilized for the construction of the railroad bridge. After the RAISE grant was awarded the construction costs rose significantly and the grant is not indexed to





increased costs. The increased cost has created a shortage of funds to complete the project. We have requested that Norfolk Southern close 100% of the remaining gap to replace this 100-year-old bridge.

- Phase II Benching The County Commissioners have over \$6,000,000 remaining in the sales tax fund that was generated over a ten-year period from 2009-2019. The sales tax remaining is sufficient to cover the cost to complete Phase II Benching.
- Eagle Creek Storage Basin The State of Ohio has awarded \$60,000,000 to the Ohio Department of Natural Resources to complete the Eagle Creek Storage Basin
- In 2023 the City of Findlay approved \$2,500,000 in capital funding to be utilized for • flood mitigation.

To secure funding and complete construction of the three remaining projects we are requesting the City of Findlay to submit a Federal Emergency Management Agency, Flood Mitigation Assistance Grant Application.

For audit purposes a resolution of support is requested. We are requesting authorization from City Council to submit the application for the Federal Emergency Management, Hazard Mitigation Grant for a requested amount of \$20MM. The grant application is due February 22, 2024 and therefore we would request the legislation be adopted at your February 6th, 2024 meeting.

Submitting this grant does not bind the City of Findlay to any specific funding agreement for flood mitigation efforts moving forward and per the Ohio EMA the local match requirement is met through the funds which have already been spent on flood mitigation efforts and the State Funds towards the eagle creek basin.

This AGREEMENT is made and entered this <u>IOL</u> day of <u>January 2024</u> by and between the City of Findlay at 318 Dormey Plaza in Findlay, Ohio 45840, hereinafter referred to as "City", and the Findlay Hope House for the Homeless, Inc., 1800 North Blanchard Street, Suite #106, Findlay, Ohio 45840, hereinafter referred to as "Provider".

Whereas, the City of Findlay receives Community Development Block Grant (CDBG) funds from the Ohio Department of Development; and

Whereas, the federal government requires that local government recipients of CDBG funds must provide certain Fair Housing services; and

Whereas, the purpose of the Fair Housing Program is to inform the area residents of Fair Housing laws and to provide area residents with a system for redress of complaints of illegal discrimination in the obtainment of housing;

NOW THEREFORE, in consideration of the premises and mutual covenants and agreements contained herein, and other good and valuable consideration, the parties do hereby mutually covenant and agree as follows:

ARTICLE I: TERM

- 1.1 This Agreement shall be effective, retroactively, as of January 1, 202 and shall continue in effect for a primary term of one (1) year from the date of execution.
- 1.2 Upon expiration of the primary one (1) year term of this Agreement (January 1, 2024), this Agreement will be automatically renewed for an additional one (1) year term (January 1, 2025), unless either party hereto has submitted written notice of termination to the other at least thirty (30) days prior to the expiration date of the primary term.
- 1.3 Notwithstanding Sections 1.1 and 1.2, after this Agreement has been in effect for thirty (30) days, either party may, for good cause shown, terminate this Agreement by first submitting a written notice of termination to the other, which provides at least thirty (30) days notice of intent to terminate this Agreement.
- 1.4 Not withstanding this foregoing, this Agreement shall immediately terminate upon written notice to the Provider that the City CDBG contract with the Office of Housing and Community Partnerships, Ohio Department of Development has been terminated, or that the source of funds used by The City of Findlay to compensate Provider for services rendered as a result of this Agreement are no longer available.

ARTICLE II: SCOPE

All benefits and services rendered as a result of this contract shall apply to persons residing in The City of Findlay, OHIO.

ARTICLE III: FAIR HOUSING PROGRAM

- 3.1 Provider shall be responsible for providing fair housing services that meet or exceed the requirements of the State of Ohio.
- 3.2 At a minimum the Provider shall be responsible for the following:
 - (A) Have a published phone number for residents to call when they have fair housing questions or complaints;
 - (B) Designate an employee who is available Monday through Friday during regular business hours to receive calls;
 - (C) Establish a system to record the nature of calls, the action taken, and the result of the action taken;
 - (D) Establish a method of intake of complaints, forwarding complaints to the Ohio Civil Rights Commission, and a method of follow-up on complaints:
 - (E) Conduct training and provide fair housing educational materials to residents of the CDBG target area or special populations, and at least three (3) additional groups. (This documentation should include an agenda, attendance sheet, meeting notices or advertisements, and handouts);
 - (F) Develop and distribute fair housing information and materials to at least ten (10) area agencies, organizations or public events. (File should contain distribution list, date of distribution and copy of materials);
 - (G) Adopt an Affirmative Fair Housing Marketing Plan if the City implements a rental rehabilitation program funded with CDBG or HOME funds; and
 - (H) Conduct and update the analysis of impediments to fair housing in the community.

ARTICLE IV: COMPENSATION

- 4.1 Compensation will be remitted to the Provider in four (4) quarterly payments. For the purpose of this Agreement, the calendar year will be from January 1 to December 31 of the proceeding year.
- 4.2 Remittance of quarterly payments are to be made within ten (10) days of the beginning of each subsequent quarterly period for the preceding three month period. Provider shall submit an invoice for services rendered before payment is received.
- 4.3 If the Provider's expenses for services provided as a result of this Agreement should vary significantly from the payment schedule identified in Sections 4.1 and 4.2, the parties shall renegotiate a new payment schedule that more closely reflects actual costs.

ARTICLE V: REPORTING

5.1 Provider shall prepare and submit a written report to the City semiannually. This report will include a description of all of the services rendered as a result of this Agreement, and information on the status of any unresolved complaints at that time.

ARTICLE VI: ASSURANCES

- 6.1 Provider assures that all employees that are involved in the execution of services and activities identified in this Agreement shall be properly trained in Fair Housing laws and appropriate methods of complaint processing.
- 6.2 Provider agrees it shall indemnify and hold harmless the City, its directors, employees, and agents, from and against any and all claims of loss, damage, or liability arising from any act of commission or omission of Provider in connection with the performance of this Agreement.
- 6.3 Notwithstanding the foregoing, City shall be entitled, if it so elects, and at its own expense, to representation by attorneys of its own selection. City, at its option, shall be the sole judge of the acceptability of any compromise or settlement of any claims or actions for which City will be solely liable.
- 6.4 Provider assures that all services and activities performed in connection with this Agreement will be done so without regard to race, national origin, color, creed, sex, age, handicapping conditions, or political or religious affiliation.
- 6.5 This Agreement sets forth all understandings between parties respecting the subject matter of this transaction, and no modifications or amendments of this Agreement shall be binding on either party unless in writing and signed by all parties concerned.

The LPA agrees that all utility accommodations, relocations and reimbursements will comply with the current provisions of 23 CFR 65 and the ODOT Utilities Manual.

MEMORANDUM OF AGREEMENT BY AND BETWEEN THE CITY OF FINDLAY, OHIO AND THE MAUMEE WATERSHED CONSERVANCY DISTRICT

I. BACKGROUND:

Several recent and severe floods in the Blanchard River Watershed have encouraged cooperative floodplain management efforts of local communities impacted by the events. The Hancock County Commissioners and the Maumee Watershed Conservancy District (MWCD) engaged Stantec Consulting Services, LLC to review a study prepared by the U.S. Army Corps of Engineers (USACE) to make recommendations for projects that would reduce the risk of damages during flood events. One of the recommendations is the construction of a flood storage basin along Eagle Creek south of the City of Findlay. The completed basin will require the closure of Township Roads 49 and 77 in Eagle Township necessitating an alternative method of ingress and egress to the impacted area.

MWCD, a watershed district formed pursuant to Chapter 6101 of the Ohio Revised Code, has tasked Stantec, in cooperation with the Ohio Department of Transportation (ODOT), to prepare an alternative plan for ingress and egress.

II. MWCD DUTIES AND REQUIREMENTS:

A. <u>Alternative Ingress & Egress</u>. MWCD has partnered with ODOT to modify the US 68/SR 15 interchange to connect Township Road 80 into said interchange that will provide ingress and egress to the area impacted by the closure of Township Roads 49 and 77. ODOT has secured a PROTECT grant that will provide 80% of the construction cost for the interchange modification. ODOT will also fund all construction engineering and inspection.

B. <u>Representations</u>, <u>Warranties and Covenants</u>. MWCD is a subdivision of the State of Ohio with all the requisite power and authority to construct, or provide for the construction of, the Eagle Creek Flood Basin under the laws of the State. MWCD has the power to enter into and perform its obligations under this Agreement and have been duly authorized to execute and deliver this Agreement. MWCD is not the subject of nor has it initiated any claim or cause of action that would give rise to any liability which would in any way inhibit the ability of MWCD and to carry out the performance of the terms of this Agreement.

III. CITY OF FINDLAY DUTIES AND REQUIREMENTS:

A. <u>Local Funding</u>. The City of Findlay hereby agrees to provide the 20% local match for the construction of the interchange modifications in the amount of \$ <u>650,000</u>. Said amount shall be delivered to MWCD on or before February 16, 2024 to ensure timely submittal of said funds to ODOT.

IV. GENERAL TERMS

A. <u>Liability</u>. Each party to this Agreement shall be responsible for its own acts and omissions and those of its officers, employees and agents. In no event shall either party be liable to the other party for indirect, consequential, incidental, special, or punitive damages, or lost profits.

B Effective Date. This Agreement shall become effective by the date of last signature.

C. <u>Governing Law</u>. This Agreement shall be interpreted and construed in accordance with the laws of the State. In the event any disputes related to this Agreement are to be resolved in a Court of Law, said Court shall be located in the courts of Hancock County, State of Ohio.

D. <u>Entire Agreement</u>. This Agreement and its Appendices and Attachments contain the entire understanding between the parties and supersede any prior understandings, agreements, proposals, and all other communications between the parties relating to the subject matter of this Agreement, whether such shall be oral or written.

E. <u>Assignment</u>. Neither this Agreement nor any rights, duties or obligations described herein shall be assigned by any party hereto without the prior written consent of the other parties.

AGREEMENT

THIS AGREEMENT entered into as of this ______ day of <u>January 2024</u>, by and between the CITY OF FINDLAY, OHIO (hereinafter referred to as the City) and the Hancock Regional Planning Commission (hereinafter referred to as the HRPC). WITNESSETH:

WHEREAS, the City is eligible for funding under the Small Cities Community Development Block Grant Program (CDBG), and anticipates filing an application for such funding, and;

WHEREAS, in administration of such funds the City requires certain assistance, office space and other services in connection with such undertakings, and;

WHEREAS, the CDBG rules allow that administrative costs up to Thirty (30) percent of the grant amount may be charged to the program, and;

WHEREAS, the City wishes to use such administrative funds to pay the HRPC for assistance in CDBG administration:

NOW, THEREFORE, the parties hereto do mutually agree as follows:

I. Scope of Services

The HRPC shall perform and provide all the necessary services provided under this Agreement in connection with the City of Findlay Community Development Block Grant Program, (hereinafter referred to as "Program") and shall perform, provide, and carry out, in a satisfactory and proper manner, as determined by the City, the following:

- A. Provide Staff assistance to the City in implementing past Program activities, in executing the current Program, and in preparing applications for future programs.
- B. Provide sufficient office space for the operations of the City Community Development Department.
- C. Provide utility services, including electricity, natural gas, and water.
- D. Provide and make available secretarial, drafting and printing services.
- II. Time of Performance

The services of the HRPC are to commence as of January 1, 2024 and include all CDBG applications for the 2024 and 2025 calendar years and shall continue until the Programs have been completed.

III. <u>Compensation</u>

Compensation for the specified services in Section I will be based upon the following schedule of fees for HRPC Staff members' time:

Director	\$54.78 per hour
Grant Administrator	\$48.27 per hour
Development Services Admin	\$45.98 per hour
Comm. Serv. Planner	\$44.51 per hour

IV. Method of Payment

Payment for staff services shall be made on a quarterly basis. On or about the first day of each quarter the City shall transmit to HRPC the agreed upon amount for the current fiscal year.

V. Designation of Development Coordinator

During the term of this Agreement, the Director of the Hancock Regional Planning Commission shall be designated as the Development Coordinator of the City of Findlay Community Development Department. As such, the Director shall assume the duties and responsibilities of the Coordinator, and shall be empowered to sign and/or execute such forms and documents as are necessary to carry out the activities of the Community Development Department.

VI. Equal Opportunity Employment

- (1) The HRPC will not discriminate against any employee or applicant for employment because of race, color, religion, sex or national origin. The HRPC will take affirmative action to ensure that applicants are employed and the employees are treated during employment without regard to their race, color, religion, sex or national origin. Such action shall include but not be limited to the following: employment, upgrading, demotion or transfer; recruitment of recruitment advertising, layoff or termination, rates of pay or other forms of compensation, and selection for training, including apprenticeship. The HRPC agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the contracting officer setting forth the provisions of this nondiscrimination clause.
- (2) The HRPC will, in all solicitations or advertisements for employees placed by or on behalf of the HRPC, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex or national origin.
- (3) The HRPC will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice to be provided by the agency contracting officer, advising the labor union or workers' representative of the contractor's commitments under Section 202 of Executive Order No. 11246 of September 24, 1965, and shall post copies of the notice in conspicuous places available to employees and applicant for employment.
- (4) The HRPC will comply with all provisions of Executive Order No. 11246 of September 24, 1965, and of the rules, regulations and relevant orders of the Secretary of Labor.
- (5) The HRPC will furnish all information and reports required by Executive Order No. 11246 of September 24, 1965 and by the rules, regulations and orders of the Secretary of Labor or pursuant thereto and will permit access to his books, records and accounts by the contracting agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations and orders.
- (6) In the event of the HRPC's noncompliance with the nondiscrimination clauses of this contract or with any of such rules, regulations or orders, this contract may be canceled, terminated or suspended in whole or in part and the contractor may be declared ineligible for further Government contracts in accordance with procedures authorized in Executive Order No. 11246 of September 24, 1965 or by rule, regulations or order of the Secretary of Labor or as otherwise provided by law.

(7) The HRPC will include the provisions of Paragraphs (1) through (7) in every subcontract or purchase order unless exempted by rules, regulations or orders of the Secretary of Labor issued pursuant to Section 204 of Executive Order No. 11246 of September 24, 1965, so that such provisions will be binding upon each subcontract or vendor. The HRPC will take such action with respect to any subcontract or purchase order as the County may direct as a means of enforcing such provisions including sanctions for noncompliance: Provided, however that in the event the HRPC becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the County, the HRPC may request the United States to enter into such litigation to protect the interest of the United States.
