There is a charge of \$20.00 per sample for the bacteria testing of all new water lines. Requests shall be made at least 24 hours in advance. Samples are set up and analyzed on Mondays, Tuesdays, and Wednesdays between 8:00 am and 4:00 pm, but must be received by 12:00 noon on these days.

Additional bacteria testing may be done on Thursday, Friday, Saturday or Sunday in special circumstances, with the permission of the Plant Superintendent at a cost of \$110.00 plus \$20.00 per sample.

#### 17. Requested meter changeout

Actual cost of labor, materials and equipment plus fifteen (15) percent. An estimate of cost can be obtained by contacting the Water Distribution Department.
