ANY PERSON CHARGED WITH A THIRD OFFENSE OR MORE WITHIN A YEAR OR VIOLATION MARKED COURT MUST APPEAR ON THEIR ASSIGNED COURT DATE. ALL TRAFFIC OFFENSES LISTED BELOW ALONG WITH THEIR CORRESPONDING FINE AND COST AMOUNTS (HERETOFORE KNOWN AS THE "WAIVER SCHEDULE") MAY BE DISPOSED OF BY THE FINDLAY MUNICIPAL COURT TRAFFIC VIOLATIONS BUREAU:

1-1st offense exception - Defendant may waive fine and points by attending distracted driving safety course established by the Ohio Director of Public Safety.

2 - Distracted Driving - RC 4511.991 If an offender violates certain sections listed in the ORC/CO and is noted on the face of the traffic citation the offender shall pay an additional fine of \$100.00. If the offender completes the one-hour course regarding distracted driving and submits written evidence of completion of the distracted driver course the Court will waive the \$100.00 enhancement.
