## RESOLUTION NO. 043-2014

A RESOLUTION COMMENDING LARRY POCOCK FOR THE EXCELLENCE OF HIS SERVICES TO THE CITY OF FINDLAY, OHIO.

WHEREAS, Larry Pocock who served the City of Findlay, Ohio for twenty-three (23) years as a dedicated loyal employee, retired effective November 30, 2014. Larry was appointed to the City of Findlay Water Pollution Control Center as an Assistant Operator on October 6, 1991. He was promoted to Assistant Operator Class II at the Wastewater Treatment Plant on January 2, 1994, then to Assistant Operator Class III. He transferred to Water Distribution as a Waterline Maintenance Worker I on June 29, 1997, then was promoted to Waterline Maintenance Worker II on June 15, 2003, and finally a Waterline Maintenance Tech Assistant with Class I License on April 15, 2013, a position he held until his retirement, and;

WHEREAS, Larry completed his Class I Operator Wastewater Works training through the Ohio Environmental Protection Agency on December 31, 1992, his Class II Operator Wastewater Works training on December 15, 1993, his Class III Operator Wastewater Works training on June 30, 1994, and his Hazard Communication training on August 30, 1994. He obtained his Class 1 Water Distribution License in May of 2008, and;

WHEREAS, Larry received a letter of commendation from the then Water Distribution Superintendent on May 13, 1999 for his assistance with the repair of a twenty inch (20") water main. On February 20, 2013, a resident of Westmoor Road contacted the City complimenting Larry on his quick response and hard work on a waterline leak during inclement weather.

WHEREAS, during the winter of 2004, Larry spent over six (6) months updating maps for the Water Distribution Department and continues to update them as needed, and;

WHEREAS, in 2007, Larry assisted in rebuilding the Reservoir 1 and Reservoir 2 ramps, and;

WHEREAS, Larry was also recognized during the August 21, 2007 City Council meeting by Resolution No. 034-2007 for his participation during and after the August 21, 2007 flash flood, and;

WHEREAS, Larry received recognition during the August 21, 2012 City Council meeting by Resolution No. 039-2012 for the actions he took during and after a severe wind storm that occurred on June 29, 2012, and:

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Findlay, State of Ohio:

SECTION 1: That the said Larry Pocock be and he is hereby commended for his loyal services to his City, and that this Council extends their best wishes to him upon his retirement from the City of Findlay, Ohio.
