## MINUTES OF THE FINDLAY CIVIL SERVICE COMMISSION September 2, 2015

The Civil Service Commission met on Wednesday, September 2, 2015, in conference room 1 located on the third floor of the Municipal Building. Those present at the meeting were Civil Service Commission members – Tom Kemp, Barb Larick, and Chuck Clapper; Deidre Ramthun, Clerk/Secretary to the Commission; and Don Essex, Director of Human Resources and Performance Excellence, City of Findlay.

- A. A motion was made by Barb Larick that the minutes from the August 5, 2015 meeting be adopted as circulated. Said motion was seconded by Chuck Clapper, unanimously approved, motion carried, and minutes adopted.
- B. Deidre Ramthun reported the following:
  - 1. A request was received on August 5, 2015 from Chief Horne to administer a probationary police officer test to Noah Burkholder. Officer Burkholder passed the test on August 6, 2015.
  - 2. A request was received on September 1, 2015 from Chief Horne to administer a probationary police officer test to Nicholas Huber. The test has been scheduled for September 10, 2015.
  - 3. A letter was received on August 27, 2015 from Chief Horne extending Office Christopher Brickner's probationary status for six months. This item was tabled until the next meeting. The Commission requested that Don Essex ask Chief Horne to review the Collective Bargaining Agreement regarding the extension of probation and provide a copy of the letter that was provided to Officer Brickner.
  - 4. Brenda Galvin was appointed to the vacant records clerk position in the Police Department due to the retirement of Anita Ewing in July 2015. Brenda's hire date is contingent upon the completion and passing of the pre-employment background investigation, psychological evaluation, and physical.
  - 5. Interviews were held on August 14, 2015 for the Fleet Manager position in the Police Department. Chris McDougal was hired pending completion and passing of the background investigation. This item was tabled for discussion at the next meeting.
  - 6. A request was received on August 6, 2015 from Chief Eberle to schedule a probationary firefighter test for Richard Gonzalez. Firefighter Gonzalez passed the test on August 20, 2015.

- 7. One hundred four applications have been filed to date for the entry level firefighter test. The application filing deadline is 4:30 p.m. on September 3, 2015.
- 8. The following Findlay City School District employees have been reclassified:
  - a. Rhonda Waldman from library aide to 214 secretary at Lincoln Elementary School effective August 6, 2015.
  - b. Stephen Crawford from substitute custodian to custodian at large effective August 17, 2015.
- C. Discussion was held on the following:
  - 1. The felony conviction question on the Employment Application was deferred to the next meeting so the City Law Director can be in attendance for discussion.
  - 2. The Year-to Date Budget Report was reviewed.
