



# ORDINANCE NO. 2018-023

AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR OF THE CITY OF FINDLAY, OHIO TO ACCEPT GRANT FUNDING FROM AND EXECUTE ANY AND ALL GRANT AGREEMENTS OF THE DEVELOPMENT SERVICES AGENCY ROADWORK DEVELOPMENT (629) GRANT PROGRAM FOR THE PURPOSE OF INTERSECTION UPGRADES WITHIN THE CITY OF FINDLAY, DECLARING AN EMERGENCY.

WHEREAS, the City of Findlay was notified that the Development Services Agency Roadwork Development (629) Grant Program has approved funding for intersection upgrades and other public improvements for the development of public right of way to service an industrial development site within the City of Findlay.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Findlay, State of Ohio:
