Subject: New Ohio Law will be a Problem in Findlay

Paul,

I know the City does not promote that Golf Carts are legal to drive on City streets, however, starting January 1, 2017, a new Ohio traffic law will allow golf carts on <u>all Ohio</u> roadways with a speed limit of 35 mph or less.

The old law only let them on 25 mph roads or less.

Think of golf carts traveling on Tiffin Ave / Trenton Ave / Main St /N & S Blanchard St/ CR 236, any road with a Speed limit of 35 mph. And with all of the Semi traffic, not a good idea in my opinion.

Any City ordinance passed before the State Law goes into effect will trump it.

I think the City should enact an ordinance restricting golf carts to only traveling on 25 mph roads or less, or any other restrictions the Law Director would deem appropriate.

This new law will treat them just like any other vehicle. The golf carts will have to go through an inspection to get a title so they can get license plates. They will need a windshield, headlights, tail lights, turn signals and a horn, etc.

Ohio Revised Code 4501.01 (Effective 1/1/2017) Motor Vehicles definitions.

I just wanted to pass this along for your consideration.

The most likely placement of a sign of this type would be on the traffic light post at the South West corner of South Main and Lima (South bound traffic lanes); and the traffic light post at the South East corner of South Main Street and Sixth Street (Northbound traffic lane). These are the general "boundaries" of our neighborhood.

We do not have any funds for this project but have been advised that we may be able to secure some grant monies. There is a person in the SMNA willing to write a grant if we have the "okay" to proceed from the appropriate city department.

Dear Mr. Schmelzer:

The University of Findlay is requesting that a No Parking Zone be established for the 300 block of College Street. Currently the University owns all of the properties within the block with the exception of the property at 331 College Street. This property is residential and has off street parking on the property.

Based on our observations the primary people that are parking in the street appear to be University students. The University has ample off street parking within short distances from the buildings on College Street for these students to utilize. In order to provide unimpeded access for emergency vehicles and street maintenance vehicles and to improve safety on these blocks we respectfully ask that the Traffic Commission consider our request to eliminate street parking along this section of street. 
