

Ms. Launder and Traffic Commission,

I would like to request that a subject for discussion be added to the Traffic Commission 2:30 pm meeting on the 3rd Monday of September (18th).

I was referred to you by Brian Thomas and I have been in touch with Ron Monday.

My request is to discuss better signage in the 200-300 block of Center Street for eastbound traffic (particularly semi trucks) to inform them that

SR 12 and SR 224 are to bear left after the RR tracks at Factory Street and not to continue straight on Center Street into the 400 block. I have lived on

Center Street for approximately 27.5 years and have noticed more semi trucks coming over the tracks into the 400 block of Center Street, stop

before reaching North Blanchard Street only to then go to N. Blanchard and turn left back towards Tiffin Avenue. I was concerned about this

for some time but this actually became more important when plasma medication for my wife was left on the front porch of 432 Tiffin Ave by UPS

instead of being delivered to our address of 423 Center Street. More detailed signage prior to the RR tracks should possibly eliminate unwanted

commercial traffic on a residential street and also aid delivery drivers (many who may not be from the Findlay area) as to the State Route Designation

and Street names at this unusual intersection.

I would also like to be notified prior to this meeting so that I may attend to answer any questions or make a statement.
