ORAL COMMUNICATIONS:

Charles Williams - Why would you deny a citizens their 1st amendment right to speak in City Council?

Mr. Williams watched City Council two (2) weeks ago from his home and he about came out of his chair. He has a lot of friends that he met in Vietnam. One of his friends was brought home in a casket after fighting for everyone in this room. What Mr. Williams heard from that City Council meeting blew him away. He asked why anyone would deny a citizen their first amendment right to speak at City Council. He asked Council President Monday (serving as Acting Mayor tonight) if he would like to answer that question. President Pro-Tem Russel replied that Mr. Williams can make a statement to Council, but it is not his purvey to question Councilmembers during his time to speak. Mr. Williams asked if he can do so outside of the Council Chambers. President Pro-Tem Russel replied that outside he can do pretty much whatever he wants. Mr. Williams replied by stating "we know how that works now don't we". Mr. Williams continued "with that said, that just shows how many cowards there are in City Council", but clarified by stating that he is not talking about everyone. It is just disgusting. Councilman Harrington sits there with a smirk on his face. Councilman Harrington replied that he is not a coward. Mr. Williams replied that he is. Councilman Harrington replied that he takes offense to that, Mr. Williams replied that he is a coward. Councilman Harrington replied that he is not. Mr. Williams noted that there were one hundred thirty (130) people here a month ago which says this is a great country. If someone has a problem, right or wrong, they deal with it. There is a family on 830 East Sandusky Street who started a petition to get on the ballot. Mr. Williams sat on Main Street and did his thing with his red truck. There were people yelling and screaming, but only had two (2) negative people, one (1) being Council President Monday who was laughing and taking a picture who thought it was kind of funny, but when you talk to him, he does not think it is all that funny and he will not talk to you because he is a coward. People line up in droves at 830 East Sandusky Street to sign the petition which shows you how great this country is. His father-in-law fought in Japan and his brother-in-law was shot down in Germany as a prisoner. They fought for this stuff, but yet a citizen comes here and is denied to speak. He asked if that person had said something wrong or if what he had said was negative or threatening. He would like to know that answer, but being that he will not be getting that answer, he told Council to have a good day.

The third quarter Key Performance Indicators or "KPIs" have been compiled. These are the performance measurements the City monitors for each department on a continuous basis. A few highlights of the third quarter are:

City Auditor Staschiak - RLF Administration

The Hancock Regional Planning Commission has submitted an invoice for their expenses/staff time for RLF administration for July 2018 through September 2018. Service Director/Acting City Engineer Thomas - Recreation Maintenance Storage Structure project number 31983700

As part of the 2017 Capital Improvement Plan, Recreation Maintenance was planning to construct a storage building, but would like to change the scope from the construction of a storage building to the purchase of two (2) smaller prebuilt storage buildings. This change will allow them to end up with more square footage while reducing the cost of the project. Funds for the project have already been appropriated, therefore, no legislation is needed. Service Director/Acting City Engineer Thomas - Marathon Diamonds

Recreation Maintenance had it in their budget for a contractor do some regrading on two (2) of the fields at the Marathon Diamonds this year with the remaining fields being regraded in the future. During the year, this information was communicated with Findlay Girls Fastpitch Softball Club (FGFSC) and Findlay Youth Baseball who had asked if the City would consider regrading all four (4) fields if they donated funds to help offset the additional cost. Checks from both organizations have been received and those funds need to be appropriated back to the Recreation Maintenance budget. Legislation to appropriate funds is requested. REASON: The CR 236 debt payments were appropriated and paid initially by Capital Improvements money for 2018. There was a balance in County Permissive Fund of seven thousand one hundred fifty-four dollars and eighty-one cents (\$7,154.81) and were able to draw one hundred twenty-five thousand six hundred seventy-three dollars and fifty-three cents (\$125,673.53) from the County Permissive Fund to pay the 2018 debt payments as an allowable use of the money. These appropriations allow the County Permissive money to be used for the debt and reimburse Capital Improvements.

REASON: In 2004, the City made the final debt payment on the 2003 Sidewalk Construction Program, however, there were several assessment deferments granted at that time in addition to several property owners that had chosen not to pay the assessment. Also, the City made the final debt payment on the 2010 Sidewalk Repair and New Construction projects in 2014. About half (1/2) of the assessed property owners chose not to pay this assessment, therefore, the City had to cover the costs of the debt payments with General Fund money and was to be reimbursed when the property owners finally made payment. The one dollar eighteen cents (\$1.18) represents the amount of money that was received in 2018 for some of these properties. This money should now be returned to the General Fund. There are still a few outstanding assessments to be collected from these projects.

The one thousand nine hundred sixty-five dollars and fifty-six cents (\$1,965.56) represents the amount of money currently showing in the Special Assessments Pavements Fund that is from one of the deferrals. There is still one property from this special assessment project that is remaining on deferred status.

Councilman Harrington pointed out that this is money that has been donated.

Councilman Russel asked who the donation(s) were received from. Service Director/Acting City Engineer Thomas replied the Girls Fastpitch Softball Club and Findlay Youth Baseball. Councilman Russel pointed out that each organization donated five thousand four hundred fifty dollars (\$5,450.00).

Councilwoman Frische asked what will be done with the donations. Councilman Russel replied the diamonds at the CUBE facility will be regraded. Initially, the City was going to do two (2), but with the donations, the other diamonds will also be done at the same time.

UNFINISHED BUSINESS: OLD BUSINESS

Councilwoman Frische asked if there will be some clarification information out to the general public on the water quality. There are still some complaints out in different areas. She received a phone call today from a resident in the West Park area. When residents have to do a boil because of a dig up or repair, there needs to be communication about it with the public. She asked if there is going to be a report or something for the public to have a better understanding of what is going on. Service Director/Acting City Engineer Thomas replied that he has been putting out the updates. They have conducted testing throughout the whole ordeal. The City has tested for everything that could possibly be tested for and have had no issues with that. Individuals on social media have asked to see the report. There have been discussions about putting it on the website and are trying to determine how to do that to show what the limits are and what the results are. He talked with the Water Treatment Plant Supervisor to put something on the website to show that there is no microcystin nor any other harmful toxins in the water. The process happens every year. Unfortunately, it was bad this year. The results change from year to year. It is not as simple as turning the dial on it because of what time of year it is. Every year it is different. The Water Department is going out on a complaint basis and flushing out hydrants in the area. Most of the complaints they have been receiving are on the dead-end lines where there is not as much flow and the water sits. If a resident is still having water issues, they just need to let the Water Department know and will go out and flush the hydrants in the area to take care of it. Councilwoman Frische pointed out that the EPA did some testing. She asked if something is broken if that needs to be discussed by the Water and Sewer Committee. She asked if there needs to be better check valves or back up if there isn't one. Service Director/Acting City Engineer Thomas replied that the recommendation from the EPA is to have a second carbon pump. The purchase order for that has already been approved and the Water Treatment Plant Supervisor is in the process of purchasing it. Other than that, there weren't any other recommendations from them that we do anything differently. They did not say that we are doing anything wrong and are doing everything that we are supposed to be doing and are not over any limits.

Councilman Harrington asked if the City water is fine except for the smell and taste. Service Director/Acting City Engineer Thomas replied that is correct.

City Auditor Staschiak reminded Council that the City collects income tax from Mt. Cory, Vanlue, and Arlington. A few weeks ago, the City Auditor's Office received a copy of a collection services agreement to collect on behalf of the village of Carey, but that he has not received any legislation that Council has passed authorizing them to do so. In 2016, Council passed legislation to collect for Mt. Cory, in 2014 for Vanlue, and in 2002 for Arlington. Legislation is not needed to collect it for Carey, but for the City Auditor's Office to pay them. He does not have the authority to pay them anything unless Council authorizes it. He requested legislation to do so. Councilwoman Frische asked if Arlington will need renewed since the legislation is back to 2002. City Auditor Staschiak replied renewal legislation is not needed the way the 2002 one is written.

Councilwoman Frische asked if the City purchased the former gas station on Tiffin Avenue across from Tiffin Avenue. Law Director Rasmussen replied no the City did not purchase it. Councilwoman Frische noted that she has received some phone calls on the lot being vacant with items for sale placed on it. Councilwoman Frische asked who owns it. Law Director Rasmussen replied the owner. Councilwoman Frische added that she was under the impression that the City was looking into purchasing it. Law Director Rasmussen replied the owner left and it has not transferred. The City scraped the site to make it more slightly in anticipation of the sign company looking at it. He has seen campers and other vehicles for sale on it. He thinks they think it is City property or their property and can just park on it. Nothing has happened with that site since.

NEW BUSINESS

City Auditor Staschiak informed Council that they will see a request to fund the Self-Insurance Fund to a million dollars (\$1,000,000) which is used for the City's liability on environmental claims and to pay deductibles when there are claims against it. The Severance Payout Reserve Fund is not looked at very often. It is the fund where money is put aside for pending retirements that are expected in the next year or so and for money for those that are eligible to retire but have not said one way or the other what they are doing. That fund will be down to about three hundred thousand dollars to three hundred fifty thousand dollars (\$300,000-\$350,000) at the end of this year. He does not believe it will be enough because there is well in excess of one and a half million dollars (\$1,500,000) worth of possible payouts based on those who are eligible to retire in the next year or so. He requested this be discussed in an Appropriations Committee meeting prior to the budget hearings so that an appropriate amount of money would be available while the City is in a strong cash position to set aside so that the individual payouts do not drain the cash in the General Fund unexpectedly. The last one that was appropriated was one hundred fifty thousand dollars (\$150,000). Some of the payouts are relatively large such as former Fire Chief Lonyo's payout. Councilwoman Frische asked what is currently in that fund. City Auditor Staschiak replied three hundred seventy-five thousand dollars (\$375,000) and will end between three hundred to three hundred fifty thousand dollars (\$300,000-\$350,000). There are always employees who do not inform his office ahead of time. No matter what is planned for, it is always a question of how much to plan for. He requested that discussion take place.

City Auditor Staschiak pointed out that he spoke with Safety Director Schmelzer and Service Director Thomas who have given the okay to start drafting the salary ordinance so that it can be in place January 1, 2019. This is a different ordinance that is in the works for elected officials which will hopefully be in place before the end of the year and well before the next primary filling date. He strongly encouraged Council to have a member or two be involved in the process. It is vital that Council be involved in making sure that the salary ordinance states what they want it to say so that those retiring are funded and to address concerns. He also thinks Council is due for a review of exempt and non-exempt employees that qualify for overtime, who is salaried, and who is exempt from overtime so employees can come back and file if they are inappropriately classified.

Councilman Hellmann asked if a policy could be adopted making it mandatory that employees give the City a certain amount of notice when they plan to retire and expect to be paid. City Auditor Staschiak replied it currently is thirty (30) days notice to qualify. Employees do give notice but sometimes do not decide they are going to retire until something happens in the year. It could be a life change or they may just not want anyone to know because of the concern that it could affect how they are treated on the job. The policy has served pretty well, but is Council's purvey if they want it changed to require employees to give more notice prior to being eligible for a payout. He will refer this to the Law Director as he did not feel all the money that was paid out to the former Fire Chief should have been, so it is vey complex. Councilman Hellmann asked if the Law Director could provide some information at the next meeting. Law Director Rasmussen replied that Council did not adopt what he had suggested after the former Fire Chief payout situation where he made a suggestion that Council could change it. Councilwoman Frische asked what the Law Director proposed to be changed at that time. Law Director Rasmussen replied to change the language of retirement.
