### Mayor Lydia Mihalik - appointment to HRPC Board

Mayor Mihalik is asking for a confirmation of Dennis Bash to the Hancock Regional Planning Commission Board. Mr. Bash has expressed a desire to serve the community as a member of the Hancock Regional Planning Commission Board. He will be filling the unexpired term of Dan Clinger who has been appointed to the City Planning Commission. This appointment will be effective through December 31, 2014. This appointment requires the confirmation of Findlay City Council.

### Service-Safety Director Paul Schmelzer - appropriation for MARCS

The MARCS system that the City uses for radio communication requires an upgrade. The capital plan from last year showed the seven hundred thousand dollar (\$700,000.00) expenditure under the Police capital budget as the P-25 MARCS conversion. If the City is to continue utilizing the MARCS system for City communication and statewide emergency response connectivity, this hardware upgrade is a necessity. If the system is contracted before December 6, 2013, the City can receive discounts from MARCS and Motorola, as well as obtain some credit for the consoles the City already owns. An Appropriations Committee meeting to follow the Committee of the Whole meeting on November 26, 2013 is requested. If Council approves the Service-Safety Director enter into a purchase contract, he will continue negotiations with Motorola and MARCS. The latest proposal for the consoles is three hundred ninety-seven thousand six hundred sixty-one dollars (\$397,661.00). If the agreement is executed yet this year, savings will be approximately twenty-seven thousand nine hundred dollars (\$27,900.00).

The five year capital plan explains who this purchase will positively impact the overall plan. This purchase was planned and documented as a proposed purchase in 2014. He is requesting to move the purchase forward into 2013 at a lower cost in order to save money. This is similar to the process that was used when additional funding was put into the paying plan for 2013 in order to take advantage of low unit prices.

An appropriation of four hundred thousand dollars (\$400,000.00) to the P-25 MARCS conversion is requested.

The Airport has reported the need to purchase more jet fuel. An appropriation of ninety thousand dollars (\$90,000,00) is requested. This purchase would cover fuel purchases for the remainder of this year and into the beginning of 2014. Ordinance No. 2013-081 was created.



Call to Order: In the absence of the Mayor, Mr. Cline called the meeting to order at 7:35 A.M.

Minutes: Mr. Cline called for a motion to approve the minutes of the September 18, 2013 Board Meeting. Mrs. Work moved to accept the minutes of the September 18, 2013 Board of Health meeting as circulated. Seconded by Mr. Alge. Motion carried 5-0. Filed

### **HEALTH COMMISSIONER REPORT**

- 1. There are four Tuesdays left for the *Get Your Tail on the Trail Walking Program*. The program has had from 12 to 30+ participants each week with an average of 20 to 25 each time. There will be prizes awarded at the end of the program along with encouragement to continue walking.
- 2. Dr. Mills will be meeting with hospital representatives regarding working together on the Million Hearts Campaign. The goal of this national campaign is to prevent one million heart attacks and/or strokes by the year 2017. The group is hoping to work on a media and education campaign aimed at smoking cessation, blood pressure and cholesterol control and the use of aspirin. He will also be meeting with Dr. Meijer and Dr. Gerschutz and setting up a planning committee.
- 3. Dr. Mills and Mrs. Wilhelm were among a small contingent invited to Bluffton to attend a meeting regarding Bluffton's progress on bike and walking pathways. Mrs. Wilhelm attended and reported that through a large community transformation grant Allen County has hired a consultant from Michigan to assess walkability and bikeability in Bluffton. The consultant was present at the meeting and provided an overview of the project and the benefits of promoting an active lifestyle in the community. A power point presentation identified many types of improvements that can be made in a community to encourage safe pedestrian and bike traffic. Bluffton officials would like to eventually see a bike path from Bluffton to Findlay.

4. Blanchard Valley Hospital is part of a group of 138 Ohio hospitals committing to using CliniSync. CliniSync allows physicians and hospitals across the state to exchange health information electronically. This will allow different health systems and providers to share information about a patient's care and improve the process of communication allowing for higher quality, lower cost, and more patient centered care.

### **DEPUTY HEALTH COMMISSIONER REPORT**

1. Mrs. Wilhelm shared with the board that both she and health educator Jenn Rathburn will be traveling to Salt Fork State Park next Thursday to receive a Healthy Communities Award for Findlay. Award recipients are selected by the Ohio Department of Health's Bureau of Healthy Ohio and is based on programs and policies that have been implemented to improve the health of the community. The recently completed Community Health Improvement Plan, Underage smoking regulation and enforcement, school recess activity program, walking program and a newly implemented school nutrition program all helped Findlay achieve Gold status.

While at the conference Mrs. Wilhelm and Mrs. Rathburn will also participate in a panel discussion for Gold level award winners and will also partner with Barb Brahm, former Hancock County O.S.U. Extension Educator to provide an afternoon session on building community partnerships.

2. Copies of the proposed 2014 health department budget were presented to the board. Mrs. Wilhelm highlighted changes to the expenses and revenues from 2013 to 2014. In addition she reviewed the increase in revenue due to the new Help Me Grow Home Visiting Program, the Medicaid Administrative Claiming Program and BCMH. The Health Department has been able to add an average revenue of over \$6,000 per month with these programs using existing personnel. There is room for growth in these programs as we are not reaching all eligible clients but at this time do not have the staff to actively promote these programs. In addition to the added revenue we have seen with Help Me Grow, other benefits to the community in the first 6 months of the program include saving 10 visits to the emergency room, providing 2 families with Wrap services, referring 2 parents to additional parenting classes, seeing increased compliance with well-baby visits and immunizations, and conducting prenatal visits with two high risk moms who subsequently gave birth to healthy babies. Mrs. Wilhelm requested the board consider adding a new nursing position to the budget to expand these programs. Projected cost for a new nurse would be \$68,000 per year with benefits while projected revenue this position would generate would be \$74,000.

Mr. Niese also added that he did not include the cost of additional mosquito chemical which would likely need to be purchases this year if the health department is to continue its mosquito spraying program. Mr. Niese also noted that the mosquito sprayer is checked and

calibrated each year but has already outlived its projected lifespan and will also need to be replaced. Safety Service Director Paul Schmelzer felt this service should continue and advised that the chemical cost should be added to the budget and a new sprayer could be placed in the capital improvement plan. Mr. Niese will gather cost projections for a new mosquito sprayer and chemical.

After some additional discussion Mr. Alge moved to approve the 2014 budget with the addition of a nurse position and mosquito chemical. A mosquito sprayer will be requested in the Capital Improvement Plan Seconded by Dr. McEvoy. Motion carried 5-0. Filed.

Dr. McEvoy asked the Safety Service Director if there was any additional information regarding merger. Mr. Smeltzer responded that talks are ongoing. He complimented the health department on the work they have done with the budget and the ability to actually add services.

#### **NURSING REPORT**

1. There was nothing new to report in the nursing division, however Mrs. Bern noted that Christine Carrigan, the environmental health clerk, has been doing a great job helping the nursing clerk with some of her duties such as filing and data input. This allows the nursing clerk to spend more time keeping up with insurance billing. Mrs. Wilhelm concurred that Mrs. Carrigan has being doing a good job getting up to speed and helping out with a variety of duties in the office.

### **ENVIRONMENTAL HEALTH REPORT**

- 1. The matter of budgeting for mosquito spraying was handled under the deputy's report.
- 2. Mrs. Work moved to approve the Plans and Specifications for Jimmy John's, 1805
  Tiffin Ave. Seconded by Mr. Alge. Motion carried 5-0. Filed.

### **EMERGENCY RESPONSE / EPI REPORT**

1. Mr. Masters updated the Board on the opportunity for the Medical Reserve Corps unit to apply for the Capacity Building and Challenge Awards, which would provide additional funding to further preparedness and public health in the community. The Capacity Building Award is the amount to support the MRC in standard operations and purchasing of certain supplies for the volunteers, along with preparedness trainings for volunteers. The Challenge Award is similar to the Competitive Award that was offered in 2012-13. The

Health Department received the Competitive Award of \$7,000 last year and it was utilized by our health educator for the "Healthy Kids Day" held at the University of Findlay last spring. This event included different screenings and assessments to determine those children at risk for developing chronic disease due to certain diagnostic levels (i.e., high blood pressure, high cholesterol, BMI), and then allowed them to meet with a physician to review the results and set a plan of action. The Challenge Award for 2013-14 will be for \$20,000 and if awarded would be used to further the "Healthy Kids Day" event by adding an additional event at the beginning of the school year and focusing on chronic disease prevention. Dr. McEvoy commented that he thought that the "Healthy Kids Day" was a success. His one suggestion was that he wanted to meet with the health screeners prior to the event so as to standardize the measurements taken for more accurate reporting of the results. Mr. Masters responded that he will forward that on to the health educator for implementation.

Mr. Masters informed the Board that he had visited 6 medical provider offices in Findlay on October 3<sup>rd</sup> to deliver literature packets on the Medical Reserve Corps for recruiting purposes. He explained that he will be following up in several weeks to inquire about interested individuals for volunteers. Mr. Masters also stated that there will be a ½ page color advertisement in The Courier the weekend of October 19<sup>th</sup> as well as 2 billboards placed in the city to promote the MRC and recruit medical professionals to become members. Dr. Mills asked if the orientation training can be offered at the Continuing Medical Education (CME) in Blanchard Valley Hospital. Mr. Masters responded that the "MRC 101" had been offered in January, 2012 at Blanchard Valley Hospital and that several medical professionals had signed up. Dr. McEvoy suggested that an opportune time to introduce the MRC program would be at one of the physicians' quarterly meetings held at Blanchard Valley Hospital. Mr. Masters stated that he would look into that possibility.

#### PLUMBING REPORT

1. The plumbing inspector continues to be out on sick leave. Inspections are being completed once per week through a contract with Ottawa County.

### **OLD/UNFINISHED BUSINESS**

Mrs. Wilhelm informed the board that the health department was not funded for Project DAWN. Only four projects were funded across the state with three being in large metropolitan areas and the fourth being in Ross County which is located in southern Ohio, a county harder hit by the prescription drug abuse problem. Along these lines, Mr. Niese reminded the board that the next prescription drug collection will be held on Saturday October 26 from 9 am until noon here at the Municipal Building. The health department has assisted with the collections since their inception.

Mrs. Wilhelm also shared that Dr. Arnette from the Hancock County Health Department would be meeting with her today to discuss the matter of the TB Control Unit designation. Mrs. Wilhelm shared that she has talked to Brian Robertson about the issue but has not received any guidance and suspects that Dr. Arnette will propose developing a M.O.U. (Memorandum of Understanding) to allow the city to continue to conduct investigations on suspected TB cases within the city. The Board advised that since the city is handling such issues as HIV and Hepatitis C testing and Help Me Grow Home Visiting for the entire county that the county should maintain the TB Control Unit designation and handle the subsequent responsibilities associated with that designation.

Council Members:

The MARCS system that the City uses for radio communication requires an upgrade. The capital plan from last year showed the \$700,000 expenditure under the Police capital budget as the P-25 MARCS Conversion.

If the City is to continue utilizing the MARCS system for City communications and statewide emergency response connectivity, this hardware upgrade is a necessity.

If the system is contracted before December 6<sup>th</sup>, 2013, the City can receive discounts from MARCS and Motorola, as well as obtain some credit for the consoles we already own. I would request a meeting of the appropriations committee to follow the committee of the whole on November 26<sup>th</sup>. If the Council can give me the ability to enter into a purchase contract, I will continue my negotiations with Motorola and MARCS. The latest proposal for the consoles is a total of \$397,661. Executing the agreement yet this year will save approximately \$27,900.

The five year capital plan allows you to see how this purchase will positively impact the overall plan. Since this was already planned and documented as a proposed purchase in 2014, we will simply be moving that project purchase forward into 2013, at a lower cost in order to save money. This is similar to the process we used when we put additional funding into the paving plan for 2013 in order to take advantage of low unit prices.

Please appropriate \$400,000 to the P-25 MARCS Conversion.

Separately, the Airport has reported the need to purchase more jet fuel. Bob Johnston has requested an additional \$90,000 to fund a purchase that would cover fuel purchases this year and into the beginning of 2014. I would request an appropriation as follows:

AN ORDINANCE VACATING A CERTAIN ALLEY (HEREINAFTER REFERED TO AS FIRST STREET ALLEY VACATION) IN THE CITY OF FINDLAY, OHIO.

WHEREAS, a petition has been presented to Council for vacating a portion of an alley set forth herein, and;

WHEREAS, Council upon approval and recommendation of such vacation by the Planning Commission of the City of Findlay, Ohio, is satisfied that it will not be detrimental to the general interest and ought to be made.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Findlay, State of Ohio:

SECTION 1: That the following described alley be and the same is hereby vacated:

Situated in the City of Findlay, County of Hancock and State of Ohio:

Being a two hundred foot (200') long alley lying adjacent to Lots 4, 5, 6, 7, and 8 in the Central Addition to the City of Findlay, County of Hancock, State of Ohio.

SECTION 2: That the aforesaid vacation is hereby made subject to the preservation of the public utilities right-of-way, in accordance with the provisions of Ohio Revised Code Section 723.041 including an easement is reserved for all sanitary and/or storm sewer lines in said vacated right-of-way.

SECTION 3: That this Ordinance shall be in full force and effect from and after the earliest period provided by law.
