# Charles Williams - What is the definition of appropriate in City Council

Mr. Williams noted that at the last meeting, the word appropriate was mentioned, so he looked up the definition in a dictionary which defined it as something that is suitable, fit and proper. He witnessed the most violent thing he has ever seen in City Council consisting of Auditor Staschiak and the Mayor, two (2) elected city officials. The Mayor questioned the City Auditor about his record on taxes and key records, and about how many employees he has. Auditor Staschiak is doing a fantastic job. He asked if what had happened there was suitable, fit and proper as he does not think so. They had to go into a special council to cool her down. That happened here in Findlay.

The lives of the two (2) individuals that requested the alley vacation are more important than the safety of the family of ten (10) living at 830 East Sandusky Street including a pregnant mother of twins who was put through unreal crap. They put this mother's life in danger because two (2) guys wanted their streets closed to endanger the residents' lives at 830 East Sandusky Street.

He asked if was proper for Mr. Rooney to allow a fence to be put up when he was a lawyer for Best. Mr. Williams reminded Council of the tape he brought before Council playing a recording of Mr. Rooney stating that the property owner can do anything he wants to do with it. He asked why the City is charging citizens two hundred fifty dollars (\$250.00) to go through a variance committee. Council President Monday reminded Mr. Williams that he has one (1) minute remaining on his time. Mr. Williams continued stating that it is a rip off.

Mr. Williams asked who Robert is when Council refers to Robert's Law. He asked if it is Bob Schuck. Councilman Harrington lifted up a copy of the Robert's Rules of Council book that Council follows. He informed Council that Bob Schuck said to give Council hell for their corrupt crap. He told that to his wife and she relayed that to him.

Mr. Williams noted that Findlay should be called sex in the city and not Flag City. He asked Council if they realize the lawsuits that some City Councilmembers are doing in the City of Findlay and are getting paid to take trips with it which is pathetic. Council President Monday notified Mr. Williams that his time had expired.

REASON: The City had to appropriate the entire amount of the interest payment for the Energy Bonds for the 2018 debt payments, however, the Series B bonds are federally subsidized and we did receive a portion of our subsidy payment. Due to the federal mandated sequester, we did not receive the entire subsidy. Also, the amount that was due on the Series A bonds ended up being less than was shown on the amortization schedule and was originally budgeted. These transactions return the fronted appropriation to CIT Fund - Capital Improvements restricted account.

REASON: A portion of the amount received from the assorted property taxes from the County tax settlements is deposited into Police and Fire Pension Funds by law. The cash balance is then transferred to the General Fund at the end of the year. Although the revenue budgets for 2018 were estimated very closely, the transfers out of these funds were budgeted low. The County revises their revenue estimates after adoption of our annual appropriation ordinance, and in order to avoid potentially over-budgeting the fund on the certificate filing, the transfer out is budgeted lower than expected.

REASON: Based on current projections, the actual income tax collections will be more than the original estimate. The tax is allocated to the CIT Fund - Capital Improvements Restricted Account and General Fund based on actual collections. More money will be transferred than originally budgeted and need the appropriation increased by this amount in order to complete the transfer to the General Fund. Legislation to appropriate funds and to adopt on an emergency for the above listed items is requested. Ordinance No. 2018-126 was created.

#### Discussion:

Mayor Mihalik pointed out that there are two (2) really good news within this letter. The Cemetery Trust Fund has come in higher than the original budgeted estimate for 2018. That total amount will get transferred to the General Fund. Also, income tax collections are more than the original estimate for 2018. Both were positive news.

City Auditor Staschiak clarified that any interest that comes into the Cemetery Fund will stay with the Cemetery. When lots are sold out, the money that is generates to run the operations and maintain the Cemetery to remain in the fund. Council should look at that every five (5) years or so to make sure that they are on track with the receipts so that it does pay for the operations. Filed.

By authorization of Ordinance No. 2018-019, a bid opening was held for this project on December 5, 2018. One bid was received from Mosser Construction of Fremont, Ohio in the amount of \$278,000. This project is included in the 2018 Capital Improvements Plan with a project estimate of \$275,000. \$20,000 was previously appropriated to the project for design and startup. An appropriation for construction, inspection, and contingency is needed at this time to complete the project. Legislation to appropriate funds is requested. Ordinance No. 2018-127 was created.

Service Director/Acting City Engineer Brian Thomas - areas B4-B6 sewer separation phase 2, project no. 32556100

As part of the project, the new sewer needed to be bored under the railroad on Foulke Avenue. As part of the railroad's process, they provide an estimate for flaggers to be present during the boring process. Engineering has not received the final bill from the railroad. That bill is anticipated to be about half of the original estimate. During construction, several sanitary laterals were discovered to be in conflict with storm sewer that was being installed. Engineering would like to pay the contractor for this work, but the contingency money for this project is currently tied up in the PO for the railroad for the work previously mentioned. Since the City has not control over how long it will take to get the bill from the railroad, remaining funds from Phase 1 of the project and additional \$12,000 be appropriated into Phase 2 so that the contractor can be paid. Once the railroad bill is received and paid, the existing PO can be reduced and the remaining funds will be returned to the Stormwater Fund. Legislation to appropriate and transfer funds is requested. Ordinance No. 2018-128 was created.

Hancock Regional Planning Commission Director Matt Cordonnier - amendments to the Findlay Zoning Code

Hancock Regional Planning Commission (HRPC) respectfully submits three (3) text amendments to the City of Findlay Zoning Code for review and comment. These proposed amendments are being submitted the first meeting of January 2019. The first proposed amendment to Section 1161.11.3 and 1161.11.6 reduces the number of parking spaces required for multi-family developments zoned M-1 or M-2. Over the last year, HRPC has worked with several developers who have commented that Findlay's parking standards are much higher than the industry standards. Upon further investigation, a reduction in the number of parking spaces required from 2.5 spaces per unit to 2 spaces per unit is being proposed. Secondly, HRPC is proposing additional language to be added to Section 1161.15 Conditional Use Requirements. The proposed language outlines the criteria that the City Planning Commission (CPC) shall use when considering a conditional use. the third amendment adds language to Section 1113.20(C). This section outlines the framework of "discretion" that the City Planning Commission has when reviewing cases. Filed.

#### Discussion:

Councilwoman Frische asked if any other zoning options were considered. Mayor Mihalik replied that this was the zoning classification that the property owners requested. It was reviewed by the City Planning Commission and also the Planning and Zoning Committee before their recommendations came to Council via this Ordinance which has now received three (3) readings and also a public hearing.

Councilman Russel believes the zoning classification being requested is appropriate. The concerns of the abutting property owners have been addressed with the City Planning Commission. He has served on the City Planning Commission and has observed many of their meetings where they are very cognizance of making properties fit in harmony with neighbors. When they did the zoning changes a couple of years ago, they further strengthened the screening requirements, especially when two (2) zonings do not match. In this situation, it is I-1 to a county residential. The Planning Commission takes those concerns into account during the site review. Mayor Mihalik agreed stating the standards that are in place now far exceed those that were in place several years ago. It takes into consideration what the zoning classification is to an adjoining property and provides a better opportunity for screening and overall aesthetic enhancements as opposed to what was outlined in the past. In the past, it was okay to put an industrial building anywhere. Now, there are screening requirements, landscaping requirements, and what the impervious surface looks like in a building is looked at. There is a lot more consideration to protect the adjoining property owners than what was in the past.

Councilwoman Frische noted that for economic development reasons and this being the first step, she supports the ordinance for the zoning change. Adjoining property owners need to be active and diligent in meetings when it gets to the actual project. One of the adjoining property owners in the audience thanked the City for contacting them during the process.

Councilman Hellmann encouraged the Planning Commission to take a look at not only the standard things, but also any noise issues, light glare, vehicular access, and look at creating some no-access along Crystal Avenue and other streets where this comes up on. He would like to see them tighten up the site plan review more than just the standard review.

Councilman Russel pointed out that the zoning code already includes light emission that leads off the property. He is unsure how to address noise suppression, but that it is enforced through the zoning code through the site plan process. When the City Planning Commission is reviewing the site plan to a set of standards, it is the zoning code that is already in effect.

# UNFINISHED BUSINESS: OLD BUSINESS

Mayor Mihalik asked for some direction from Council on the City Mission's request. She is looking into the possibility of utilizing Community Development Block Grant (CDBG) funds for this request to provide emergency housing services to those in need. She was approached by several community members who are affiliated with the City Mission and would like to let them know where Council is with their request. She would like to inform them if Council wants to continue to pursue the CDBG option in conjunction with a General Fund appropriation as requested, or just the CDBG option. They would like some clarity.

Councilman Shindledecker pointed out that he volunteers at the City Mission and is well aware of their needs. They are an organization that the City vitally needs, but to use strictly City taxpayer funds for this would be improper. He supports the effort to find any grant money that might be available.

Councilman Hellmann noted that he concurs with what Councilman Shindledecker just stated and believes it is a great idea.

Councilman Harrington noted that a couple Councilmembers will continue to work on this, and he also concurs with Councilman Shindledecker's comments in that the most appropriate action would be to seek grant funds and that Council should try to do anything that they can do with the hopes to find something that can help them.

Mayor Mihalik clarified that the CDBG formula money that is received is utilized to do infrastructure projects in low to moderate income neighborhoods throughout the City. There is a program in place for that. If Council is interested in using CDBG money from formula dollars, it could potentially impact, or will impact the ability to use those dollars for infrastructure projects and would then utilize not only OPWC money, but also General Fund money to support the construction of those projects.

Councilman Niemeyer would not support using General Fund money for this as it is taxpayers money that is not proper for the City to give away. If someone wants to give money to the City Mission, they could use their own funds. He suggested that instead of individuals giving money to the United Way, they could give to the City Mission.

## **NEW BUSINESS**

Councilman Hellmann noted that in the last COMMITTEE OF THE WHOLE meeting, it was mentioned to have the Economic Development Director Tim Mayle from the Alliance come and give a presentation to City Council to include an overview and summary of what has taken place over the last twelve to eighteen (12-18) months. It is a great story that he would like City Council to hear. He hears it every month at the board meetings. It would be beneficial for everyone else to hear it. He proposed having a COMMITTEE OF THE WHOLE meeting before the January 15, 2019 City Council meeting. Councilman Hellmann moved to have the meeting at 6:00pm, seconded by Councilman Slough. All were in favor.

agenda: Economic Development

City Auditor Staschiak thanked Council for passing the clean up Ordinance. He informed the general public that Council needed to do that because governmental accounting is different than private sector accounting. He reminded Council that at the first meeting in January, there will be a couple of ordinances that will need to be passed on an emergency because the way the rules work with the State, he cannot pay the money out until Council appropriates it. The entire budget is appropriated during the first meeting in January each year as reviewed by Council in their December meetings. There are no changes to the budget from the December meetings that took place a week or so ago. The budget will be in legislative form at the January 2, 2019 City Council meeting.

Councilman Harrington pointed out that the new crosswalk lights in the downtown streets add to the safety of pedestrians. He asked how those lights are tripped. Safety Director Schmelzer replied that they are a very good addition to our pedestrian crosswalks given the surrounding light sources that are out there. They are easily picked up by motorists. Both the Service Director/Acting City Engineer and the Project Manager did the research to come up with the idea. They are tripped when a pedestrian stands in the crosswalk for a number of seconds. There is a sensor on the pole, much like a traffic camera that picks up a car, they pick up a pedestrian that starts the light automatically. Councilman Harrington if they will work if there is a snow or frozen precipitation event. Safety Director Schmelzer replied that has already been thought about. The lights are used in other cold weather communities. They are frost-proof, snow-proof, and plow-proof. It is one of the reasons why they did a stamp-asphalt crosswalk instead of a poured concrete one. Eventually, they will have to be replaced.

Mayor Mihalik informed Council that within the next twenty-four (24) hours, the budget in brief will be ready for public view on the City's website that more concisely interrupts what has been submitted to Council for consideration. It is a quick source to see what the City is planning on spending dollars on, where dollars come from, and will provide some key statistics that have been accumulated throughout the year. Budget books will still be available if Council prefers them.

Safety Director Schmelzer pointed out that fifteen million dollars (\$15,000,000) is going toward flood mitigation. A handful of individuals were heavily involved in lobbying for that infrastructure, the Mayor being one of them. Anyone that has ever been impacted by any of the severe floods in the City of Findlay should thank the Mayor, as well as the members of the State Legislator who voted in favor of it. It will go a long way toward the City getting flood mitigation done here.

Council President Monday informed Council that the first meeting of January 2019 will be on Wednesday, January 2, 2019 due to Tuesday, January 1, 2019 being a holiday.

Council President Monday adjourned Council at 8:16 pm.
