President Monday opened the meeting with the Pledge of Allegiance followed by a moment of silence in memory of Findlay Police Officer Doug Akers.

WRITTEN COMMUNICATIONS:

Matthias Leguire - referendum petition for Ordinance No. 2018-058 AS AMENDED

Discussion

Councilwoman Frische requested that the letter be read. The Council Clerk read the letter in its entirety.

Mr. Leguire requested that his letter and a letter from Attorney Robert Griffin Jr. be included in tonight's agenda and be read into the minutes. The City of Findlay filed Ordinance No. 2018-058 AS AMENDED with the Hancock County Auditor's and Hancock County Recorder's Office. The Ordinance was approved 6-5 with Council President Ron Monday casting the deciding vote to vacate named streets Benton and Carrol on August 7, 2018, and as stated in the Ordinance, was to go into effect 30 days after approval, however, Hancock County records indicate the City of Findlay filed the Ordinance on August 20, 2018 which is well before the 30 days required for the Ordinance to go into effect. A referendum petition was successfully filed with the City of Findlay Auditor's Office and approved by the Hancock County Board of Elections within the required 30 days, thus putting a hold on the Ordinance until it can be voted on in the November 2019 general election. The attached letter states "Section 731.29 Ohio Revised Code, specifically provides that once a referendum petition concerning a city ordinance has been filed, such ordinance or measure shall not go into effect until approved by the majority of those voting upon it." Mr. Leguire requests Councilmembers to get involved in correcting this situation as quickly as possible. Council should also look into the processes involved when Ordinances are approved and when information is sent to the County, affected property owners, etc. He asked if the Ordinance should have vaited at least 30 days before being sent to the County and if letters should be have been sent out to all involved property owners notifying them of the referendum petition explaining the situation. He also asked about 725 Hawthorne Road and informed Council that the property sold on November 21, 2018 with improper property boundaries as it boarders both Carrol Street and Benton Street which are listed as vacated on the County records. Mr. Leguire requested a response from Council as to how this error will be corr

Discussion:

Councilman Russel noted that there is a second letter on the back side of Mr. Leguire's letter. Council President Monday replied that the other letter is addressed to Law Director Rasmussen from a Robert H. Griffin Jr., Attorney at Law that will be read into the record as well. The Council Clerk read the letter in its entirety. Council President Monday noted that Mr. Leguire will be speaking to Council tonight as an ORAL COMMUNICATIONS.

Councilman Hellmann asked if the City Law Director has any comment regarding this. Law Director Rasmussen replied that he discussed this with the Auditor's Office the beginning of last week which is when it came to his attention that the Ordinance had been filed on August 20, 2018. He has not received the petition from the Auditor's Office, so he does not know the petition date which will be provided through the Auditor's Office or the Board of Elections. He is unsure if the thirty (30) day deadline or the filing of the Ordinance came first. He has researched the property sale that he did not know about until after the filing. Once he has all those documents, he will look at where this situation is at. If it is before the petition, there are a couple of things Council can do. They can let it go or can repeal the Ordinance. If the Ordinance was not filed in time, then it is null and void. Until he has that additional piece of information, he does not know the outcome.

Councilwoman Frische asked if there is a process in place for when something is vacated and is passed by Council for the thirty (30) day referendum period on how and who is notified. She asked if there is a process in place for the Zoning Department or Board of Zoning Appeals, or if there is anything Council needs to be doing to put any processes in place. Law Director Rasmussen replied that there is nothing in the code about the notification process. In this case, the Ordinance was not passed on an emergency measure. Every piece of legislation has a thirty (30) day period of referendum unless it is passed by an emergency measure. This Ordinance was filed and did not have the emergency language, so it should not have been filed as early as it was. Councilwoman Frische asked if the Ordinance had the thirty (30) day clause on it. Law Director Rasmussen replied that it did not. It was not an emergency, so it did not have the clause that provides the referendum period. Councilwoman Frische asked if the Zoning Department knows not to issue any permits for in-ground pools, fences, etc. for properties backing up to these streets due to the adopted Ordinance to vacate and the referendum on the vacation, even though those property owners were under the impression they would have additional ground with their property when they purchased it. She asked if the property owners are notified in order to avoid any type of issues. Law Director Rasmussen replied that the Zoning Department knows now because when he received this letter from Mr. Leguire, it was the first indication of a house transferring. Only one (1) home is transferring that shares the vacated alley. He spoke with the Zoning/Floodplain Administrator at length this afternoon to make sure nothing is being placed on those properties that would interfere with the vacation.

Safety Director Schmelzer added that subsequent to the petition that was filed, there were internal discussions about making sure that any property owner that wanted to do anything in that area was aware of it. The Zoning/Floodplain Administrator is not going to be issuing any permits into right-of-way and/or for allow for encroachments and setbacks based on right-of-way subject to that petition. Councilwoman Frische asked if letters were sent to those property owners since that initial conversation. Safety Director Schmelzer replied that the Zoning Department are not going to issue permits if someone applies for something based on that vacation. Councilwoman Frische asked if notices went out to the property owners. Safety Director replied there would be no need to if no one wants to do anything. Filed.

ORAL COMMUNICATIONS:

Matthias Leguire - Carrol St/Benton St

Mr. Leguire pointed out that this is the first he has addressed Council since he requested the deadline for the referendum petition in September. He was successful and the referendum petition will be on the November ballot. He thanked those who signed his petition and helped him garner enough signatures. He found an error in the paperwork for Ordinance No. 2018-058 for the vacation of Carrol Street and Benton Street where it was sent to the Hancock County Recorder's Office on August 20, 2018. He filed a referendum petition in September within the thirty (30) days of the Ordinance being signed by Mayor Mihalik with enough valid signatures for it to appear on the ballot in November 2019. Ohio Revised Code Section 731.29 states that the referendum petition prevents the Ordinance from going into effect until it has been voted on by the public. He asked Councilmembers to correct the mistake and un-vacate the streets with the County. He does not understand why it was sent to the County before the thirty (30) days. It was sent there within two (2) weeks of it being passed at Council. He does not think it should have gone to the County until at least thirty (30) days because it did not go into effect until thirty (30) days later. Also, he hopes that Council will notify the property owners at 725 Hawthorne Road as that property is smaller than what they purchased. Filed.
