Chief Development Officer Rod Siddons of Blanchard Station Housing Partners II, LLC - 50 unit housing unit at end of Concord and Bishop Lane

The Blanchard Station Housing Partners II, Inc. plan to be the general partner of a residential rental development located in or within a one-half (1/2) mile radius for our political jurisdiction and will submit an application to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property. The proposed development is new construction and is expected to serve moderate income families with affordable rent. It will offer up to fifty (50) residential units that are all single story with garages that feature open floor plans to maximize the amount of livable space, providing comfortable living accommodations for families. The units will feature enhanced lighting package, including various forms of task lighting in the kitchen and bathroom ceilings, and lighting under the cabinets. Universal Design principles were incorporated into the development, and the entire development will be fully visitable. Each unit will have utility rooms and washer/dryer hookups, central air conditioning, new kitchen appliances, including stove, refrigerator, microwave and dishwasher. While the apartments will be designed to meet the needs of families, they can be easily modified to accommodate individuals with physical limitation. Universal Design features will include 32' minimum clear door opening widths, flush thresholds, light switches, electrical receptacles and view windows at appropriate heights, lever door handles and grab bar blocking in walls around toilets and in tubs/showers. The development will also be seeking certification under the Energy Star Certified New Home Program. There will be a variety of site amenities to encourage recreational activities and social interaction, amenities will include a community building, shelter house, dog park, children's playground, and accessible pathways for residents to enjoy. The proposed development will be financed with Housing Tax Credits, Conventional 1st mortgage, HDAP Home Funds, Housing Development Loan and a Deferred Developer fee.

City Auditor Staschiak - City's self-insurance fund

During the budget and pre-budget meetings, City Auditor Staschiak mentioned it is time to replenish the City's Self-Insurance Fund. Historically, it is funded to a level of one million dollars (\$1,000,000) and is used for various insurance related items. Several years ago, it was estimated that the fund has saved the City over five million dollars (\$5,000,000) in additional insurance premiums over the years. The City does not have any environmental insurance coverage and this fund serves as partial protection against any potential future claim. Legislation to appropriate funds to replenish the fund is requested for the February 19, 2019 City Council meeting. These funds were included in the projected beginning cash balance for 2019 based on the budget meeting comments as part of the budget calculations. Ordinance No. 2019-014 was created.

President Pro-Tem Russel asked Service Director/Acting City Engineer Thomas if it would be advantageous to the City to have this receive its third reading tonight. Service Director/Acting City Engineer Thomas replied that two (2) larger pieces of equipment for the Street Department are included in this that they are currently renting equipment until this is approved to purchase new equipment. If this Ordinance is approved tonight, they could purchase them sooner. If it waits until the next meeting for the third (3rd) reading, it would result in them having to rent the equipment an extra month, so passing the Ordinance tonight would save some money.

Councilman Hellmann asked what the rental costs are. Service Director/Acting City Engineer Thomas replied he does not know.

Councilwoman Frische asked what specific pieces of equipment they are. Service Director/Acting City Engineer Thomas replied that they are not listed in the amended part because the amended part is to update the project numbers. The original Ordinance did not have job numbers. Those two (2) pieces of equipment are in the equipment part of the original.

Councilman Shindledecker moved to suspend the statutory rules and give the Ordinance its third reading, seconded by Councilman Niemeyer. UNFINISHED BUSINESS: OLD BUSINESS

Safety Director Schmelzer thanked Law Director Rasmussen for his assistance for the better part of six (6) years, which is about how long some of the proposals in the contracts were talked about, with the Union contracts. He thanked Fire Chief Eberle and the staff in his department. They are by far the best contracts that the City of Findlay has ever signed with its bargaining units. There was a lot of work that went into them. They protect the City's ability to maintain financial stability and compensates employees very fairly. He is appreciative of Council's votes, the City's leadership team, and all the employees who participated in the conversations with their willingness to give the contracts a shot.

Councilman Hellmann asked if the Law Director and/or the Fire Chief if they concur with what the Safety Director has just stated. Law Director Rasmussen replied he agrees with Safety Director Schmelzer. Negotiation with these contracts have taken place since 2012. The Safety Director has saved the City a lot of money with his negotiation assistance. The Bargaining Groups were fantastic to work with. The fact that they passed these contracts show that they agree on what the Administration is trying to do in the City.

Councilwoman Frische asked when the contracts will be signed, sealed, and delivered. She asked when they will be public. She asked when everything will be retroactive. Safety Director Schmelzer replied by the end of the week.

NEW BUSINESS

Councilman Harrington: PLANNING & ZONING COMMITTEE meeting on February 21, 2019 at 1:00 pm in the first floor Council Office (CO). agenda: proposed zoning code revisions via Ordinance No. 2019-010.

Service Director/Acting City Engineer Thomas informed Council that due to the passing of Mike Slough and also another member of the PARK AND RECREATION BOARD living outside of the City limits, there are two (2) vacancies on the PARK AND RECREATION BOARD. He wanted to mention that because the SHADE TREE COMMISSION had mentioned their vacancies at a City Council meeting and were able to get those filled right away, so it is his hopes to fill these vacancies quickly. He asked that if anyone is interested in being on the board to let him know. They meet the third (3rd) Monday of each month at 4:00pm.

Councilman Slough made a motion to excuse the absence of Councilman Wobser, seconded by Councilman Niemeyer. All were in favor. Filed.

President Pro-Tem Russel thanked the Ad Hoc Committed (Councilman Harrington, Councilman Slough, Councilman Wobser, and Councilman Russel) that worked on the Council Rules of Procedures. Council President Monday was at the majority of the meetings and Councilman Hellmann attended a handful of the meetings. A tremendous amount of work was accomplished during the numerous times the committee met and a lot of research was done on how other municipalities run their meetings.

President Pro-Tem Russel summarized the changes:

The biggest change is a reorganization of the old version into the new. The old one had been amended by simply adding verbiage at the end of it over the years and no longer made sense. There were things that should have been grouped together, so a majority of the changes were simply reorganization which is shown in the cross-reference from the old to the new. There was also some word-smithing done. The same general sections were kept the same and just moved some verbiage to areas where they belonged.

The second largest change is on Councilmembers. For example, Section 2J, verbiage was added about how Council conducts debates. Political speech and City Council representation is in Sections 2K and 1D.

Also in the proposed rules, Council is no longer allowed to send mail to constituents in their district at the City's expense.

The requirement for attendance has been changed in that if a Councilmember knows that he/she will be absent, they are to notify the Council President in advance of the meeting(s) they will be absent. The process for how notification is given is in Section 2E.

When and how it is appropriate to abstain in voting is listed in Section 2M5.

There has been a lot of comments in the newspaper about changes in public participation. The changes make a lot of sense. There is now a restriction on advertising products or services.

Section 2l3 states that there is no promoting of political candidates. Someone cannot state "vote for Joe (or whomever)" at a City Council meeting. This also applies to Councilmembers. It does not restrict citizens from asking Council to take a position on a ballot issue. If it is a ballot issue and they want the City to weigh in, that continues to be acceptable. Section 2l6 does not allow for signs or banners in Council Chambers.

Section 215 restates what Ohio Revised Code already talks about on disrupting public meetings and having civil discourse.

Collectively, it appears that there are a lot of changes, but the changed version has much in common with the old rules. Any questions on the rules or how the committee got to the changes and where they came from can be addressed with any committee member.

If there are no questions or concerns, the next step would be a formal vote of Council to adopt them. It is not via legislation, but requires a vote of Council to adopt them as Council's Rules of Procedure.

Councilman Shindledecker noted that he received a few phone calls on this, not many and not indignant in any way indicating that they were somewhat concerned that the new regulations might make it somewhat difficult for a member of the audience to have a comment directed to a specific individual member of Council. He has gone through the proposed rules four (4) times in the last ten (10) days, including today, and cannot find anything that would preclude or limit a member of the public from having such conversations. He commends the committee on the job that was done in preparing the rules. President Pro-Tem Russel replied that when bringing an issue before Council, it should be brought to all of Council for concern. It is not to narrow down to one specific Councilmember for only he/she to know or to ask him/her why he/she did a certain thing. That type of discussion should happen one-on-one with Councilmembers and the general public individually. It does not preclude someone from coming and saying something to all of Council. These proposed rules do not change the ability of citizen participation in any manner other than that they cannot promote candidates and cannot advertise. Those are the only two (2) big restrictions that have been placed on citizens that were not specifically stated before.

Councilman Harrington moved to approve the 2018-2019 Council Rules of Procedures as presented, seconded by Councilman Slough.

Discussion:

Councilman Russel asked Law Director Rasmussen if the President of Council, when acting as Interim Mayor, is authorized to vote per Ohio Revised Code. Law Director Rasmussen replied that is correct. He/she is authorized to vote.

Councilwoman Frische feels that the public should be allowed to have one-on-one conversations with Councilmembers if they so choose. While she agrees that the one-on-one conversations with Councilmembers should be allowed to happen, she feels if that does not happen, a question should be allowed to be asked and answered at the pleasure of the citizens of the community. For that main reason, she is voting against adopting the proposed rules. Councilmember's job is to communicate, so when trying to limit that, it sends the wrong message to the community.
