By authorization of Ordinance No. 2019-003, a bid opening was held for this project on February 21, 2019. Bids were received from four (4) potential contractors with bid amounts ranging from \$727,739.75 to \$805,947.50. The lowest and best bid was received from Newcomer Concrete of Norwalk, Ohio. This project is included in the 2019 Capital Improvements Plan, and the total project estimate is within the budgeted amount. Previous, an amount of five thousand dollars (\$5,000) was appropriated to the project for design and startup. At this time, an appropriation for construction, inspection and contingency is needed to complete the project. This request is for concrete work only. There will be a separate request for the asphalt portion of the work. The contractor would like to begin the work on March 25, 2019 so that the work can be completed earlier in the construction season. Due to this still being the beginning of the year and the Capital Fund balance is still lower, so he is asking that this project be funded from the General Fund. SECTION 5: That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements; wherefore this ordinance shall take effect and be in force from and immediately after its passage.
