My name is Judy Brenner and I would like to request the city to allow street legal golf carts to be driven in the downtown area. I am looking to create a business that would shuttle people around the downtown Findlay area and promote local businesses. The service will be offered free of charge. The revenue will be generated by advertising for local businesses via digital signs mounted on the cart. It is my understanding that in the State of Ohio and Hancock County it is legal as long as the golf carts are equipped with the street legal safety equipment, are inspected, and that speed limit for the road that they are traveling on is not over 35 mph. It is also my understanding that the city of Findlay must pass an ordinance to allow the carts to be driven in the downtown area. I am requesting that the city passes the ordinance so I can start shuttling people and promoting downtown business by making it easier to get around. 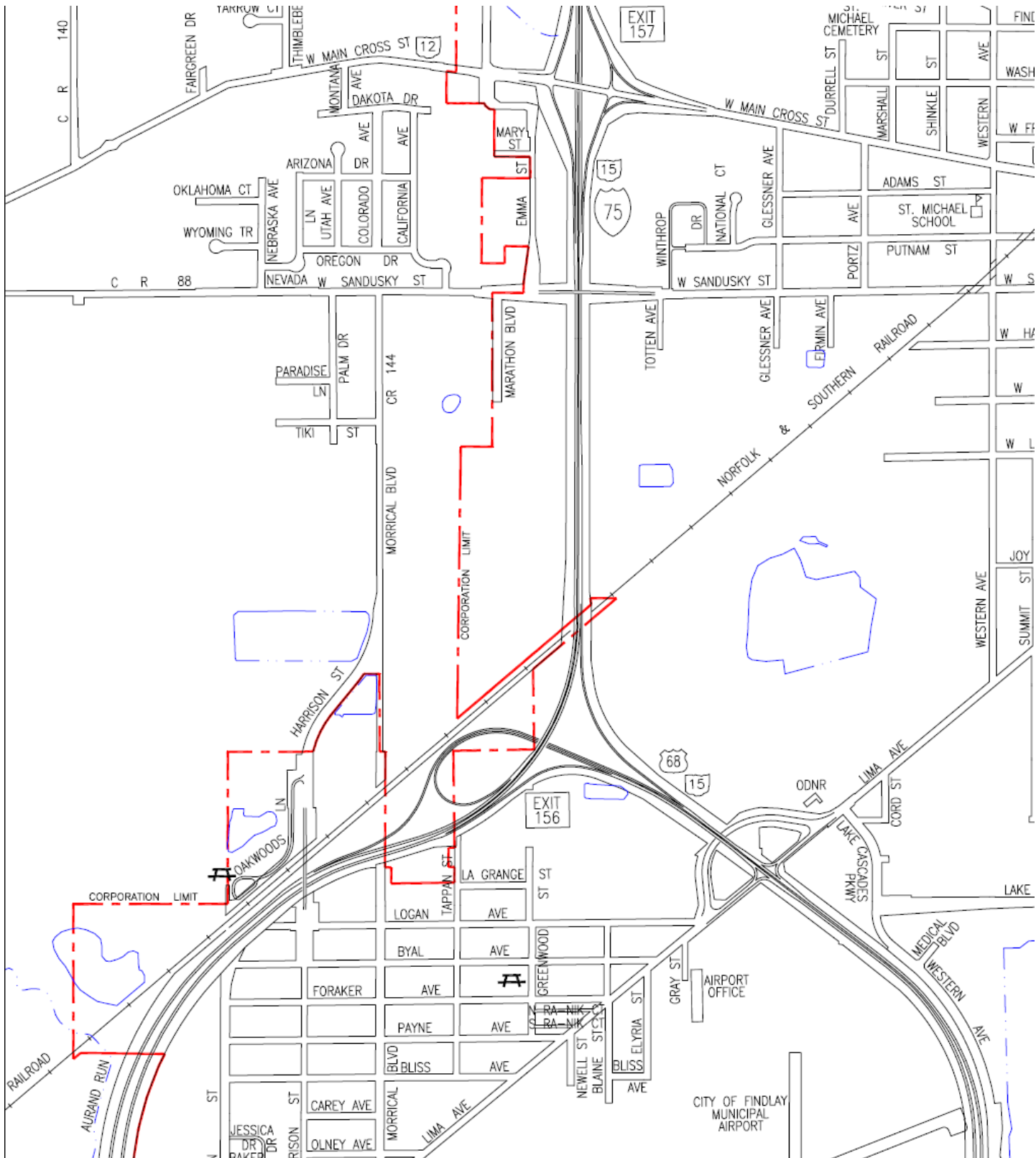
