Mayor Lydia Mihalik - Dog Warden services

The agreement for Dog Warden services between the City of Findlay and the Board of Hancock County Commissioners expired on December 31, 2013. The City and County are interested in reviewing the agreement for said services for the period commencing retroactively on January 1, 2014 through December 31, 2014. The agreement will then renew itself for additional one (1) year terms for a period not to exceed three 93) years. In consideration for the services to be rendered under this agreement, the City agrees to pay the County the sum of twenty thousand dollars (\$20,000.00) per year. Funds are budgeted each year for these services.

#### **MINUTES**

#### ATTENDANCE:

MEMBERS PRESENT: Service-Safety Director Paul Schmelzer, Police Chief Greg Horne, Fire Chief Tom Lonyo, Councilman Ron Monday.

<u>STAFF PRESENT</u>: Mayor Lydia Mihalik, Matt Stoffel, Public Works Superintendent; Kathv Launder. Citv Clerk.

<u>GUESTS PRESENT</u>: Jennifer Cramer, George Adam and members of Findlay Hunter's Ridge Homeowners Association.

#### **OLD BUSINESS**

 Request of Jennifer Cramer, 929 East Main Cross Street, to reduce speed to 25 MPH on East Main Cross from Osborn to beyond Huron Road.

#### 04/21/2014

Jennifer Cramer stated that there are drivers that speed around the curve near the Blanchard River dam on East Main Cross Street. She is concerned for safety of those walking in the area. Councilman Monday stated several years ago this request came before the Traffic Commission. At that time it was discussed that East Main Cross Street from Osborn to Bright Road is to be posted 35 MPH because it is over one mile long (1.1 miles long) without having to stop, and East Main Cross Street from Osborn to Blanchard Street is to be posted 25 MPH because it is under one mile long (.9 mile long). Councilman Monday stated this is due to state law. Chief Lonyo stated that there have been numerous accidents with motorists ending up in the river and suggested that East Main Cross from Osborn to Bright Road be made 25 MPH. Director Schmelzer stated that we need to research the law to determine if we can legally lower the speed limit to 25MPH.

Motion to table request by Councilman Monday, second by Director Schmelzer. Motion passed 4-0.

#### 05/19/2014

Motion to lift item from table, by Director Schmelzer, second by Chief Horne. Motion passed 4-0.

Director Schmelzer stated that Law Director Don Rasmussen stated that the speed limit should remain at 35 MPH based on ORC 4511.65. The City can put up sign warning of a curve and hidden driveway. Stoffel stated that there are chevron signs posted warning of the curve. Chief Horne stated that he will increase the patrol and enforcement in the area to help slow motorists.

Motion to deny request to reduce the speed limit to 25 MPH on East Main Cross Street from Osborn to Bright Road, by Director Schmelzer, second by Councilman Monday. Motion to amend to include approval of posting additional signs to warn of the curve ahead with speed limit advisory, by Director Schmelzer, second by Chief Lonyo. Motion as amended passed 4-0.

#### **NEW BUSINESS**

1. Request of George Adam, Sr., on behalf of the Findlay Hunter's Ridge Homeowners Association, to change the stop sign at the corner of Williams and Lippincott to a Yield sign; and to revisit the temporary traffic flow pattern on Fishlock Avenue during the Hancock County Fair.

Motion to remove all signage at the corner of Williams and Lippincott until the road is improved, by Chief Lonyo, second by Councilman Monday. Motion passed 4-0.

Director Schmelzer stated that the City's Event Committee reviews the request of the Hancock County Fair each year to temporarily change the traffic flow on Fishlock Avenue for the duration of the Fair. When the Event Committee meets to discuss this, the City will contact Mr. Adam to invite him and other members of the Findlay Hunter's Ridge Homeowners Association to attend to give input. Prior to this meeting, Chief Horne suggested the Homeowners Association meet with Lt. Ring to discuss alternatives to the current traffic flow plan. A map of the traffic flow will be emailed to Mr. Adam for review. Mayor Mihalik mentioned that she will reach out to residents in Hunters Creek to obtain their input.

2. Request of Adam Gelbaugh to place stop signs in the alley intersection of the first alley to the east of South West Street between Locust Street and Baldwin.

Chief Lonyo spoke with homeowner. The issue mainly occurs during pick up and drop off of students at Donnell Middle School. East/West direction would be best to place the stop signs. Chief Horne stated that this is a blind alley. Motion to install stop signs in the alley intersection of the first alley to the east of South West Street between Locust Street and Baldwin in the east/west direction, by Chief Lonyo, second by Chief Horne. Motion passed 4-0.

3. Request of Sandy Radabaugh, 640 Cherry Street, to change the following intersections to four-way stops: Dunn Avenue and Cherry Street, Central Avenue and Cherry Street.

Councilman Monday stated that he doubts this area meets the traffic warrant to make the intersections of Dunn Avenue and Cherry Street and Central Avenue and Cherry Street four-way stops.

Motion to deny request to make the intersections of Dunn Avenue and Cherry Street and Central Avenue and Cherry Street four-way stops, by Councilman Monday, second by Director Schmelzer. Motion passed 4-0.

4. Request of Kathy Markley, 200 Clinton Street, to paint parking spaces on Clinton Street from Center Street to Cherry Street.

If Traffic Commission were to approve this request, the area could potentially lose parking spaces.

Motion to deny request based on one resident's request and that it would be more detrimental than helpful, by Director Schmelzer, second by Chief Lonyo. Motion passed 4-0.

With no further business to discuss, the meeting adjourned. The next meeting of the City of Findlay Traffic Commission will be held on June 16, 2014, at 2:30 p.m. in the third floor conference room of the Municipal Building.

#### **MINUTES**

#### ATTENDANCE

Members Present: Paul Schmelzer, Chair, Matt Cordonnier, Dennis McPheron, Bob Nichols, Gary Pruitt, Mike Slough.

<u>Staff Present</u>: Lu Draper, Matt Stoffel, and Kathy Launder. <u>Guests Present</u>: Jim Carpenter, Coed Volleyball Association.

#### APPROVAL OF MINUTES

Minutes of the April 21, 2014, meeting was not approved for lack of a quorum.

#### OLD BUSINESS

Review of Policies and Procedures and Rate Schedule: Coaching Policy: Draper developed a policy for coaches who want to use Public ice at no charge to them and then charge students to coach them. This is no different than if a vendor came in to use the ice. Vendors are charged a fee to use City facilities. Coaches have been coming in during Public ice time, not paying the admission fee to get in, and then charging students to coach them during this time. The students pay the admission cost as well as the coaching fee. The policy states that the coaches shall pay a \$50.00 fee for 6 months. There have been 10-25 coaches utilizing the ice at no charge. A memo will be displayed stating the new policy.

<u>Pool Slide</u>: Director Schmelzer stated that installation of the new slide at the pool has been delayed due to permitting processes.

<u>Pool Study</u>: Director Schmelzer stated that we will be getting an update from the consultant soon. The delay was the question of whether we could hold sanctioned tournaments in the current depth. It was determined that we will need to increase to a 7foot depth if we want to hold sanctioned tournaments. The consultant will plug in the requirements then come back to the next meeting of the Parks and Recreation Board to give their report.

Miracle Field and Additional Two Fields: Director Schmelzer stated that he is in the process of getting engineering proposals for the Miracle Field and two additional ball fields. Cannot get easement where we wanted so looking to go through east side of parcel.

#### **NEW BUSINESS**

Request for Assistance with Winter Volleyball League: Jim Carpenter, outgoing president of the Coed Volleyball League, stated that they have using Glenwood for many years. The league previous to last year did not have to have liability insurance. Now the Findlay City Schools are requiring them to have liability insurance. The league always felt like they were an extension of the City's Recreation Department. That is why the league requested to use City's insurance last year. The winter coed volleyball league used to be a City run league. It is no longer run by the City. Findlay City Schools allows the league to use its facilities, but requires liability insurance. Since the league is no longer part of the City, the league cannot use the City's insurance. Director Schmelzer stated that it is not cumbersome to obtain liability insurance. League should have no trouble obtaining it. The City would like to see the winter league continue, but cannot have it run under the City's insurance. Carpenter was also concerned that since the league is no longer associated with the City, they will have to pay rental fees to Findlay City Schools.

#### DEPARTMENT REPORTS

Recreation Department Report: Draper reported that they are trying to promote the National Softball team coming and working on getting volunteers to help. There are several tournaments scheduled. New events at the Cube include a drive-in movie in the parking lot, flea market, antique valuation, demonstration of repurposing items – trash to treasure. We received the new bleachers for the Marathon Diamonds. The summer ice season is up and running. Last year the summer Learn to Skate program had 10 participants. To date we have 31 paid participants without advertising the program. Also two hockey camps will be scheduled.

Parks Maintenance Department Report: Stoffel reported that they are getting the cemetery ready for Memorial Day. The pool is filled and are getting it ready to open. They are finishing up renovation work on the Bandshell in cooperation with the Hancock Park District to get it ready for the Concert Series. The masonry of the Bandshell will fixed with the next distribution of Hancock Park District Foundation grant monies. This year's grant monies are being used to fix roofs on shelterhouses in Riverside Park. The project to replace the base surface with a rubber surface at the Kiddie Koral is almost complete.

#### OTHER REPORTS

Hancock Park District Report: Pruitt stated that the Zonta Landing Boat Rentals will be open weekends and Holidays starting Memorial Day weekend. The Concert Series at Riverside Park will begin June 11 on Wednesdays with one Sunday evening performance. Dan Boyd, Park Operations Manager, will be retiring. Bill Patch will be assuming Boyd's duties along with maintaining his current duties starting June 1.

#### OTHER BUSINESS

<u>Next Meeting</u>: The next meeting of the Parks and Recreation Board is scheduled for June 16, 2014, at 4:00pm in the third floor conference room of the Municipal Building.


