AN ORDINANCE APPROPRIATING AND TRANSFERRING FUNDS AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Findlay, State of Ohio, two-thirds (2/3) of all members elected thereto concurring:

SECTION 1: That the following sums be and the same are hereby appropriated and transferred:

FROM:

CIT Fund – Capital Improvements

\$4,000.00

Restricted Account

TO:

Howard Run Ditch Cleaning Project No. 32549500

\$4,000.00

SECTION 2: That the actions of the Mayor be ratified and that she be authorized to pay the bond amount pursuant to Ohio Revised Code 6131.06 to facilitate the notification process. Said Funds shall be advanced to the County in accordance with an agreement to be formalized between the City and County. Two thousand dollars (\$2,000.00) was appropriated to this project tin 2014. Additional funds will be required once assessment levels are determined.

SECTION 3: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the inhabitants of the City of Findlay, Ohio, and for the further reason it is immediately necessary to appropriate and transfer said funds so that the City's portion of the construction costs may be paid. Whereby the County will return any and all unused funds to the City.

WHEREFORE, this Ordinance shall take effect and be in force from and after its passage and approval by the Mayor.
