Discussion:

Councilwoman Frische asked if it is normal for the withholding to be down. Mayor Muryn replied that it was a little irregular, but that June is up significantly, so it has balanced out. It was just a timing issue. City Auditor Staschiak added that happens when there is a third (3rd) pay period in a month. There typically are only two (2) pay periods in a month, so when there is a third (3rd) one, it comes in either early or late the next month, which causes a large bump or decrease. Councilman Russel added that from April to May, a tremendous amount of discrepancies were made up from the previous year. May was a good month for withholding. Filed.

City Auditor Staschiak - Revenue Estimates for fiscal year 2020

City Auditor Staschiak will provide, in the July 16, 2019 City Council packet, the estimated revenues for the next fiscal year. This is the first step required under Ohio budgetary law and the figures are a best estimated of what is expected in revenues over the next eighteen months. In order to meet the statutory requirements for the distribution of the local government money, this document should be accepted by Council at the July 16th meeting so that it can be filed with the County Auditor no later July 19, 2019. A motion for acceptance of the revenue estimates will be needed during the July 16, 2019 City Council meeting. A public hearing before the July 16, 2019 City Council meeting will be scheduled and published in ten (10) days before the hearing, during which period two (2) copies will be available for public inspection in the City Auditor's Office. Council's motion to accept this is needed. A Public hearing to be held at 6:55pm on July 16, 2019.

Councilman Russel asked that the letter be read into the record, seconded by Councilman Wobser. All were in favor. The Council Clerk read the letter in its entirety. All were in favor.

City Auditor Staschiak pointed out that there is a clean up item that needs to be done and the ten (10) day inspection resolved before the final draft is done and the final inspection starts. It is a minor accounting item that is very important to this document. Ordinance No. 2019-001 appropriated three hundred seventeen thousand dollars (\$317,000) to the Municipal Court Special Projects Fund, but the Court revenues did not end up last year as they had hoped, so a de-appropriation of seventeen thousand dollars (\$17,000) will be on the agenda for the next meeting. Unless Council de-appropriates that seventeen thousand dollars (\$17,000), the report to the County will indicate that those funds were expended and that they are planning on ending the year in a deficit in which they are not because they have already corrected it on their end, but Council needs to correct it on their end as a formality and then he can report things properly and keep the City from getting cited which is the worst thing that could happen in this situation.

Councilman Russel confirmed that the de-appropriation legislation has been requested.

President of Council Monday noted that there is a public hearing scheduled for this on July 16, 2019 at 6:50pm. Filed.
