## **ORAL COMMUNICATIONS:**

#### Darwin Dunten - flooding on Rector Avenue and Dalzel Ditch

Mr. Dunten has been the pastor of the First United Brethren Church on Rector Avenue for thirteen and a half (13 ½) years. He came before City Council to address some issues in his neighborhood about flooding. His neighborhood has experienced more and more flooding as the years go by. They have had to pump the basement of the church out ten (10) times, three (3) of those were in the last year (July 8, July 9, December 22). They had to pump the basement out at 2:00am on December 22, 2013 for their Christmas service later that morning. The frequency of this problem has been happening more and more to not only the church, but to the entire neighborhood of Rector, Madison, and Clifton. None of those areas are close to the river, but are close to the Dalzel Ditch. He met with former Councilmember Deb Seng when she was on City Council and has met with the City Engineer who both continue to point the finger at the ditch. For the first five (5) years that he was pastor of the church, they did not experience any flooding. The frequencies of flooding started when the separation of the sewer and water runoff was done which he believes was in 2005. The first rain following that was a major flood in the neighborhood. They are seeing more and more frequencies of it. It is coming from different areas. The first couple of floods came through the sewer system in which the church fixed that problem. Now it is coming through the walls of the basement. They have put pumps, drainage and a cistern in. There is nothing else they can do except wait for the ditch to be fixed which is something he believes the City is considering. He encouraged Council to get the ditch cleaned out. His church has spent tens of thousands of dollars that they have not been reimbursed for on repairs and to try to stop what is happening. They received at least six inches (6") of water in their parking lot from the last flood on December 22, 2013. Their parking lot is flat. It was coming from the Bolton and Rector area. Whenever there is a major rain, this area is shut off by high water. He did not see this happening until the separation of the water and sewer. He again encouraged Council to clean the ditch out. Cleaning the ditch has been in discussion since he came here thirteen and a half (13 1/2) years ago. When the first major flood happened, clean up of the ditch was in discussion. When the 2007 flood happened, Council was talking about the Blanchard River and the ditch clean up was also in discussion at that time. It was also in discussion in July and December last year. Home values in the neighborhood are going down. Residents cannot use their basements anymore. They were using them as family areas, but can no longer use them. On behalf of his neighborhood, the area he serves, and his church, he asked Council to do something.

#### Discussion:

Councilman Monday asked if there is any way to give the residents in that area any reasonable assurance that the ditch is going to be cleaned in the near future. It was a project that was almost there when property owners were going to be assessed. He attended a meeting at the Blanchard Valley School where the County Commissioners received a lot of resistance. For some reason, the project was stopped. The project was talked about often, but nothing happened. He feels it is time to have something done and work with the County to give the residents reasonable assurance that something is going to be done. Service-Safety Director Paul Schmelzer replied that he spoke with Mr. Wilson today and asked him how soon he could have the applications ready if the capital plan is approved to which he replied next week. We are positioned to get this project underway. The plans were done previously but need to be updated which requires them to be reviewed by the County, then it has to be decided what level, if at all, Council is going to fund the project, then it is turned over to the County to be done. The project is ninety percent (90%) of the way there.

Councilman Russel added that once this goes to the County Commissioners, there will be another hearing. Jill Schroeder from that neighborhood came before City Council last June or July about this. When this comes to the County Commissioners, it will be encumbering on you and the neighbors and those affected in there to make your voices heard to the County Commissioners. He has talked to the Commissioners about it and they know the petition is coming. They look upon it favorably, but have a lot of things they have to do to make a decision. Making your voices heard to the County Commissioners helps them hear your view. He encourages everyone to continue voicing their concerns to them.

Emerson Focht - riparian buffer on Lye Creek

Mr. Focht and his wife have lived in Findiay at the same location since 1972. The first flood they dealt with was in 1981. It has since gotten worse. He is unsure what is causing it. He was asked to come before City Council to speak on behalf of his neighborhood. The riparian buffer will add more trees and shrubs, and the grass will get tall between the creeks. He attended the public meeting about it where the Service-Safety Director was in attendance. He voiced his opinion about only wanting to do half of it and then taking a look at it, but has since changed his mind after reviewing some information that shows what the plans are. There are woods on Sandusky Street just across the bridge over Lye Creek where deer come out of. He has had several run out in front of him. He fears this riparian will bring in a lot of wild animals. Coyotes will come after the deer. If the grass gets as tall as they were told it will get, he is concerned what that will do to the soil. They have lost thirteen (13) neighbors since they have lived there because their homes were destroyed. There were forty-one (41) homes contacted in his neighborhood about the proposed riparian. Some were not home and some did not want to sign anything. There were twenty-one (21) people who voted against the riparian. If funds have not been received yet, he proposes not using the funds for this and using it elsewhere. He prefers to leave his neighborhood alone as there will be setbacks that need to be mowed. When they come to mow across the street in the empty lots, the area is rough, but they get through it. It doesn't take them very long to mow it. He does not feel the riparian will eliminate any costs. There are a lot of kids that play in that area in the summertime. They would not be able to if the trees are planted. If you drive on Main Cross and look to the right on Blanchard Street you will see the woods. There is a lot of junk that has accumulated there since he has lived here. He does not see how the proposed riparian plans will make an improv

Discussion:

Councilman Douglas was contacted by multiple residents asking questions about the City gym. He then asked what liability the City has if someone were to get hurt while using the City gym. He asked if the City has a blanket policy that covers it. Law Director Rasmussen replied the City probably does not have liability under the revised tort reform legislation and the recreational users statute for subdivisions, also under recreational users. The City can be sued. He will develop a waiver to further immunize the City. New individuals asking to use the gym will have to sign the waiver before they can use the gym. An update to their cards to gain access to the gym is required. He will provide the waiver to the Police Department, so whenever someone requests access to the gym, they will sign the waiver then. Those already utilizing the gym will also have to sign a waiver.
