### Discussion:

Councilman Monday noted that the three (3) liquor permit requests tonight are all new requests, not transfers. Approximately three (3) or four (4) years ago, the former Law Director stated that there is a quota of allowed liquor permits per county and that Hancock County had reached their quota. He asked how new requests come about if we have already reached our quota. Law Director Rasmussen replied that the quotas are per type of license. It does seem like Council has had a lot of liquor license requests come through, but he is unsure if the quota is still followed or not.

### N.E.A.T. Departmental Activity Report - May 2014.

#### Discussion:

Councilwoman Spence noted that at one point, the possibility of adding employees to the N.E.A.T. Department was discussed. As this report states, during the month of May, there was a substantial amount of calls for the N.E.A.T. Department to go to. She asked if those discussions are still going on. Service-Safety Director Schmelzer replied that he does not have any plans at this point to add staff to that department this year. The possibility of adding staff can be discussed with the next budget year. He realizes that the only employee in that department is extremely busy, especially this time of year following winter. Phone calls do increase this time of year. It is his hopes that compliance with the properties will increase as the year goes on. Councilman Klein is proactively looking at what that department should be doing from a code enforcement standpoint. He anticipates some additional discussions on it, but does not have any plans to add staff right now.

Councilman Russel noted that a fews ago, he, Councilman Klein, and the Zoning Administrator discussed ways to enhance enforcement policies and work in a more efficient manner. It is still an ongoing discussion. The need is there and they are still working through their ideas to come up with the best solution. Filed.

## Service-Safety Director Paul Schmelzer - I-75 Sanitary Sewer Relocation, Project No. 35649300

The Ohio Department of Transportation (ODOT) has nearly completed the design plans for the widening of I-75 through Findiay. One element of the plan calls for the abandonment of a twenty-four inch (24") sanitary sewer that parallels the roadway south of West Sandusky Street to Harrison Street. Currently, there are two (2) businesses still connected to this sewer (Michigan Sugar and Daskto Ltd.). In order to abandon the twenty-four inch (24") sewer, it will be necessary to construct new sewer connections for these businesses. ODOT will reimburse the City for the cost of these new connections after the work has been completed.

In order to move forward with the project, it is necessary to have authorization for bidding and contracting and appropriating design funds as follows:

## City Auditor Jim Staschiak - Revenue Estimates for fiscal year 2015

Ohio clearly defines a budgetary process which includes the requirement that municipalities prepare an annual tax budget by July 20. The County Budget Commission has not required the filing of a complete tax budget for many years and requires the City of Findlay only provide the attached Estimated Revenues for submission to the Budget Commission for the next fiscal year. No action will be required at this meeting. In order to meet the statutory requirements for the distribution of the local government money, this document should be formally accepted by Council at the July 15, 2014 meeting so it can then be filed with the County Auditor by no later than July 20. A motion for acceptance of the revenue estimates will be needed during the meeting on July 15. The Council Clerk is asked to schedule a public hearing before that meeting, notice of which must be published ten (10) days before the hearing.

### Discussion

Councilman Douglas asked if a date has been set to meet on this. City Auditor Staschiak replied that the Budget Commission will send him a notice. Once he receives it, he will give it to the Council Clerk for distribution to Councilmembers. Budget Commission consists of the County Auditor, County Treasurer, and the County Prosecutor, and there typically is a County Commissioner present. They ask some interesting questions (i.e. have you considered this, do you know where these monies/local government funds are going, etc.). They have input on local government funds around the County. Filed.

### Parks and Recreation Board minutes - June 16, 2014.

### Discussion:

Councilman Russel noted that these minutes mention safety concerns at Eagle Creek Skate Park and asked if any records are kept on the usage of the park. Service-Safety Director Schmelzer replied that there are no usage records, but does have some concerns about its condition and would like to look at it as part of next year's capital plan to make an investment there or somewhere else. He is looking into a possible alternate location for the skate park and/or repairs made to the existing location. It will be discussed during a Parks and Recreation Board meeting. Councilman Russel asked if there could be a liability if someone were to get injured due to the park not being properly maintained. Law Director Rasmussen replied that it would not be a liability issue, but could end up being a lawsuit issue. Recreational user statute would most likely deny a claim, but someone could always file a claim which would be an action filed. Councilman Russel then noted that he has not been by the skate park recently, but the last time he went by it, it was getting run down. He asked if shutting it down might be an option if there is a safety concern.

Councilman Nichols noted that at the last Parks and Recreation Board meeting, the Street Department Supervisor commented about relocating the skate park to Riverside Park where his department could build a ramp out of concrete in which they would provide the labor to do so. It wasn't an official meeting, so he is unaware if anything has been planned. The condition of the existing skate park is very poor, dangerous to use, and there is a lot of vandalism and problems with that location.

Councilwoman Spence is in favor of allowing the Lowe's Heroes Program to be used for the miracle field as they suggested. It is her hopes that the Parks and Recreation Board can partner up with them as it would be a great usage of their program. Filed.

## Service-Safety Director Paul Schmelzer - CUBE evaporative condenser

As part of the 2014 Capital Improvements Plan, an amount of fifty thousand dollars (\$50,000.00) was appropriated into the Recreation Functions operating budget for replacement of evaporative condenser at The CUBE. Upon further examination, it may be prudent to install a larger unit than currently exists in which a consultant will be hired to help make this determination, and then this will be put out to bid. In order to cover consulting fees with the previously appropriated monies, a project will be created. If a larger unit is required, the cost and any additional allocation will be examined at an Appropriations Committee meeting. Legislation to transfer appropriated funds is requested.

Councilwoman Frische asked if the new slide at the pool at Riverside will be ready for this coming Friday for the holiday. Service-Safety Director Schmelzer replied it will not be in for this coming holiday. He is waiting on Wood County and the State Board of Health to do their inspections. The inspection will take less than an hour. The holdup is getting them here. Wood County is accommodating, but are about a week or more out with the State Board of Health.

Councilwoman Frische asked for an update on the jail fees. Law Director Rasmussen replied that it went back and forth this past week between the County Prosecutor's Office, his office, and Municipal Court Judge Starn. He talked with Mark Miller about it today. The first paragraph of the contract is what was causing the most problems, but is now worked out. As of the end of today, he does not have the final version of the contract, but anticipates having it tomorrow. A hearing notice has been put together for consideration this Thursday.

Councilman Nichols asked the Law Director to provide the Freedom of Information materials to Councilmembers. The committee is anxious to get it out of the way. Law Director Rasmussen replied he does not have everything he requested, but will provide what he has, or if Councilmembers prefer, he can provide everything all at once, once he has everything. Councilman Nichols replied they would like whatever he has now so that they can get start looking at it.

### **NEW BUSINESS:**

Councilman Shindlecker has attended some baseball games at Emory Adams Park this past weekend. Some of the trash containers were overflowing. He noticed the CUBE has special containers for recycling and asked if Emory Adams Park could also have them.
