# Findlay Fire Department Chief Eberle – Firefighter Exposure to Environmental Elements Grant (FEEEG) Project No. 31994800

On November 5, 2019, City Council authorized Safety Director Schmelzer to submit a grant application to the Ohio Bureau of Workers' Compensation via Ordinance No. 2019-095. Below is a synopsis of the minutes from that City Council meeting:

City Council previously authorized under Ordinance No. 2017-121, the expenditure of \$10,092.50 of an awarded \$15,000.00 Ohio BWC Firefighter Exposure to Environmental Elements Grant to purchase particulate blocking firefighter hoods. The Findlay Fire Department has \$4,907.50 remaining and is now requesting permission to submit an application to utilize \$4,023.75 of that remaining balance to purchase a turnout gear washer/extractor. The local match required is \$804.75, which will be taken from the existing Fire Department budget.

The Bureau of Workers' Compensation (BWC) uses the Firefighter Exposure to Environmental Elements Grant (FEEEG) Program to partner with Ohio employers to minimize exposure to dangerous environmental elements.

Legislation authorizing the Safety Director to apply for said grant funds is requested. Ordinance No. 2019-095 was created.

#### **CPC STAFF**

#### **General Information**

This request is located on the south side of Birchaven Lane. It is currently zoned C-1 Local Commercial. Land to the west is zoned M-2 Multiple Family. To the east and south is zoned C-1 Local Commercial. To the north is zoned O-1 Institutions and Offices. It is not located within the 100-year flood plain. The City of Findlay Land Use Map designates the area as Planned Mixed Use Development (PMUD).

#### **Parcel History**

This site is currently vacant.

#### **Staff Analysis**

In 2009, the west portion of this lot containing 8.893 acres was rezoned to C-Residential. This converted to the M-2 Multiple Family district when the zoning code rewrite was adopted in 2012. An additional portion was rezoned to M-2 in December 2018.

At this time, the applicants wish to rezone an additional 10.141 acres to that Multi-Family area.

#### **Staff Recommendation**

CPC Staff recommends that FCPC recommend approval to Findlay City Council APPLICATION FOR ZONING AMENDMENT #ZA-10-2019 filed by Blanchard Valley Health Association, 15100 Birchaven Lane, Findlay to rezone a portion of Lot 2 in Eastern Woods Subdivision from C-1 Local Commercial to M2 Multiple Family High Density.

Todd Jenkins stated that last December BVHA had requested to rezone another portion of this lot for the purpose of developing senior housing. This new proposal will be for a second phase of that future development. They want to reserve some commercial land along the Eastern Woods Parkway frontage so they left a strip 150 feet deep there as C-1 Local Commercial. Dan Clinger questioned if that area to remain C-1 is deep enough to develop. Mr. Jenkins replied that it will be small commercial and probably more office type development.

2. APPLICATION FOR CONDITIONAL USE #CU-03-2019 filed by Movement Church Findlay, 112 E. Front Street, Findlay to operate a church at 200 S. Main Street, Findlay.

#### **CPC STAFF**

#### **General Information**

This site is located on the southwest corner of W. Front Street and Main Street in downtown Findlay. It is zoned C-3 Downtown Commercial and is completely surrounded by C-3. It is located within the 100-year flood plain. The City of Findlay Land Use Map designates the area as General Commercial.

#### **Parcel History**

The parcel has been the site of Ace Hardware since 1994.

#### **Staff Analysis**

The applicant is proposing to operate a church at this location. Currently, the applicant operates their church services out of Glenwood Middle School and are looking for a permanent location. They also have a downtown office across the street at 112 W. Front Street. There is a purchase agreement in place with the current owner, contingent on receiving a conditional use permit.

According to the Auditor's website, the building is 7500 square feet. There is currently a parking lot that can accommodate approximately 12 cars. While the C-3 Downtown Commercial district does not have any parking requirements, the applicant has acknowledged there may some barriers with parking on Sundays, but are working to create an effective plan to address those concerns.

In the northeast corner of the parcel, is a pylon sign. Staff recommends this pylon sign be removed and replaced with signage that fits the downtown standards.

#### **Staff Recommendation**

CPC Staff recommends approval of APPLICATION FOR CONDITIONAL USE #CU-03-2019 filed by Movement Church Findlay, 112 E. Front Street, Findlay to operate a church at 200 S. Main Street, Findlay subject to the following conditions:

- Removal of the pylon sign

#### **DISCUSSION**

Dan Clinger commented that he doesn't foresee any issues with Sunday parking but wondered what they would do for week day activities. Eric Ferguson stated that there are about 225 spots in the proximity of their building. Because they are tenants in the building on Front Street, they have a verbal agreement on using about 50 of those parking spaces as needed. He stated that right now they may have 75 to 100 cars at any one time for events. Their primary spots would be on the site and across the street by their offices. They can spill into other areas as needed.

Christina Muryn commented that she thought it is great that they have the opportunity to use that space. Mr. Clinger asked if the shared parking plan would be submitted to zoning prior to getting their permits. Judy Scrimshaw reminded the committee that the district does not have any parking requirements, so we can't really hold them to any plan. They were kind enough to show a map with area lots that can be used by their congregation as needed. Mr. Ferguson replied that they certainly want to be good neighbors and if there are concerns brought forward they will address them.

#### **CPC STAFF**

#### **General Information**

This request is located to the south of Hunter's Creek subdivision, and to the east of Homestead Drive. It is zoned R-1 Single-Family Low Density Residential. It is surrounded by R-1 to the north, west and south. The Findlay Land Use Plan designates this area as Single Family, Medium Lot. A portion of the proposed development is located within Marion Township.

#### **Parcel History**

The site is currently vacant.

#### **Staff Analysis**

The applicant is proposing one hundred twenty (120) single-family lots on the 12<sup>th</sup>, 13<sup>th</sup>, 14<sup>th</sup>, and 15<sup>th</sup> additions of Hunter's Creek Subdivision. The City and Marion Township boundary line bisects lots 425, 426, 427, and 447. Lots 397, 399, 409, 411, 412, 425, 446, 447, 462, 463, 465, and 465 do not meet the R-1 standard for frontage. Staff would like to see a revision so that all lots meet the R-1 standard.

This proposed addition will bring a street connection between Fox Hound Drive and Country Creek Drive. There will be temporary turnarounds at the ends of Browning Drive and Springfield Drive to avoid stub dead ends.

Staff would like more information regarding how the developer will work to develop the portion of the site within the 100-year floodplain.

This Preliminary Plat will be on the HRPC agenda this month for review.

#### **DISCUSSION**

Dan Stone noted that they were forwarded many emails in regard to concerns of the existing neighbors in Hunters Creek and Hunters Ridge subdivision. Mr. Stone asked if the Commission wanted him to discuss this first or address comments from the audience present. Ms. Muryn said she thought he could address the comments he had received.

Matt Cordonnier asked if he could give a brief overview of the process. Mr. Cordonnier stated that the Preliminary Plat is required when a developer wishes to divide 5 or more lots of 5 acres or less, dedicate right-of-way for public streets, and construct infrastructure to serve that area such as water and sewer. The City looks at things like street layout, where utilities will lie and the size of the lots in conformance with zoning. After that is reviewed they submit construction drawings. Those include cross sections of the road construction, installations plans of water and sewer lines and this is when drainage calculations are also submitted. This is when the Engineers will have to certify to the City that the ponds and drainage meet City standards. The storage capacity was increased after the 2007 floods in the City's regulations. With an approval or denial of a Preliminary Plat, there are not legal rights to create lots, sell lots or begin any of the construction. This Plat is essentially an overview of what is planned. If they get approval, then the move to designing for construction. If done in phases, a Final Plat will then be submitted for the first phase. If that Final Plat is approved, then the lots can be created and sold. This particular plan is partially in the County and will thus be going through the same process again with Regional Planning and the County Engineer. The applicant stated that they will start the annexation process soon. Dan DeArment asked if the annexation would have to be completed prior to the Final Plat. Cordonnier said he anticipates that if this moves forward, the developer will Final Plat the 12<sup>th</sup> and 13th additions first while the process is going on and will not get to the two phases that are currently outside the corporation until the annexation process is complete. Dan Stone clarified that phase 12 is currently all inside the City and that 13 is also inside.

Mr. Stone proceeded to comment on areas of concern from emails that were received in regard to drainage and ponds. He stated that the intent is to have the entire new development drain into the new pond to the south. Mr. Stone commented that the original Hunter's Creek and Hunter's Ridge developments were done prior to the amendments to the Subdivision Regulations. The City and County both increased their detention requirements after the 2007 flood to take a 100 year storm that releases at a pre development rate of the farm field. He stated that he thinks most of Hunter's Creek was designed for a 25 year storm. The City worked in 2008 on getting new piping to help drain the existing ponds to get to Lye Creek. With the new pipes and control valves the City has the ability to let the water out quicker. During the floods, the biggest problem was that the water couldn't get out.

Dan Stone stated that knowing the sensitivity in the area with the newer development, they want to take the new area to the proposed pond at the south end. They will have to take into consideration an existing raw water line that traverses the property and how they can cross that. The rear yards of some of the lots abutting the north pond may drain there because of how homes may be built up, but everything else would go south. There's the existing flood route swale that when the pond over tops takes it Lye Creek will remain. An audience member asked if it would be a dry pond. Mr. Stone replied that it will be a wet pond similar to what they have but about twice the size. The pond area will be part of the flood mitigation and will go through FEMA. The swale will remain, there will be the new pond which will be built to satisfy the storm water drainage, the EPA water quality standards, sediment and erosion control as well as flood mitigation.

Christina Muryn asked Mr. Stone if there is any benefit or help this will provide to the existing neighborhood. Mr. Stone replied that there is currently part of the land here that does drain into the existing pond and some may drain back into some existing yards. A lot of the flood waters that enter the development, come across CR 180, through the field and in. Some will still do so, migrating in a southwest direction. The new drainage should help pick it up and move it to the new pond. The existing pond was developed for that development only, so they are not planning to push any water there. They hope to intercept some of those flood waters and put in their pond now.

Dan DeArment asked if the new pond is designed for this development and all the way over to CR 180. Dan Stone explained that they have to design the pond for whatever drains there today. Everything comes down to Lye Creek. If the land to the east ever does develop, they will have to put in their own ponds. Ohio EPA dictates a lot about how things are developed with their sediment and erosion control standards. Any time you disturb over an acre, you must put in sediment basins. Dan stated that they will look at what water comes their way and make provisions for that.

Dan Clinger asked if when they redid the one pond they weren't metering it out as slow. Dan Stone replied that the City has two valves that they use to allow the water from the development to release. The City controls it. If the water is backed up in the streets and such, the City can open them and let the water out quicker. Mr. Clinger asked if the ponds are connected. Mr. Stone replied yes and pointed out the three ponds and how they flow into one another. Dan replied that his goal is to not take any water to the existing pond if they can get through the waterline easement.

Mr. Clinger asked if it would make sense to have a drainage swale that picks up the farmland drainage if it in fact does come over there. Obviously, if you have a 4" per hour rain it is going to run off much faster than only a ½". Mr. Stone replied that there is a good chance they will put an off-site bypass somewhere. They haven't done a detailed contour survey yet. They have LIDAR contours. Dan Clinger said it bothered him the most that the west side had much of the lots in flood plain. He would prefer that area be set aside as greenspace or something. Dan Stone replied that they have some land farther east that would give them the ability to move things over and avoid that area. That would open up a buffer area and minimize any impact on the flood areas.

Dan Clinger asked that since the history of flooding is in this area, would it be desirable to even build that pond to handle more than the 100 year flood. Dan Stone replied that it actually will be because of the EPA requirements to put the water quality storage in it as well. This normally adds about another 25% of volume to a pond. Mr. Clinger asked if since the pond is in a flood plain, will it be inundated already. Mr. Stone replied that they can look at one of two ways. They could bring the berm of it up high enough that it does not or they can put tail water impacts on it and see how it impacts the rest of the development. The higher they take the berm, the more flood plain mitigation they have to do. That would have to be looked at in the design.

Dan DeArment asked if the ponds could be bypassed instead of feeding into each other. Mr. Stone replied that since it is already developed you cannot. It would entail tearing up roads, requiring easements from owners. Ponds running in sequence is pretty normal in development. If it's calculated properly, you run tail water impacts, it stacks up and it functions properly. Matt Cordonnier pointed to Lakeview pond which flows into the Winterwoods pond and down to the creek. So putting these in series is very common.

Dan Clinger asked what size piping was put in with the valves. Brian Thomas stated that it is either two 36" or two 48" pipes. Mr. Thomas stated that they are manually operated valves. Mr. Stone said he believes they are locked so they can't be tampered with. Ms. Muryn said it has to do with the levels in Lye Creek. The City may need to close them in order to avoid Lye Creek backing up and causing additional flooding. You'll get the initial water increase in the roadways, then once the Creek levels drop they can be opened up again. Ms. Muryn commented that with the other flood mitigation efforts that are in progress it should help with the Lye Creek backups.

Dan Stone stated that the other comment from emails was in regard to traffic. When Hunter's Ridge was initially designed, it came through Planning Commission. The Commission wanted a second access in and out. They looked at extending Lippincott out but it was too close to the bridge and had visibility issues. They required the stub into the vacant ground to the east in order to someday get that connection to another development. With the expansion of Hunter's Creek the roads will connect through and satisfy that initial requirement.

Dan Clinger commented that there is also a stub street going out east from the existing Hunter's Creek. He said you could potentially see that whole corner developing. Mr. Stone said when the area was looked at there was always discussion of taking the roadway out to CR 180. They do not control those properties to the east and cannot dictate what happens there other than to provide the means to connect at some date. But they have no idea when and how that will eventually all work out.

Brian Thomas noted that the County has bid out a project to add some additional drainage to try and get some of the water that comes across more access to get up to the river. That should help with some of the water coming across the field also. Dan Stone explained that in significant rain events, the roadside ditch becomes plugged with corn fodder and such so the catch basins no longer can function. The water overtops CR 180, goes west into the development. There were a lot of old storms and field tiles here. They have tried to cap those. They are in the process of adding a larger storm sewer going to the river to prevent the flood waters from crossing 180 and getting into the development.

Jeff Harper, 1473 Timberwood Drive, came forward to address the Commission. He lives along the one pond. An extension was built on the pond when Hunters Ridge was developed. He stated that this hasn't been successful. What will be done differently this time? A tile had collapsed between the ponds and the City, at great expense, replaced them in the last couple years. That pond flows without check into their pond. The owners on the pond paid for the flood gates with their taxes, and they are designed to stop the water in their pond from going into Lye Creek when it is high as was mentioned. The pond is already at capacity. It rises significantly into yards and streets flood. Mr. Harper stated they are concerned that any additional water whether form the east, west, etc. will create flooding to houses that have not flooded before. He said one possible suggestion is to take five lots (which he pointed to) and develop an extension of the pond there and eliminate building five homes.

Mr. Harper stated that the traffic pattern is a problem. Hunter's Ridge is a giant flag lot with only one way in and out. There is potential for 120 homes if all the additions are done. That is a bare minimum of 120 cars, but most homes have at least two cars so more likely 240 to 300 cars travelling either out to Sandusky or out to Fishlock. The traffic is awful around 5:00 on Sandusky and a traffic light will not solve it. If this is done right, they must consider going out to County Rd. 180. Dan DeArment asked why he thought a traffic light would not help at Fishlock and Sandusky. Mr. Harper said it may help get cars in and out, but doesn't help with the fact that there are 120+ more cars trying to get in and out of the same two lane street. Mr. Harper noted that the streets were designed to flood and when they do they strand people in Hunter's Ridge and also Hunter's Creek.

Mr. Harper commented that the pond they are proposing could be substantially increased in size. He summarized his comments: Remove 5 properties from the plan and increase the size of the pond, double the size of the new pond and consider an extension of road out to CR 180. Dan DeArment asked Mr. Stone to comment on the pipes Mr. Harper mentioned going north into his pond. Mr. Stone replied that he knows there are pipes that come out of it, but doesn't know if they're field tile. Mr. Harper said they are green PVC. Mr. Stone said he thinks perhaps when they created that pond they encountered some old field tiles they had allowed them to go through the pond. Mr. Stone said that during their construction, that old tiles will be taken out of service and tied into their sewer system.

Dan Clinger asked about the street flooding. Dan Stone replied that he cannot address how that was designed. Mr. Harper said they need to provide the access out to CR 180 to allow the residents to perhaps have a way out. Mr. Stone replied that they don't control that land and therefore cannot do anything if the owners don't wish to do so. Mr. Harper replied than maybe they shouldn't consider any new development until they can.

Mark Roynon, Timberwood Drive, said that that are 300+ homes in Hunter's Creek and many in Hunter's Ridge, and this proposes possibly 120 more. So roughly 600 houses go through the subdivisions. You can't go out to Fishlock if it is flooded. You can't go out Sandusky if it's flooded. There's no way out. This has to be addressed. You can't keep 600 people in a subdivision for three days until someone from the City or County deems it acceptable to open the flood gates.

Stephen Gons, 1127 Homestead Drive asked who owns the property directly east of this. Jim Koehler said it is owned by Riegels. He said he thought it was all Bishop Farms.

Mr. Gons stated that most of the neighbors he shared a copy of the plan with had the same concerns of traffic and flooding. He stated they have lived there since mid-2016 and have experienced significant flooding where they have been trapped in. He has spoken with multiple people in Hunter's Ridge and Hunter's Creek that have had sporadic flooding where it hasn't flooded before. When the bodies of water, river, creeks, fill up the water has nowhere to go. He knows these developers have many areas in town they build, but why is this a first choice to develop here with all the issues there have been. There are probably better options in the area. Mr. Gons said they have been finishing off their basement and now with this plan he is concerned that it may cause problems that they were not anticipating. He said he hopes they will take their concerns seriously and that they can get some answers and some sureties before this will move ahead.

Dan Clinger asked about detention that was done at the Fairgrounds. He inquired if it caused any more back up at Lye Creek. Mr. Stone said no. Dan DeArment asked if there were a possibility of creating an access to the south out to Blanchard Avenue. Mr. Stone replied that it's not likely. There would have to be a bridge to cross the creek that would cost at least \$500,000. The developer only owns so far. Dan Clinger said that maybe access could be onto Strong Avenue. Mr. Stone replied that parts of that are vacated and there isn't enough right-of-way there to make a proper street. It could be a bridge to nowhere if they can't control access through the property along Blanchard which his client doesn't own either. The developer's hands are tied. As a private developer, he can't go through other privately owned property. The City may have mechanisms to allow them to acquire right-of-way, but we cannot. We can ask, but if the owner says no, there is nothing they can do.

Mayor Muryn asked if there have been conversations with those property owners. Mr. Koehler stated that he has spoken with the Rigel's in the past and they are not willing to sell or develop. He says he thinks some day they may just turn it into a piece of ground that is not developable. Mr. Koehler said he wants to make it a nice area. If things go well he might want to go further, but development is not easy. It's a gamble to do the first phase alone.

Jeff Fenimore, 1011 Country Creek, stated that the farm field has been flooding differently in the last few years. He and a neighbor now get water in the back yard and they never did before. They were told the streets were designed to flood and he assumed it was from the storm sewer. Are they saying that any storm sewers in the new development would not be connected with theirs and would all run south and not north? Mr. Stone said the land naturally drains in the south direction. It will drain into the detention facility, and then to Lye Creek. Mr. Fenimore said he understands that the problems in Hunter's Creek were never solved, they just made it so the streets flood and put in the gates to let it out. Mr. Fenimore questioned how putting the new development water out to Lye Creek can't affect the issues in Hunter's Creek. If they are putting more water in the Creek how will it go down to allow for the opening of the flood gates. Dan Stone replied that with the design of the detention facilities, the release rate has to be the same as pre-development conditions. Mr. Fenimore said he lives at the end of Country Creek and the water flows through the small woods, through his street and down. Mr. Stone replied that their goal is to take as much water as possible down to their pond. They are trying to avoid putting any additional water in the existing storm system. Mr. Fenimore said they will still get water from the east. There is water in that field now. Mr. Stone replied that the City and County are working on trying to prevent additional water east of CR 180 from coming over. They are trying to do additional piping, additional drainage along the road to keep this from happening.

Dan Clinger asked that if the existing pond was expanded, would it help alleviate the flooding of the streets. Mr. Stone stated that he had not analyzed that. If you add more capacity to a pond, it should take away some of the pressure on the streets but, if there is a storm like in 2007, it will help for a few hours, but once the pond fills up it can't. When the water was coming from the Kenton area and hitting the smaller creeks and they each over top the other, nothing was moving. The Eagle Creek basin is intended to take some of that pressure. Eagle Creek will act on its own and not take on the water from the others. It's a complex situation. They are taking good steps to try to protect downtown. Mr. Fenimore replied that it would be nice to see these other things in place and see if they work before they go ahead and build in a flood zone.

Ed Lentz thanked the Commission for taking the time to hear the neighbors' concerns. He stated that he has lived in Hunters Creek since 1997 at the corner of Misty Oaks and Country Creek. He said that whatever goes on downstream, has ripple effects upstream. He stated that the pond was not made to handle all that it does. He blames no one, it's designed for what they knew at the time. Anything done downstream that is going to help that situation will help the whole subdivision. He said this is the first year that he has had water in his backyard the whole winter. He knows they had a lot of rain. Things were so saturated and the pond was so high there, but obviously the gates weren't open and their backyards were flooded all winter long. Anything that can be done to relieve the pressure in the upper pond is going to help a great deal. He said that a berm in to keep the water from the farm field entering will only eventually push that water up to Cranberry. Mr. Stone said they are not putting a berm in to deflect water. They cannot do anything that might push water onto someone else's property. He was only talking about an area around the pond to keep flood water out. Mr. Stone said they plan to try to intercept that water from the east and send it to their system.

Total precipitation recorded at the City of Findlay Water Pollution Control Center was 6.18 inches of rain and 6.5 inches of snow for the fourth quarter (Oct-Dec) of 2019.

At the end of December, the Findlay reservoirs stood at 82% of capacity. This reservoir level represents an 855 day water supply at the city's current usage rate.

The City of Findlay Water Treatment Plant treated 565.08 million gallons of water in the fourth quarter of 2019. That is an average of 6.14 million gallons per day.

SECTION 1: The internet auction of property which is not needed for public use, or is obsolete or unfit for the use for which it was acquired will be conducted in accordance with the policy and procedures established for such online internet auctions as set forth in in "Exhibit A" as amended from time to time, a copy of which is attached hereto and incorporated herein as if fully rewritten herein.

SECTION 2: All items offered for sale through online internet auction shall be offered for sale for a period of time to be determined by the administration but which period shall be not less than ten (10) days, including Saturdays, Sundays and all legal holidays.

SECTION 3: The City of Findlay will contract with a representative(s) to conduct the auction, however the general terms and conditions of sale shall be established by the city. The administration, in consultation with the auditor, shall determine and select authorized representatives to conduct the online internet auctions which representatives may change from time to time.


SECTION 4: The Clerk of Council is directed to publish, in a newspaper of general circulation in the municipal corporation or as provided in section 7.16 of the Revised Code, notice of the City of Findlay's intent to sell unneeded, obsolete, or unfit municipal personal property by internet auction all in accordance with R.C. 721.15(D).

SECTION 5: Notice of the City of Findlay's intent to sell unneeded, obsolete, or unfit municipal personal property by internet auction shall be posted continually throughout the calendar year in a conspicuous place in the office of the city auditor, in the office of the mayor and on the city web site.

SECTION 6: The City of Findlay retains the right to establish a minimum price and may establish other terms and conditions of any particular sale, including requirements for pick-up or delivery, method of payment, and sales tax. Such information shall be provided on the internet at the time of the auction and may be provided before that time upon request after the terms and conditions have been determined by the legislative authority.

WHEREFORE, this Resolution shall take effect and be in force from and after its passage and approval by the Mayor.

### Procedures for Online Internet Auctions (R.C.721.15(D))

The Auditor's Office will receive a request from the City department who wishes to auction an item which is not needed for public use, or is obsolete or unfit for the use for which it was acquired. Items must have already been offered to other departments via e-mail.

The Auditor's Office selects the proper form i.e. vehicle inspection forms, office equipment inspection forms, etc. for the department to complete for the specific item of personal property. Forms are completed by the department so that all pertinent information regarding the item is known and given to the Auditor's Office along with pictures of the item, the minimum bid for the item and a reserve or minimum price, if so desired.

The Auditor's Office will prepare a draft auction write-up of the item based on the information given and release it to the department for review. Any corrections that should be made are noted. The department supervisor then signs the draft auction write-up thus giving his/her approval. The write-up is then forwarded to the Service Director or Safety Director for their approval to sell the asset via online internet auction.

Once the draft auction write-up is received back by the Auditor's Office with the two required signatures, any noted changes are made and the auction is released on the online internet auction site for a minimum period of 10 days. There is a link on the City's website that will bring up anything that the City of Findlay is currently offering at auction on the online internet auction sites. Otherwise, any person can search by entity (City of Findlay) and see what is currently offered.

When the auction ends the Auditor's office receives an e-mail notification from the online internet auction provider indicating whether or not the asset sold. If sold, the e-mail will include the selling price and the name and contact information for the seller. This e-mail is forwarded to the department supervisor.

Another e-mail is received once the online internet auction site receives payment for the item. All payments are to be made directly to the online internet auction provider. The City does not accept direct payment for auctioned items. This e-mail is forwarded to the department supervisor.

For assets other than vehicles, the buyer is to schedule pick up arrangements through the department supervisor or designee. A bill of sale is printed from the online internet auction site and sent to the department supervisor. Once buyer arrives and inspects the item, they are to sign the bill of sale and remove the Item from City property.

If the asset is a vehicle, the buyer needs to verify with the Auditor's Office the name in which they would like the vehicle titled. This information is sent to the City Clerk so that she may get the title transferred and ready for the new owner. If needed, the title information is corrected on the online internet auction provider bill of sale and the bill of sale is printed. Pick up is arranged so that the new owner first stops at the Auditor's Office to sign off on the bill of sale and pick up the transferred title. The buyer then travels to the physical location of the vehicle and removes it from City property.

Once the auction item has been removed from City property, the department notifies the Auditor's Office by sending them the signed bill of sale. Item is then marked as picked up on the online internet auction site. Routinely the online internet auction providers generate payment for items marked picked up to the Auditor's Office.

When the payment from the online internet auction provider is received, the auditor's staff breaks down the payment for accounts receivable to show the gross sale amount, the auction fee (if applicable), and the net amount received per item. A copy of the account receivable receipt is then sent to the department to notify them of payment posting.
