City Health Department Health Commissioners Stephen Mills – grant appropriations: public health emergency preparedness grant. The Findlay City Health Department has again received a notice of award from the Ohio Department of Health for grant funding for continued work to bolster public health emergency preparedness within Findlay and Hancock County. This funding will enable the Findlay City Health Department to retain Chad Master in a full-time Emergency Response Coordinator/Epidemiologist role as well as pay for MARCS radio service and pager service needed to help the Findlay City Health Department respond to disasters both natural and manmade. The approved funding level is \$80,750 for the period of July 1, 2015 through June 30, 2016.

An emergency appropriation of this grant money is requested so that activity on it may begin as soon as possible. While the Findlay city Health Department will cease to exist on January 1, 2016, they are working closely with the City and County Auditor's Offices, as well as the Ohio Department of Health to make sure the transition of these funds to the new entity is a seamless one. Ordinance No. 2015-066 was created.

#### Discussion:

Councilman Van Dyne congratulated Barb Wilhelm and the Health Department on a job well done and asked what the total dollar grant funding amount has been obtained so far this year. Mayor Mihalik replied she is unsure but knows that it is substantial. Filed.

# Service-Safety Director Paul Schmelzer - Municipal Building security

Over the past number of months, the Service-Safety Director has been reviewing information with our Building Maintenance, Computer Services, and the Police Department regarding Municipal Building security. Upgrades to this system are necessary. In lieu of waiting until next year, he would like to proceed immediately with the hardware and software updates. The 2016 Capital Plan called for an estimated \$75,000 to complete the upgrade, but believe the scope of work can be accomplished for under \$50,000. The Service-Safety Director provided information for review at the Appropriations Committee with hopes that this would be passed by City Council at the July 21, 2015 meeting. This would allow it to fit into a construction schedule and avoid months of delay. Legislation to appropriate funds is requested. Ordinance No. 2015-066 was created. Filed.

## Discussion:

Councilman Van Dyne asked if he were to vote nay on this if it will remain a tri-plex as it is now. Law Director Rasmussen replied that it can remain a tri-plex, but will be a non-conforming illegal use and will remain zoned R-2 Single Family. If the property were to be financed, the bank calls the Zoning Administrator where they will learn that it is an R-2 single-family residence. Councilman Van Dyne then asked if Council will be able to deal with that later. Law Director Rasmussen replied they can, but it would remain that way until something else is done later.

Councilman Russel noted that City Planning Commission (CPC) recommended the duplex. He asked that in order for Council to override CPC's recommendation, would it require a different minimum of votes. Law Director Rasmussen replied that to override it, it would be a threequarter (3/4) or seventy-five percent (75%) vote. Councilman Russel then asked if eight (8) votes against this would be needed in order for CPC's recommendation to hold. Law Director Rasmussen replied that is correct.

Councilwoman Frische asked if this Ordinance could be amended tonight to make it legal for a tri-plex and if it has to receive eight (8) aye votes, or does this Ordinance need to be voted down and a separate ordinance be done. Law Director Rasmussen replied that Council can move to amend. He is unsure what it would have to be, but would have to be under the new code M-1 or M-2. I would have to be at least M-1.

## Discussion:

Councilwoman Frische noted that the reason for the amendment is because the Service-Safety Director spoke with the County Commissioners who are unsure if there is a flood impact to use flood dollars, so they are going to change their funding to a 50/50 split and pull from the General Fund. The original appropriation was for the City's share to be \$10,000 and the County's to be \$5,000, but only \$7,500 is needed now.

ORDINANCE NO. 2015-058, AS AMENDED (Fire Chief severance payout)

AN ORDINANCE AUTHORIZING A SICK LEAVE SEVERANCE PAYMENT TO FORMER FIRE CHIEF LONYO.

Councilman Van Dyne moved to adopt the Ordinance, seconded by Councilman Russel.

# Discussion:

Councilwoman Frische pointed out that the documentation on record with the City Ordinance from 2013 states that retirement is defined as being eligible to immediately receive retirement benefits from its employers' pension. Based on a recommendation from the City's Law Director, Council was informed that the former Fire Chief was eligible, but the letter from the State instead stated "based on your years of service, credits you are eligible for service commuted retirement effective the date following your attainment of age 48. OP&F recommends that you file a new application about 45 days prior to your 48<sup>th</sup> birthday." The former Fire Chief is not immediately eligible. It is Council's responsibility to follow ordinances in place which states he is not eligible. If the Former Fire Chief wants to take this further, the proper steps to take would be to go through legal action. If he is awarded, more power to him, but if he is not, then the ordinance stays in place. Council's job is not to negotiate or interpret. Council's job is to follow ordinances that are in place.

Councilwoman Spence will be voting in favor of this ordinance because the City Law Director wrote a very lengthy opinion giving his reasoning. The current ordinance does not follow Ohio State Law which is a concern of hers and that an Ad Hoc Committee should address this to get this negotiated and worked out for the future so there is no additional confusion. When the former Fire Chief was promoted to be the City's Fire Chief, he could have cashed in sick pay which would have been approximately the same amount that he is requesting. Based on both of those reasons, it is reasonable to approve the ordinance.

Councilman Shindledecker is also voting in favor of this, but do not believe that he is entitled to it. As the Law Director has pointed out, there is also State Law involved. Based on the City Ordinance, he is not eligible to receive this, but we do have to follow State Law as well, so he will vote in favor of this, but hopes the Ad Hoc Committee will have an announcement about it to clear this up.

Councilman Niemeyer asked if this is sick leave, retirement, or both. Law Director Rasmussen replied sick leave at retirement. If Council desires, he can read the 4-page legal opinion again. The Constitution for the State of Ohio give us home rule power. It does not allow us to do certain things that are against general laws. Courts have ruled that this section is General Law. The definition of retirement is in that code section, so that is what retirement means until we fix it.

Councilwoman Frische further pointed out that if it was that easy of a decision to be made and was allowable, it would not have taken eight (8) months to come to a decision. Councilman Shindledecker made a good comment at the Appropriations Committee that if the Mayor and Law Director want to have a severance payout to the former Fire Chief, it might be splitting hairs, but maybe the request should be coming from the Administration and not from Council because it is not Council's job. Law Director Rasmussen replied that it is Council's job to approve the payouts and appropriations. This issue did not just drag on. There were meetings. There were several meetings with the Auditor's Office where he gave his opinion, which is what dragged on. Nothing was getting done, so he had to issue his opinion.

Councilman Van Dyne noted that it took him awhile to digest all the information on this in order to decide which direction he wanted to go. He never felt that this came to Council from the Administration. Council determines what is right and what is required by State Law which is what Council votes on, not the desire of the Mayor or Law Director on what to pay the former Fire Chief.

Councilwoman Frische noted that if the ordinance was allowable, it never would have been an issue. An ordinance would have been written where Council would have voted on it and it would have been done. There has been a lot of discussion and a lot of different angles given to get this payout to the former Fire Chief over the last eight (8) months. She has a lot of respect for the former Fire Chief, but the way he has handled himself in this matter in trying to negotiate to get what he wants is not very upstanding.

# **UNFINISHED BUSINESS**

## **OLD BUSINESS:**

Councilwoman Frische asked for clarification on the voting of Ordinance No. 2015-054. She asked if the ¾ vote was needed and if it was adopted. Law Director Rasmussen replied it was in agreement with the Regional Planning Commission, so it was majority vote of six (6) ayes and four (4) nays.

Councilwoman Spence asked if the \$7,500 needs to be approved for Ordinance No. 2015-066 in order to purchase the trees in order to get moving on the Eagle Creek tree planting. Councilman Russel replied that it is his hope that the committee report would be accepted and legislation passed so that trees could be ordered. The Ordinances that are for this are Ordinance No. 2015-065 and 2015-066. 2015-065 authorizes the Service-Safety Director to apply for the grant. 2015-066 appropriates the funds. The Service-Safety Director (not present at tonight's meeting) suggested via email that they both be addressed tonight so that the trees could be purchased. Councilman Harrington noted that the only issue with adopting Ordinance No. 2015-066 is that there are two (2) other appropriations on it. He asked if the tree appropriation should be put on a separate ordinance. Mayor Mihalik replied that the Health Department would be appreciative of adopting the ordinance now. If the Municipal Building security appropriation could be adopted now, that would be great. Councilwoman Spence moved to suspend the statutory rules and give Ordinance No. 2015-066 its second and third readings. Councilman Van Dyne. Ayes: Niemeyer, Russel, Shindledecker, Spence, Van Dyne, Frische, Harrington, Klein, Monday, Nichols. The Ordinance received its second and third. Councilman Harrington, Klein, Monday, Nichols, Niemeyer. The Ordinance was declared adopted and is recorded in Ordinance Volume VV, Page 2015-066 and is hereby made a part of the record.

Councilman Niemeyer had a local businessman contact him about wanting to lease the Hochstetler building the City owns that has been vacated approximately three (3) years. Mayor Mihalik replied that he can contact the Mayor's Office.

Councilman Nichols asked the status of the Dazel Ditch. Mayor Mihalik replied that it is in the hands of the County Commissioners currently in a planning and design stage with the hopes of being done by end of this year or beginning of 2016, depending on the EPA.
