City Auditor Jim Staschiak - Resolution accepting millage rates and amounts

The County Budget Commission has completed their work and returned our Certificate of Estimated Resources for our 2016 budget. Our tax millage has been certified exactly as submitted: 2.6 mllls for the General Fund and 0.3 mills each for Police and Fire Pension Funds to a total of 3.2 mills. Local government money is estimated to be \$429,966.86 for 2016 subject to likely adjustments by the State. Council should now accept the amounts and levy the tax rates as certified by the Budget Commission. The proper Resolution must be adopted and returned to the County Auditor no later than September 30, 2015. Legislation for this is requested and only requires one reading. Resolution No. 022-2015 was created. Filed.

Service-Safety Director Paul Schmelzer - Airport Improvements (AIP-25), Design Services for Runway 18/36 Rehab, Project No.

The Federal Aviation Administration (FAA) has awarded the City a grant in the amount of \$149,514.00 to the Findlay Airport. The grant funds along with a ten percent (10%) City match will be used for design services to prepare plans for Runway 18/36 rehabilitation. Findlay Municipal Court Director of Court Services David Beach - Indigent Drivers Alcohol Treatment Fund

The Court has encountered an unanticipated and unique expenditure which is going to surpass their regular 2015 budget amount for the Indigent Drivers Alcohol Treatment Fund (IDAT). Monies within the IDAT fund are not from the General Fund, but are collected through fines and costs process of the Court as provided by Ohio Revised Code Section 4511.19. The expenditure of the additional funds are within the parameters as set forth by ORC \$4511.19. Adequate monies to cover the additional expenditure remain within the fund, but were not requested nor budgeted within the 2015 budget cycle. Legislation to appropriate funds is requested. Mayor Mihalik was approached by the Board of Education who is interested in doing a combined resolution with Findlay City Council to oppose the Issue 3 (marijuana legalization) part of the November ballot. She asked Council what their thoughts are on this. Councilman Nichols replied that he is in favor of working with the Board of Education on this. He suggested Council pass legislation in opposition of this. Councilman Monday agreed with Councilman Nichols and noted that it takes two (2) Councilmembers to request legislation. Councilman Harrington asked if the City Health Department would also want to partner on this as they probably would have the same stance on this. Mayor Mihalik replied that the Findlay Board of Health will be looking at this issue at their next meeting.

Mayor Mihalik explained what the Workforce Coalition is. It is a group of community members mostly centered around education and business in Findlay and Hancock County. It would be good for Councilmembers to get to know what is happening with the Workforce Coalition and what their efforts are bringing about in this community relative to pre-K, 2-5 middle school, and high school education and post-secondary education so that the workforce situation can improve. If Council is interested in hearing more about this, she will ask the leaders of the Workforce Coalition to present to City Council, maybe in a Committee of the Whole meeting, to discuss what the data has shown over the last two (2) years and what the plan is in order to address the issues we are facing. Councilwoman Spence replied that she is very interested in this. Mayor Mihalik will set something up for the end of September.

Councilman Harrington made a motion to excuse the absence of Councilwoman Frische and Councilmen Klein and Van Dyne. Seconded by Councilman Russel. All were in favor.
