ORAL COMMUNICATIONS:

Amy Nitecki – community accessibility in downtown Findlay, and the importance of advocacy for those with physical disabilities.

Ms. Nitecki is an Occupational Therapy student at the University of Findlay. She is before City Council tonight with three (3) other classmates. Occupational Therapists work with individuals with disabilities and have barriers helping to empower them and get through those barriers that affect their everyday lives. Recently, they have been looking into community accessibility for them primarily in the downtown area where they have run into a lot of issues. An important part of being an Occupational Therapist is to advocate for their clients which is why they are before City Council tonight. At the Post Office, there is a wheelchair ramp, but it is unadvertised. There are many alleys and sidewalks that are unsafe due to either construction or just wear and tear (i.e. north-south alley along Rieck's Gallery). Another big issue they noticed is handicap parking which is a big concern for businesses. Clinger's Chiropractic, Scrambler Marie's, Baker's Café, Doranne's Gift & Gourmet all voice their concerns on shortage of handicap parking spaces. She asked Council to keep this issue in mind when making adjustments for downtown Findlay.

REASON: CR 236 debt payments were appropriated and paid initially by Capital Improvements money for 2015. One hundred thirty thousand seventy-eight dollars and twenty-eight cents (\$130,078.28) of County Permissive Fund money was drawn to pay the 2015 debt payments as an allowable use of the money. These appropriations allow the County Permissive money to be used for the debt and reimburse Capital Improvements.

FROM: Special Assessments Sidewalks #28020000 \$ 12,871.66

O: General Fund \$ 12,871.66

REASON: in 2004, the City made the final debt payment on the 2003 Sidewalk Construction Program, however, there were several assessment deferments granted at that time in addition to several property owners that had chosen not to pay the assessment. Also, the City made the final debt payment on the 2010 Sidewalk Repair and New Construction projects in 2014. About half (1/2) of the assessed property owners chose not to pay this assessment. The City had to cover the costs of the debt payment with General Fund money and was to be reimbursed when the property owners finally made payment. The twelve thousand eight hundred seventy-one dollars and sixty-six cents (\$12,871.66) represent the amount of money that was received in 2015 for some of these properties. This money should now be returned to the General Fund. There are still a few outstanding assessments to be collected from these projects.

REASON: in 2011, the City made the final debt payment on the Rockwell Avenue Pavement Special Assessment, however, there were several assessment deferments granted at that time in addition to several property owners that had chosen not to pay the assessments. The City had to cover the costs of the debt payments with General Fund money that will be reimbursed when the property owners made payment. The two hundred thirty-seven dollars and twelve cents (\$237.12) represents the amount of money currently showing in the Special Assessments Pavements Fund from collection of delinquent penalties.

REASON: several retirements have already occurred and some are scheduled to occur this year that were not included in the original budget because the City did not have written notification of the retirements at the time budgets were developed last fall. Funds need to be appropriated to cover retirement settlements.

Auditor Staschiak reminded Council that this is normal business that is done every year. There is no need to pass the ordinance on an emergency tonight, however, if Council chooses to adopt this at the next City Council meeting by waiving the statutory rules and giving it its third reading that night, that would allow us to include the changes of these numbers for the budget presentation manual for the budget process that is gone over in December. Filed.

Service-Safety Director Paul Schmelzer - Care Navigation

As part of our effort to control health care costs, the City contracts with Mentalin for patient care navigation. Care navigation is a strategy we employ to guide employees through the healthcare process when they are seriously injured or have chronic issues. The objective is to make the employee more aware of available resources to get quality care, while lowering cost to our self-insured plan by eliminating potential redundant care.

We have been in discussions with the Blanchard Valley Health System about their patient navigation program. For slightly lower cost, we believe they will deliver better service to more of our employees. The current cost of the program is \$60/employee/year. BVHS will provide this service for \$45/employee/year for the first year and \$60 for the second year.

It is my intent to contract with BVHS for a two-year pilot project to determine the effectiveness of their program relative to the one we have used in the past. Legislation is requested. Ordinance No. 2015-095 was created. Filed.

Service-Safety Director Paul Schmelzer - W.O.R.C. Program contract staffing

The W.O.R.C. budget requires a transfer of \$34,000 from the personal services side of the budget down to professional services. The professional services budget was reduced in 2015 due to plans to hire part-time City staff, but this will not come to fruition until 2016. This is a transfer within the budget that requires legislation because it is being moved from personal to operations.

The part-time labor was a more cost effective alternative to contract labor. Since this was not accomplished this year, an additional appropriation from the General Fund is needed. Ordinance No. 2015-096 was created.

Discussion:

Councilman Russel asked why \$21,333.00 is being requested instead of the \$34,000.00 mentioned in the letter. Service-Safety Director Schmelzer replied that the balance is being moved within the fund to take care of the difference. This is all that is needed from Council. Councilman Russel asked that with the difficulty with staffing, would a temp agency be utilized for this. Service-Safety Director Schmelzer replied Job1USA is being utilized for this. Councilman Russel asked if Job1USA is similar to Securtask Ltd and if it is a cost effective option or if they have the same revolving door. Service-Safety Director Schmelzer replied revolving door. Councilman Russel then asked if it is an indication of what our labor market is. Service-Safety Director Schmelzer replied that they are consistently utilizing our staff for training. With one (1) person in that department, if we could back out the contract price and into a reasonable rate per hour and cover the other costs, we'd probably have a more consistent level of performance and would not be replacing all of the contracts. Service-Safety Director Paul Schmelzer - Street Department Equipment purchases

The Street Department has purchased salt under the ODOT summer contract and our stockpile is at 100% going into the winter. The salt was purchased at a much lower rate this year compared to last year. The budget item for salt has approximately \$154,000 remaining in it for this year.

During the process of planning for next year, Dave Honse identified a few equipment items that could be purchased at 2015 prices. A transfer of \$85,000 of the funds budgeted for salt to cover the capital expenditures in the Street Department is requested. A road widener (\$33,500), loader bucket (\$19,892), and a generator for the Street Department building (\$28,500) will be purchased with these funds. You can see from the figures below that 2015 saw a decline in salt prices.

Mayor Lydia Mihalik - Miracle Field

Approximately a year ago, discussions began about a grand collaborative effort to construct a Miracle Field in our community. This project will bring another world class amenity to our Marathon Diamonds at The CUBE. The Miracle Field will provide a place where special needs children and adults can participate in America's past time, regardless of their ability. This project will be a wonderful draw for families in Findlay and across the region in Northwest Ohio.

Community leaders and volunteers have been very busy behind the scenes ensuring that the dream of "Fields for All" comes to life.

Blanchard Valley Health Systems is currently facilitating the contracts and construction of the project. They are also serving as the clearinghouse for all fundraising activities. A bid was awarded to Alvada Construction for approximately \$1 million dollars. The bid was structured to allow construction to start this year and be phased in as funding is received. Materials will be delivered and site work will begin within the next 30 days.

The City of Findlay is excited to play a role in the development of this idea and its eventual construction with the first season beginning in fall of 2016. The Flag City is joining an impressive group of communities that have intentionally prioritized children and adults with special needs. A project like this takes the efforts of many and the heart of a community to bring it to life. Filed.

Service-Safety Director Paul Schmelzer - Water and Sewer Rotary Policy

The City of Findlay has a Water and Sewer Rotary Policy that is not well written. The Service-Safety Director requests the opportunity to discuss a few of the functional issues with the Water and Sewer Committee in later November. Referred to the Water and Sewer Committee. Filed.

The PLANNING & ZONING COMMITTEE to whom was referred a request from the Hancock Regional Planning Commission to discuss the final draft changes to the City of Findlay Zoning Code.

We recommend adoption of changes to zoning code - Chapter 1101-1199 as proposed.

Councilman Russel moved to adopt the committee report. Councilman Harrington seconded the motion.

Discussion

Councilman Russel noted that the Hancock Regional Planning Commission is currently working on formatting issues in the Zoning Code before they distribute it. Matt Cordonnier expects to have the entire code out either late today or tomorrow and will distribute it electronically and/or will post it on the City's website. A summary of the changes were included in tonight's packet. There are a lot of minor changes. Any questions on the changes can be answered by anyone on the Planning & Zoning Committee, Todd Richard, or Matt Cordonnier.

Councilman Harrington thanked Matt Cordonnier, Todd Richard, the Administration, and the Planning and Zoning Committee who met several times to review about what was on the books to try to correct redundancies, repetitiveness, and some of the issues that need to be removed and/or added. Once Council has a chance to review it, he is certain all will find it to be a positive solution. All were in favor. Filed.

Councilman Harrington moved to adopt the committee report. Councilwoman Spence seconded the motion.

Discussion:

Services-Safety Director Schmelzer explained what he did on this committee report and what Council is being requested to approve for the ordinance. Discussions during the beginning of the Water and Sewer Committee meeting were about the two (2) different phases of the project that is being looked at. The originally thought was that the \$200,000.000 was needed and it was a good decision to go ahead and finish it going down Elyria, Bliss, and the section of Newell Street so that it is safe for another phase of the project until additional grant funds can be obtained. Councilman Russel clarified that even though the committee report states \$200,000.00, the ordinance only asks for \$105,000.00. Services-Safety Director Schmelzer confirmed that is correct. All were in favor. Filed.

The APPROPRIATIONS COMMITTEE to whom was referred a request from the City Engineer to appropriate funds for the County Road 99 Waterline project.
